#### Currents and Eddies 8-1-2019

James River – Balcony Falls Take-out (Amherst County): FORVA is in the process of getting a VDOT permit for the entrance off Rt 501. We met with VDOT and did a survey and now have to get a decision from VDOT and the USFS on removing a large tree that blocks the line-of-sight. Lots more to come! --- Bill Tanger, Tom Miller & Howard Kirkland

**Roanoke River** – Rutrough Point Access (Roanoke County): FORVA got VDOT to spend \$150,000 on 3 new culverts and 1,000 feet of Fleximat to control erosion at Rutrough Point. Work now will start to re-build the stone wall damaged by Hurricane Michael. --- Bill Tanger

**Pigg River Dam Removal (Franklin County):** The Pigg River runs free, except for strainers! FFV members helped cut strainers out of the river, but much more work is needed. Anyone interested in chainsaw work in the river please contact me.

New Pigg River access parking lot was just finished. Meanwhile, a huge logjam has been created up against the VDOT highway bridge abutments. VDOT is working on removal. --- Bill Tanger FFV: Mo Byrd, Duck Stanley, Ray Williams & Williams

**New River -** Price Park (Montgomery County): The 50-acre park along Stroubles Creek in Montgomery County is open. We just put in a stone bench, a wooden bench and a picnic table on the trails. **Roanoke River** – Blueway (Roanoke County): FORVA is co-chair of the Roanoke River Blueway Committee. Roanoke is one of the few cities to have both a greenway and a blueway, and both run along the Roanoke River! king on improved access at the Bridge Street location. --- Bill Tanger & Roanoke Chapter

**Big Otter River (Bedford County):** We are looking at a possible purchase of a property for river access on the Big Otter River near Rt 460. FORVA will be making an offer on the property.
