#### Treasurer's Report

Deby reported that for the month of March the total membership dues collected was \$28,991.00 (\$9 below the budgeted amount) and \$4,660.00 (\$1,710 ahead of the budgeted amount) was collected for fishing permits. Year to date total net income is \$28,594.00. She will transfer some of the checking funds to savings. Shaun reported that since May 1<sup>st</sup> the fish patrol has collected \$1,340 for fishing permits and \$234 in membership dues.

## **Activities Committee Report**

Roni reported that at least 28 people participated in the Cleanup Day and Fish Stocking on May 6th. The new volleyball net was installed, thistles were sprayed, the prairie dog/ground squirrel holes were dealt with, the walking trail was raked and trees trimmed, island and boat area cleaned up and the shed was organized.

The next activity is the 3<sup>rd</sup> Annual BBQ Smoke Off and Derby Fund Raiser on June 17<sup>th</sup>. BBQ competitors, silent auction items and volunteers are needed. Cost is \$5 to eat and vote. Food will be served at 4:00. Cooking will go on all day.

Roni sent "thank you" letters to all sponsors of last year's Kids Derby and also a letter asking for donations. From the mailings she received a nice donation for the silent auction of Baseball Game tickets for Labor Day weekend, Rockies and Arizona Diamond Backs. Cindy Valade is working on her contacts and already has Wal-Mart and Venture Market making donations.

Roni and Deb will be working on the Kid's Fishing Derby which will be July 8<sup>th</sup>. More details to come.

At the last fish stocking, 616 pounds of rainbow trout, about 630 fish, and 130 pounds of brown trout, about 160 fish, were put in the lake.
