For Association Business it can be said that we have been attending the meetings for the All Aboard Florida Passenger System that will cause some major time delays on the River for our boating community. There was an open conference at the Convention Center on the 28th of October. At this

gathering there were easels filled with diagrams, videos available and representatives of each area of concern present to answer questions. It was organized by the U.S. Federal Railroad Administration; this was one of eight meetings to be I was there along with a representative from our Lauderdale Isles Water Way Management District and I spoke to some of our residents that were present. All the usual questions were asked and the same answers were provided, nothing new was learned. One interesting item, through our LIWMD Representative Ken Stauch, I was introduced to Mr. Jason Karas who is a consultant with Planning and Facilitation Services. This firm is doing a massive research paper for the marine industries in Broward and Palm Beach. We asked if we could be part of this effort. He has agreed and we will be added to the response presented to the Commissions that convene for the ultimate approval of the project. The Forum as presented, although it was in Broward County at the Convention Center, was primarily focused on the rail portion north of Palm Beach to Orlando. A good contact was made, which will be utilized in voicing our objections to the project as presented.

The Board is also making an attempt to remove the occupants who are currently living under the 441 Bridge. A committee chaired by Dawn Hanna assisted by myself, Geoff our Secretary and concerned residents long Whale harbor Lane are making inroads into this problem. It's slow but when you are dealing with the government it is always slow. Dawn has been down the throat of the FDOT top management, called the Governor's office, our county Commissioner's office and seems to be getting results in acknowledgements. She has been able to get them out to the area to see what the problem entails and made suggestions on how it can corrected. I have been in touch with the Davie Police Department and the Captain who has the responsibility to have his guys make sweeps of the area.

The meeting will have the usual soft drinks, coffee, and snacks for your enjoyment. I hope to see everyone at the meeting. . Stay safe and see you on the 20^{th} !

Minutes of the General Meeting of the Lauderdale Isles Civic Improvement Association, Aug. 15, 2014

President Dirk Lowry called the meeting to order at 7:11 pm.

- 1. Police Report: FLPD Ofcr. Jason Wilson, Neighborhood Action Team: There were no residential burglaries. There was one burglary of an unlocked vehicle, between 11pm 4am, probably by juveniles walking down the street. Properties are being watched on Duck Key & Cat Cay Lanes. A discussion ensued regarding issues with homeless people in Riverland Woods Park. FLPD officers have been citing people for using the boat ramp faucet for personal hygiene. A neighbor reported that these people start heading to the convenience store to buy beer around 7am daily. All FLPD shifts are working on the situation. In response to a question regarding break-ins, FLPD's policy is that the subjects will be arrested as long as a victim is willing to prosecute.
- 2. Approval of the Minutes of the May General Meeting: George Counts stated that his statement as listed in the May Minutes: "George Counts stated that alligators have been in these waters for thousands of years, and these waters are their home," was taken out of context & should be removed from the minutes. M: G. Counts, 2nd Chad Hodder, Approved: Unan.
- 3. Approval of the Treasurer's Report, as shown in the Newsletter: M: Bill Gray, 2nd: Chad Hodder, Approved: Unan.
- 4. Alligator Update: No gator activity reported in Lauderdale Isles since June. The state-authorized trapper is extremely busy throughout Broward.
- 5. Dredging Project Update: Seagrass Surveys are complete, permits requests have been submitted, and it is hoped that the permits will be approved by September 9. Dredging is still expected to start before the end of the year.
- 6. September 20th Waterway Cleanup: Neighborhood event, just for Lauderdale Isles, sponsored by LIWMD, LICIA, & LIYC. Joan Sheridan has graciously agreed to be the event coordinator. Pre-registration is required.
- 7. Website Update: Website continues to be updated. Any neighborhood pictures are welcome for the website.
- 8. Welcoming Committee: Welcome kits are complete. Several new neighbors at the meeting were introduced.
- 9. President Lowry advised that money has been set aside to repave the lanes that did not have new sewers installed.
- 10. All Aboard Florida: Ali Soule, Public Affairs Manager for AAF, presented an overview and the latest status of the project. Salient points for L.I. boaters: AAF has committed to having a bridge tender at the New River Bridge downtown. AAF north and southbound trains will cross the bridge at the same time. The bridge cycle for each closing will be 12-13 minutes for passenger trains. A smartphone app will be developed so captains on the river know the real-time status of the bridge. Bridge closings for AAF will be on a scheduled basis, not random. Improvements to the bridge will be made. Use of the tracks by Tri-Rail for a 'Coastline' commuter train operation is being studied by FL DOT. The FRA's EIS is due in September. Questions were raised by neighbors about hurricane evacuations, the corporate status of AAF, and the EIS process.
- 11. Airport Runway change: John Anderson reported on the new airport take-off heading of 285 degrees, causing aircraft to come closer to Lauderdale Isles, with resultant increased noise levels, especially with winds from the south. It was recommended that neighbors go to the county's website and complete a noise complaint form when this occurs. This is the best way to get the issue to the forefront with the county. George Counts asked neighbors to come the airport noise meeting, Sept. 11th. It was recommended that this information be forwarded to Chad for inclusion on the LICIA website. Chad would put a link on the website homepage to this information.

There being no further business before the group, the motion was made by Chad Hodder to adjourn. 2nd: Bill Gray, Approved unanimously

Alligator Update

During the last week of October, Paul of the GatorBoys responded, spotted him, and pursued him down the canal. But again, there are many boats & docks where the gator can hide, and he eluded capture. September Waterway Cleanup Event

The first Lauderdale IslesSeptember Waterway Cleanup on Sept. 20th was a huge success, and resulted in 1900 pounds of trash removed from our waterways. See the pictures of the event elsewhere in this newsletter. LIWMD is planning on making this an annual event for the neighborhood.

Special Award to LIWMD's Founding Board Member

During the party after our September Waterway Cleanup, a special Certificate of Appreciation was awarded to long-time Isles neighbor Pete Sheridan. Back in 1970, Pete had the foresight to bring about the formation of the Lauderdale Isles Water Management District within Broward County. He spent many years as a board member of LIWMD, and dedicated countless hours of time taking care of waterway issues. He was instrumental in arranging for the County to dredge our canals in 2002 prior to our annexation into Fort Lauderdale. He also arranged the transition of LIWMD to a dependent special district within the City during the annexation process.

Canal Dredging Update: GOOD NEWS!!

The City Commission has approved two additional task orders for the new company selected to dredge our canals, Gator Dredging. Gator Dredging replaces the previous company, Cavache, who was unable to comply with the permitting issues and contract requirements.

To date, three of the six canals to be dredged in Task Order #1 have been completed, and one of the two canals in Task Order #2 has been completed as well. The good news is our Lauderdale Isles canals are Task Order #3 and will follow immediately upon completion of tasks 1 and 2. Task Order #3 was submitted for City Manager approval on October 20, 2014 and all permits have been obtained.

One of Gator Dredging's responsibilities is to notify all homeowners of the dredging schedule so we should get plenty of notice before dredging begins in our canals.

I was informed by Larry Teich, Environmental Services, that he believes that the dredging will be done via a barge and crane that should be able to navigate down our canals and remove sediment without disturbing many boats. Those canals that have oversized vessels at their docks may present a problem and will need to be addressed by the dredging company. The dredging company will give plenty of notice so you can move your boat, if necessary, due to it's large beam.



NEIGHBORHOOD ISSUES

Homeless Activity Report

If you have had an unsettling experience with the local homeless and vagrants in Dr. Elizabeth Hays Civic Park, Riverland Woods Park, or in the vicinity of the convenience stores, you are not alone. I have witnessed activities from unsettling to downright scary. The root of the problem is from a homeless encampment located on the New River underneath the SR7 bridges, and the Turnpike on ramp. If you are unfamiliar with homeless issues, the vast majority are what is called, "dual diagnosis". That means they have mental instability and psychological issues in addition to substance addiction. There are also a number of sexual predators and offenders that call the SR7 bridge their official address. Since April, I have been trying to resolve the problem to make our parks and neighborhood safer.

Common homeless and vagrant activities include the following.

- Groups of vagrant men drinking, swearing and associated belligerent behavior at the pavilion at Hayes Park. All of this activity was way too close to families and small children on the play equipment.
- Smoking, drinking and loitering at the convenience store and associated volatile behavior.
- Homeless men bathing at the fresh water outlets at Riverland Woods Park.
- Homeless having their 7am beers and associated belligerent behavior at Riverland Woods Park

To address this dangerous situation, I have involved several government agencies:

Fort Lauderdale Police Department (FLPD): Although it took a few months, FLPD has really stepped up their patrols and have been very responsive to resident calls about homeless activity. Please note that homelessness is not a crime. FLPD can ask vagrants to leave the park, and sometimes they move on. However, if vagrants are breaking the rules (alcohol is prohibited in both parks mentioned above), FLPD can force them to leave or arrest them. FLPD is also very responsive to volatile behavior. FLPD is unable to assist with any activities under the bridge because it is not their jurisdiction.

Florida Department of Transportation (FDOT):

Getting FDOT to implement any effective remedies under the bridges has been a struggle. I have been up and down the chain of command, from our local office, to the Secretary in Tallahassee, and even to the Governor's office. The shelter that is provided by the bridge structure is what attracts the homeless. The bridges are under the jurisdiction of FDOT, but it has been difficult to get them to acknowledge and take ownership of the problem. Currently, they have a contract with the town of Davie to enforce the "No Trespassing" signage. The Davie Police Department has been less than enthusiastic about their role in patrolling the area and removing the trespassers. On October 31, I toured the homeless camp with an official from FDOT. He documented all of the activity and access points. Preventing access to the shelter provided by the bridge is complicated. There are federal restrictions that are associated with creating barriers around the bridges.

The official has agreed to obtain "buy in" from the residents before any solutions are implemented. I will be continuing to follow up with FDOT to resolve the issue. Stay tuned for more updates.

Financial Transparency – The City has launched a Financial Transparency Portal to further increase financial transparency and enhance customer service. Through this portal, neighbors can view the City's financial data in a variety of formats, including by department, division, or index code. Data is included for FY 2013, FY 2014 Budget and year-to-date, and for our newly adopted FY 2015 Budget. Users can drill down to see finite details or scale up to see the big picture. You can view multiple years of budget data, chart year-over-year trends, filter the data, and seamlessly download and share financial data and graphs. Charts and graphs can be used in a PowerPoint or other multi-media presentation. The Portal is accessible from any computer or tablet and through all major browsers and operating systems. It

may be accessed via http://fortlauderdale.gov/opengov/index.htm. Once on the site, simply click on "Explore Budget Data" and all of the information will be at your fingertips.

All Aboard Florida Project

Public Meeting – The Federal Railroad Administration has released the Draft Environmental Impact Statement (EIS) for the proposed Miami to Orlando Passenger Rail Service, which is planned to include intermediate stops in Fort Lauderdale and West Palm Beach. There will be a Public Meeting on the Draft EIS on **Tuesday**, October 28 from 3:30 – 7 PM at the Broward County Convention Center, 1950 Eisenhower Blvd. The Draft EIS can be found at https://www.fra.dot.gov/Page/P0672, and the comment period ends December 3, 2014. The full list of upcoming Public Meetings is provided on the same web page. The Broward Metropolitan Planning Organization (MPO), of which I am a Board Member, presents additional information in its newsletter available at http://www.browardmpo.org/userfiles/files/BMPO%20-%204%20pagesEnglish.pdf.

Quiet Zones – A Quiet Zone is an area with adequate safety features, e.g., gates, raised medians, or lights, to enable trains to pass without sounding their horns, which can reach 110 decibels. In Broward County, there are 65 train crossings, 19 of which need maximum upgrades to create a Quiet Zone. The City, All Aboard Florida, Broward County, and the MPO are working in partnership to create Quiet Zones at crossings citywide.

Lauderdale Isles Water Cleanup – The first-ever September Lauderdale Isles Water Cleanup was held on Sept. 20. There were 75 volunteers and 14 boats participating, resulting in about 1,900 pounds of trash and debris (nearly a ton!) being removed from the waterways of Lauderdale Isles. Thanks to all who participated in this job well done!

Armchair Athletes Project – In keeping with our commitment to encourage healthy lifestyles, Fort Lauderdale is kicking off a new initiative to tackle childhood obesity. The Armchair Athletes Project provides opportunities for children to participate in fun, friendly, fitness activities. On **Saturday, Oct. 25**, as part of **Fort Lauderdale Make A Difference Day**, * nearly 100 Armchair Athletes will compete for prizes in a variety of athletic events. Hosted at Snyder Park (3299 SW 4th Avenue), the free event will also include educational displays, exhibits, and presentations themed around health, wellness, physical fitness, and proper diet. Info for Lauderdale Isles Boaters

The Circle Route:

Now that we're headed into winter, quite often the seas on the outside are fairly rough, especially on the weekends. A popular alternative cruise for a Saturday afternoon is the "Circle Route" through the "woods" (technically the South New River Canal), to the Dania Cut Off Canal, to the ICW, north to the New River, and up the River back to the Isles. It's a nice leisurely cruise, and there are plenty of restaurants where you can stop for lunch. The one tough spot to navigate has always been right after you pass under the I-595 bridge as you start to enter the woods. Lousy PVC pipes for markers, and lots of rocks where you can see that plenty of boaters have damaged their props. But not any more. Recently, concrete pilings have been installed in this dangerous stretch to make traveling through much easier.


