Review School Districts Official Records

NEW BUSINESS:

Lyons Township Elementary School District Employee Benefit Cooperative

Treasurer Getty shared a letter received from District 102 informing the cooperative members that District 102 will be withdrawing from the cooperative (LTESDEBC) on June 30, 2019, which effectively dissolves the entity. The Trustees directed Treasurer Getty to research the most similar insurance coverage and the cost for the TTO. The Trustees will review and discuss at the next regular or special board meeting.

Discussion on billing the LTESDEBC for FY19 Pro-Rata Bill resulted in directing Treasurer Getty to bill the LTESDEBC an estimated FY19 Pro-Rata invoice of \$ 34,000 and adjust after the FY19 audit is complete.

IMRF Preliminary Contribution Rate (Calendar Year 2020)

Treasurer Getty reported the IMRF Board of Trustees adopted an optional phase-in rate for 2020 for the Regular plan only. The LTTO's IMRF phase-in rate is 6.94%, which is 9.98% higher than its current 6.31% rate. The Trustees will take action at the next Board of Trustees board meeting.
