SELECTMEN MEETING MINUTES
TUESDAY, SEPTEMBER 11, 2018, 6:30 P.M.



Attendance: Selectmen: Jeffrey Sanborn, Dwight Warren and Jim Dolloff as well as members of the Public.

1. **Selectmen Meeting was called to order approximately at 6:34 PM by Jeffrey Sanborn. This meeting was video recorded.**

2. **Review/ Approve meeting minutes**

Jeff Sanborn made a motion to accept and approve August 28th, 2018 meeting minutes. Jim Dolloff seconded the motion. Selectmen voted 3-0 to approve meeting minutes.

3. **Review/ Approve warrant**

Jeff Sanborn made a motion to accept and approve September 11th, 2018 warrant. Jim Dolloff seconded the motion. Selectmen voted 3-0 to approve the warrant.

4. **Old Business**

Assessing

Multiple lots are listed on one property card but shown on the tax maps as separate lots. These individual lots should have their own property card, unless legally combined. Selectmen voted 3-0 to allow Cumberland County Assessing to create individual property cards for the individual lots as needed.

Camera purchase and use

Selectmen voted 3-0 to purchase the cloud backup on the cameras to record the past recordings. Selectmen voted to buy more cameras to cover the hallway, fire department, Selectmen office and a backup camera. The cloud service is approximately \$7 per month.

Selectmen voted 3-0 to have a public hearing the next Selectmen's meeting and post the public hearing in the Shopping guide.




Adjournment

A motion was made by Jeff Sanborn and Selectmen voted 3-0 to adjourn the meeting at approximately 7:02PM.


