- » a window and/or clearinghouse that is connected regardless of competitive factors

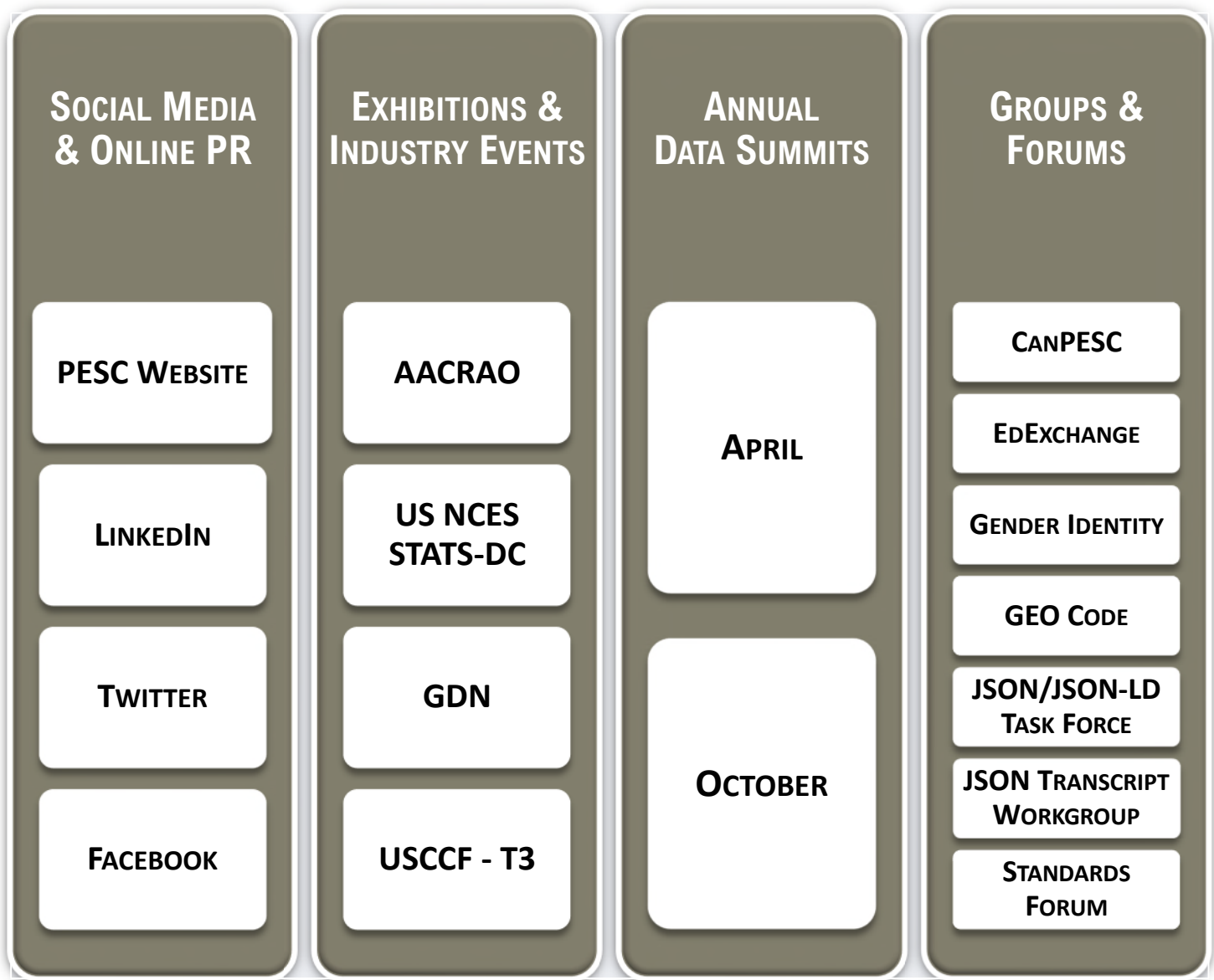
