STORING VEHICLES





If you are storing an inoperable or unregistered

vehicle on your property, the following article might be of interest to you. There are a number of regulations that concern the storage of vehicles in a residential neighborhood:

- There must not be more vehicles stored at a residence than there are licensed drivers. Additional vehicles must be in the garage;
- All vehicles must be functional, with the exception of antique vehicles or recreational vehicles. One vehicle under repair for less than 60 days is allowed;
- Residents may keep two antique or recreational vehicles, such as a boat or RV, screened behind a 6-foot wood or masonry fence;

CONSIDERING SOLAR POWER? AUSTIN ENERGY CAN HELP!



The February meeting of the CHCNA featured a guest speaker who provided information on Austin Energy's solar power education and rebate program. Austin Energy offers rebates of

up to \$2,500 for customers who complete the online Solar Education Program and install qualifying solar photovoltaic systems on their homes.

The Solar Education Program is available online at https://austin.maps.arcgis.com/apps/MapJournal/index.html?appid=d0f57a894f1346bda7a69ddd6b2fd08f and covers topics such as understanding key solar concepts; sizing your system; solar access and equipment; incentives and financing; and advice for comparing proposals.

Austin Energy suggests the following steps if you are considering solar power:

- Make your home more energy efficient. Increasing energy efficiency reduces the amount of solar power you need. Need help? Austin Energy offers incentives for energy efficiency improvents! See https://savings.austinenergy.com/rebates/about/about-featured for more information.
- Estimate your solar access. If your home is heavily shaded, it may not be a good candidate for solar. South facing locations provide the most solar energy, but east and west facing locations can also be good.
- 3. Estimate your annual electricity consumption. Find the 13 month average consumption on your Austin Energy bill and multiply that by 12.
- 4. Divide your annual consumption by 1450kWh to get an estimate of the largest size system you would meed your needs.
- 5. Get at least three proposals from contractors on Austin

Energy's list of approved vendors. Compare the bids carefully and ask questions. Austin Energy provides a bid comparison worksheet and a list helpful questions to ask contractors.

6. Select a contractor!

LAND DEVELOPMENT CODE REVISION UPDATE

On Thursday, February 13, Austin City Council approved the second reading of the Land Development Code. The Council considered more than 80 amendments during second reading. The third reading is expected to be in late March or early April.
