- out of lead in the circles, figure eights or around the end of the arena (cumulative, 1 point for each 1/4 of the circumference of a circle or any part thereof)

- jogging beyond 2 strides, but less than 1/2 circle
- or 1/2 the length of the arena
- break of gait
- freeze up in spins or rollbacks

- if a horse does not completely pass the specified marker before initiating a stop position

5 points

- spurring in front of cinch
- blatant disobedience (kick, bite, buck, rear, etc.) for each refusal
- use of either hand to instill fear

- breaking pattern
- -inclusion of maneuver (e.g. over or under-spinning, backing more than 2 strides, etc.)
- trotting in excess of 1/2 circle or 1/2 length of the arena
- repeated blatent disobedience
- use of two hands (except junior and L1 horses shown in a snaffie bit/hackamore), more than one finger between split reins or any fingers between romal reins (except in the two rein)
