On Tuesday, August 3<sup>rd</sup> and Wednesday, August 4<sup>th</sup> Dryco Construction Inc. will resurface the following streets in Diablo:

**Tuesday, August 3<sup>rd</sup>**

Alameda Diablo (Diablo Rd to Caballo Ranchero Dr.)  
Club House Rd. (Alameda Diablo to Calle Arroyo)  
La Cadena

**Wednesday, August 4<sup>th</sup>**

Avenida Nueva  
Caballo Ranchero Ct.  
Caballo Ranchero Dr. (Alameda Diablo to second speed hump)  
Calle Arroyo  
Calle Los Callados (Alameda Diablo to Avenida Nueva)  
Casa Nuestra  
El Nido

**The slurry seal project will require the streets listed above to be closed to all traffic from 7 a.m. to 6 p.m. the day the work is performed.**

Complete street closure is necessary to allow the black slurry seal to fully dry. If the slurry seal is not allowed to dry fully the black residue will adhere to vehicle tires, shoes, paws and anything else that it comes in contact with, which may lead to damaged driveways and flooring. Please keep pets indoors to avoid contact with the wet slurry seal and please reschedule all workers and deliveries to your home that day, including gardeners and housekeepers.

Dryco will have a golf cart and driver available should you need assistance. The golf cart cell phone number is 916 548-5567. The golf cart cannot drive on a street with wet slurry seal.

Tuesday, Dryco will provide flagmen to allow traffic to cross Alameda Diablo at El Nido and Calle Los Callados and to allow upper Alameda Diablo traffic to turn right onto Caballo Ranchero Dr.

Wednesday, Dryco will provide flagmen to allow single lane traffic on Caballo Ranchero Dr. to connect with Alameda Diablo.

Traffic delays are expected both days so please allow extra time when driving through Diablo.

We realize this project will cause significant inconvenience and traffic delays and very much appreciate your patience and cooperation.
