### CONSENT AGENDA

Motion Trustee Vermeulen, seconded Trustee Blodgett and carried unanimously to approve the October vouchers and invoices Trustee Vermeulen reviewed for reasonableness and which were submitted for payment approval. Payments totaling \$830,702.40 were authorized for all funds.

The Board thanked the department heads for their monthly reports.

## MAYOR – BONADIO & CO.

Mayor Taylor introduced Randy Shepard, audit partner from Bonadio & Co., who, along with engagement Manager Megan Anderson, presented the results of the Fiscal Year 2017 audit and reviewed the Required Communications Letter with the Board. Mr. Shepard stated that the audit results allowed Bonadio & Co. to issue an "Unmodified Opinion". The Board had no questions or comments for the auditors.

# MAYOR – G & G

The Mayor introduced Jay Grasso of G&G Municipal Consulting, who reviewed with the Board his proposal for G&G to perform a "Median Household Income (MHI) Survey-Low/Moderate Income Survey (LMI)" for the Village. To: Jonathan Taylor, Mayor and Mark Peake, Code Enforcement:

The time has come for me to exit from the Planning Board and VONEDA. Age is catching up with me and sapping energy and enthusiasm. Please accept this as my letter of resignation, effective December 31, 2017.
