1. Selectmen Meeting was promptly called to order approximately at 6:34 PM by Robert Flint.

#### 2. Review/ Approve meeting minutes

Jeffrey Sanborn made a motion to accept and approve January 2nd, 2018 meeting minutes. Bob Flint seconded the motion. Selectmen voted 3-0 to approve meeting minutes.

## 3. Review/ Approve warrant

Jeffrey Sanborn made a motion to accept and approve January 16th, 2018 warrant. Bob Flint seconded the motion. Selectmen voted 3-0 to approve the warrant.

### 4. Old Business

### Review/ approve sign proposal for Community Center

Selectmen reviewed and approved 3-0 to accept and schedule the Baldwin Community Center lettering from Sign Concepts at a price of \$1,061.00.

#### Review abatement request

Selectmen reviewed the abatement request and Cumberland County Assessing recommendations. The Selectmen voted 3-0 to deny the abatement request.

#### Sign Scholarship letter for WMTW

Selectmen drafted a letter to WMTW summarizing the 2017 scholarship recipients and appreciation for continuing to fund the scholarship for Baldwin students. Selectmen approved 3-0 and signed the letter.

## Puppet Ministry – every Friday for 2 hours. long term rate for meeting room or classroom.

Brett Lord came in to inquire about holding a puppet ministry at the Community Center. Potentially every Friday for 2 hours. It would be a non-profit event. Selectmen discussed and decided to charge a fee for non-profit use to cover Paul Thomas time to open/ close the community center for the event. Selectmen voted 3-0 to charge non-profits a minimum of \$25 to cover volunteer time spent opening and closing facility.

## **Review Selectmen Corner**

Selectmen had drafted a selectmen corner article for the Town website. Selectmen reviewed and voted 3-0 to post it.

#### Saddleback Culvert damage review – steps forward

Selectmen reviewed. Discussion on waiting until spring to assess the full damage. Will document the incident and related information. To assess in the springtime when snow has melted and will contact the responsible parties for the damage.
