## **FACTS**

- 1. The petitioner Heath Stocks filed his motion for the issuance of the writ of error coram nobis on September 70, 2017 and subsequently amended this petition on September 27 2017 to include that Stocks was further moving for this court to consider the issuance of the writ of audita querela and other relief based upon the facts in the petition. 4. The Respondent has filed a Petition to Seal in this case, of which it would take professional legal assistance to insure Stocks's rights to Due Process of Law and Equal

Protection to be able to use the seal documents.

5. Stocks has made an irrefutable substantial showing that he is entitled to relief, and the merits of his pleading requires an evidentiary hearing, and the State has admitted in the Response

(page 1; paragraph (4)); "....counsel should be appointed for the hearing."

6. This is an admission by the State of the need for counsel and it would be in the best
