**HARRIS COUNTY EMERGENCY SERVICES DISTRICT NO. 29**

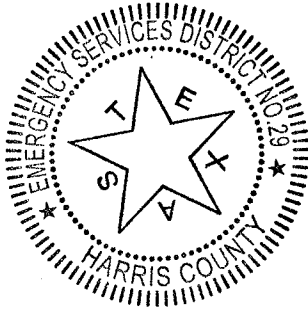
