## ORDINANCE NO. 2020- <u>03</u>

BE IT ORDAINED by the President and Board of Trustees of the Village of Chapin,

Morgan County, Illinois as follows:

Section 1: Section 1-3-3 of Ordinance 2010-2 is amended by replacing the current language of said section with the following new language:

**Section 1-3-3**. **Prohibition of Specific Animals**. It shall be unlawful for any person, entity or organization to keep or maintain within the Village any hoofed mammals of the genus *Equus* (including, but not limited to, horses, mules, and donkeys), swine, cattle, fowl, geese or ducks.

Section 2: This Ordinance shall be in full force and effect upon its passage, approval, and publication in pamphlet form as provided by law. The Village Clerk is directed to publish this Ordinance in pamphlet form.
