## MTC27/2018 Internal Matters:

To receive information on the following items and decide any action where necessary.

 Bankfield Allotments – To discuss the issues received from residents regarding the parking arrangements of plot holders and agree any action necessary - Residents from Bankfield Court and the Allotment society are present. Cllr Ibberson shows photographs on his iPad to Cllrs, showing the issues with parking. Residents are concerned that plot holders are parking in resident bays or blocking entrance to resident parking, most of which have some form of disability which requires parking near the flats/bungalows. The Allotment Society explains that there are now less plots than there used to be with only 6 plot holders, one of which lives in Bankfield. Only 1 plot holder who has a disability has been parking on the roadside. A lengthy discussion takes place. Cllr Guy suggests that a small laminated sign is put in the cars of the allotment holders, so that their cars can be identified by residents. Outcome of discussion: To put small signs in cars of plot holders or visitors, plot holders to park only to drop off & unload and then move the vehicle, MTC to arrange a site visit to look at other access points for plot holders then contact Kirklees with regards to the wall and lane into the field behind the allotments.

Emergency Item added: Bankfield Allotments Access Issue to road adjacent to 26 Nab Lane – Allotment Society report that there is an ongoing issue with the owner/occupier of 26 Nab Lane and the access road leading to the Nab Lane Allotments. A letter was sent to the occupier of 26 Nab Lane regarding access in April 2009 by MTC. On Saturday 2<sup>nd</sup>

June a lorry belonging to a contractor at 26 Nab Lane blocked the access to the allotments, which prevented a contractor hired by the Allotment Society to enter the road. The occupier of 26 Nab Lane spoke to the driver of this vehicle and now the contractor is refusing to complete the work for the Allotment Society and will not comment why. Again, on 5<sup>th</sup> June the road was blocked by the same contractor to 26 Nab Lane. The Allotment Society report that the occupier is being unreasonable and although she knows she doesn't own the land, is claiming easement rights. Cllrs agree that MTC should have been approached by the occupier of 26 Nab Lane asking for permission for the contractor to use the access road. Clerk confirms that no such request has been received from 26 Nab Lane. Cllrs discuss the issue at length with the Allotment Society. 8.35pm Cllr Lees-Hamilton leaves. Cllr Pinder Proposed MTC writes to the occupier of 26 Nab Lane with the following: It has come to our notice that major works are being carried out at your property and as such the access road to Nab Lane Allotments has been blocked. It is also noted that you have been instrumental in denying access to the Allotment Society's contractor. The council would like to remind you of the letter sent 28th April 2009, copy of which is enclosed. Please supply an explanation of your actions within 10 days of receipt of this letter. Any work planned in the interim, that uses the access road, should cease forthwith. Letter to be sent by Recorded
