The Tuesday, September 19, 2023 regular meeting of the Village of Innsbrook Board of Trustees was held at Village Hall, 1835 Highway F, Innsbrook, Missouri, in person as well as Zoom Video Conference, and called to order at 5:00 PM (CST) with Chairman Reuter presiding. Chairman Reuter led the Pledge of Allegiance.

Upon roll call, Trustees Cynthia Cook, Mike Lyles, Dan Reuter, John Simon and Donna West were present. Chairman Reuter announced a quorum was present. Mr. Tom DeBenedetti, whose subject was communication and polling residents. Mr. Jay Lutz, whose subject was Board procedures and Village Hall. Ms. Julie Francin, whose subject was ARPA Funds. Ms. Linda Hennemann, whose subject was Village revenue and tax increases.

CHAIRMAN'S REPORT/APPOINTMENTS

Chairman Reuter wants people to stay interested in Village matters and believes communication is important. A new event "Coffee With the Chairman", will begin on the first Monday of each month, starting in October, from 10am-11am, located at Village Hall. This event will provide the time to have an informal discussion to enhance communication.

- b. Administrator's Report -The report of the Administrator was received and placed on file.
- c. Planning Advisory Services Report The report of the Village Planner was received and placed on file.
- d. University of Missouri Extension Council Report There was not a report received.
- e. Planning and Zoning Commission Report Chairman Reuter recognized Mr. Allen Huddleston to give a report on the Planning and Zoning Commission. The Commission held a meeting on September 6, 2023. The Commissioners recommend approval of the Annexation and Rezone of Innsbrook Estates 10.34 acres. The comprehensive plan is being worked on by Streiler Planning.

UNFINISHED BUSINESS:

 - i. Short-Term Rentals Chairman Reuter reported that he has held a discussion with Mr. Charlie Boyce regarding short-term rentals, additional revenues, and noise sensors on rentals. Trustee West stated that nuisances should be reported to the Village Administrator in order to be addresses by the Trustees.

b. Village Administration Building

i. Loan Proposal/Application [USDA Rural Development] – Chairman Reuter reported that the Trustees met with Jason Hartke and Bridgette Sansegraw from the USDA on Friday, September 15, 2023. The loan proposal was discussed. There is a lot of additional fees that are added to a loan from the USDA, the BABA Act alone added 40% to the loan proposal. The Village will explore getting a loan from a lender and hiring a general contractor to do the construction. No formal decisions have been made yet on how to proceed.

By roll call vote, Trustee Cook "Aye", Trustee Lyles "Aye", Trustee Reuter "Aye", Trustee Simon "Aye", Trustee West "Aye". With a 5 "Aye", 0 "No", 0 Abstain vote, Bill 341 is enacted as Ordinance 337 of the Village of Innsbrook, Missouri.

All Trustees present voted "Aye". Motion passed and approved with a 5 "Aye", 0 "No", 0 Abstain vote. Chairman Reuter read Bill 343 twice by title only. Motioned by Trustee Simon, seconded by Trustee West to vote to enact Bill 343 as an Ordinance of the Village of Innsbrook. Chairman Reuter yielded the floor for debate on Bill 343. There were no public comments received by the Village, and no debate was held. By roll call vote, Trustee Cook "Aye", Trustee Lyles "Aye", Trustee Reuter "Aye", Trustee Simon "Aye", Trustee West "Aye". With a 5 "Aye", 0 "No", 0 Abstain vote, Bill 343 is enacted as Ordinance 339 of the Village of Innsbrook, Missouri.

BOARD OF TRUSTEES ANNOUNCEMENTS

Trustee Cook stated that accusations that the Trustees are not doing their due diligence is uncalled for.

Trustee Lyles stated that the Village is not trying to spend a whole lot of money on a new building, and the Trustees will look into reducing the proposed cost.

Trustee Simon stated that a new Village Hall could have space to accommodate a substation for the Warren County Sheriffs Department. This should be looked into.

Trustee West stated that she does not believe that the Village purchasing property was a losing purchase.
