I. Ratings:

7. M.R.A. rating numbers are not related to USTRC or any other association's rating system.

Add:

A) If a roper holds a current or past USTRC card above a #7 that roper ropes as their number given by the USTRC. This is only valid for numbers above a 7. All others will be according to the current MRA Team Roping Ratings Guidelines.

G. State Finals:

1. A member, **and in the novice their partner**, must compete in at least three (3) M.R.A. Approved jackpots in the current year to be eligible (qualified) for State Finals.
