

An Ordinance Apprppriating certain Money's.

Be it ordained by the Mayor and Commissioners of the city of Garnett Kansas,

Section One:- that the sum of Four Hundred and 23/100 Dollars be and the same is hereby appropriated out of the General Fund in the hands of the city Treasurer to pay the Bills allowed against said Fund at a regular meeting of said Board held on the 1st day of Febuary 1915. a list of which may be found on page 192 of the Journal of the proceedings of the Board on said date.

Section Two:- that the sum of Four Hundred and ninety nine and 33/100 Dollars be and the same is hereby appropriated out of the Water Works Fund in the hands of the city Treasurer to pay the Bills allowed against said Fund at a regular meeting of said Board held on the 1st day of Febuary 1915. a list of which may be found on page 193 of the Journal of the proceedings of the Board on said date.

Section Three:- that the sum of Forty nine and 4/100 Dollars be and the same is hereby appropriated out of the Street Fund in the hands of the City Treasurer to pay the Bills allowed against said Fund at a regular Meeting of said Board held on the 1st day of Febuary 1915. a list of which may be found on page 192 of the Journal of the proceedings of the Board on said date.

Section Four:- that the sum of Two Hundred and Eighty and 96/100 Dollars be and the same is hereby appropriated out of the Water Works Extension Bond Fund in the hands of the city Treasurer to pay the Bills allowed against said Fund at a regular meeting of said Board held on the 1st day of Febuary 1915. a list of which may be found on page 193 of the Journal of the proceedings of the Board on said date.

Section Five:- that the sum of Two Hundred and ninety nine and 6/100 Dollars be and the same is hereby appropriated out of Electric Light Fund in the hands of the city Treasurer to pay the Bills allowed against said Fund at a regular meeting of said Board held on the 1st day of Febuary 1915. a list of which may be found on page of the Journal of the proceedings of the Board on said date.

Section Six:- that the sum of One and 20/100 Dollars be and the same is hereby appropriated out of the Fund of Sewer Dist number One in the hands of the City Treasurer to pay the Bills allowed against said fund at a regular meeting of said Board held on the First day of Febuary 1915. a list of which may be found on page 192 of the Journal of the proceedings of the Board on said date.

Section Seven:- that the sum of One and 20/100 Dollars be and the same is hereby appropriated out of the Fund of Sewer District number Two in the hands of the City Treasurer to pay the Bills allowed against said Fund at a regular meeting of said Board held on the First day of Febuary 1915. a list of which may be found on page 193 of the Journal of the proceedings of the Board on said date.
