ORDINANCE NO. 18 - 09

AN ORDINANCE VACATING A CERTAIN ALLEY AND STREET IN PICQUET'S ADDITION TO THE CITY OF NEWTON, JASPER COUNTY, ILLINOIS

BE IT ORDAINED by the City Council of the City of Newton, Jasper County,
Illinois, that it has been determined that the public interest would be served by vacating
the following alley and street located in the City of Newton, Jasper County, Illinois,
legally described as follows, to-wit:

The Twelve (12) foot wide alley running East and West between the Lots 8 & 19; Lots 9 & 18; Lots 10 & 17; Lots 11 & 16; Lots 12 & 15; and Lots 13 & 14 in Picquet's Subdivision to the City of Newton; and

Undeveloped 2nd Street between Lots 20 & 19; and Lots 7 & 8 in Picquet's Subdivision to the City of Newton, reserving utility easement between Lots 20 & 19.

Which said alley and said 2nd Street is hereby vacated;

BE IT FURTHER ORDAINED that the City Clerk shall record in the Office of the Recorder of Jasper County, Illinois, a duly certified copy of this Ordinance.

This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
