 3. Consider and adopt Ordinance 522 ratify property tax increase for 2015
 4. Consider and adopt Ordinance 523 levying a tax rate for the tax rate year of 2015.
 5. Consider and approve Resolution #435 supporting Proposition 7 on the upcoming November 3rd Constitutional Amendment Election to increase transportation funding in Texas.
 6. Consider and cast votes for candidates for Board of Directors for the Grayson County Appraisal District
