



**ORDINANCE 2017-6
AMEND ORDINANCE 2010-10**

WHEREAS THE TOWN OF CLOVERDALE NEEDS TO ADJUST THE TAX ON DOGS FROM ITS SETTING IN 1996 AND AGAIN 2010-10.

BE IT ORDAINED THAT:



SECTION 6-26 OF THE CLOVERDALE TOWN CODE SHALL BE MODIFIED AS FOLLOWS:

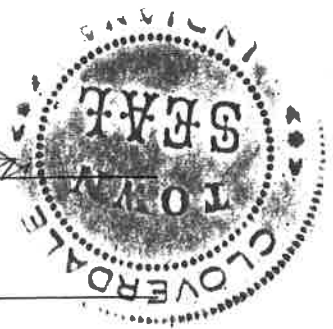
- I. THE DOG TAX SHALL BE INCREASED TO THE AMOUNT OF TEN DOLLARS **(\$10.00) EACH** UP TO TWO DOG 6 MONTHS OR OLDER WITHIN THE TOWN LIMITS. ADDITIONAL FEE IF YOU HAVE THREE TO FIVE DOGS OVER 6 MONTH OF AGE THE TAX WILL BE TWENTY DOLLAR **(\$20.00) EACH**.
- II. IF YOU HAVE MORE THAN 5 DOGS YOU SHALL HAVE A KENNEL LICENCES THROUGH THE STATE OF INDIANA.
- III. IF A COMPLAINT IS FILED OR A DOG IS CLAIMED BY THE OWNER WITHOUT A TAG A TWENTY-FIVE DOLLAR **(\$25.00)** FEE FOR EACH DOG UP TO 2 DOGS WILL BE IMPOSED FOR THE FIRST COMPLAINT AND A FIFTY DOLLAR **(\$50.00)** FEE UP TO TWO DOGS WILL BE IMPOSED FOR EACH COMPLAINT THEREAFTER. IF YOU HAVE 3 TO 5 DOGS WITHOUT HAVING A TAG A SIXTY DOLLAR **(\$60.00)** FEE EACH WILL BE IMPOSED FOR THE FIRST COMMPLAINT AND EIGHTY DOLLAR **(\$80.00)** FEE EACH FOR THE SECOND COMPLAINT THEREAFTER.
- IV. ALL OTHER PROVISIONS OF THE EXISTING DOG TAX ORDINANCE WILL REMAIN IN FULL FORCE AND EFFECT.
- V. THIS ORDINANCE WILL BE IN EFFECT 30 DAYS FOLLOWING ITS PUBLICATION PURSUANT TO LAW.
