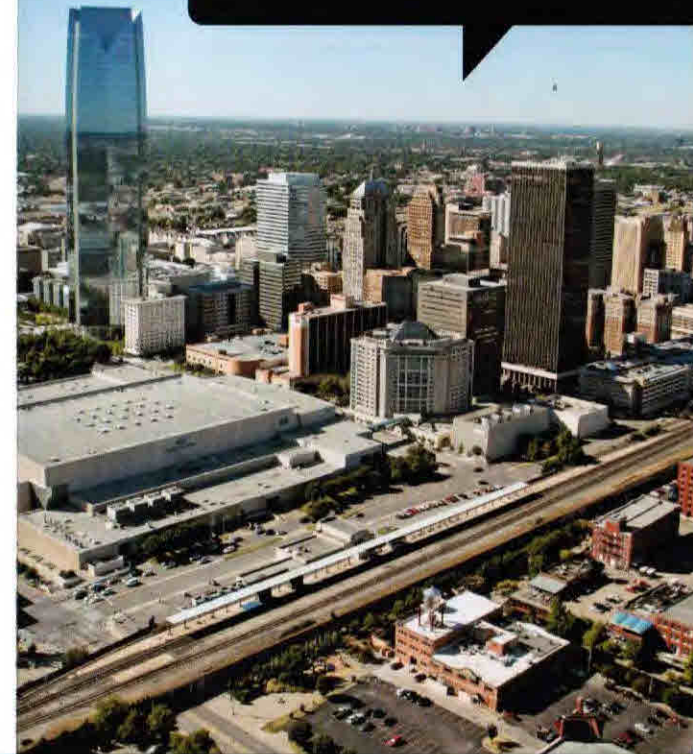

PROTECTING CITIZENS' PRIVACY AND CIVIL LIBERTIES

The Oklahoma City Police Department, in partnership with the **If You See Something, Say Something™** campaign, respects civil rights, civil liberties and privacy by emphasizing behavior, rather than appearance, in identifying suspicious activity.

Factors such as race, ethnicity, gender, national origin, religion, sexual orientation, or gender identity alone are not suspicious. For that reason, the public should report only suspicious behavior and situations (like an unattended backpack in a public place or someone trying to break into a restricted area) rather than beliefs, thoughts, ideas, expression, associations or speech unrelated to terrorism or other criminal activity.

Only reports documenting behavior reasonably indicative of criminal activity associated with terrorism will be shared with federal partners.

CRIMINAL ACTIVITY POTENTIALLY ASSOCIATED WITH TERRORISM

- Breach/attempted intrusion into a restricted area
- Using false or fraudulent IDs & documents
- Theft of uniforms, official vehicles, badges and IDs
- Vandalism of critical infrastructure, key resources, churches, schools, government buildings, water treatment facilities, etc.
- Cyber attacks
- Threats – expressed or implied
- Unusual or dangerous aviation activity

These suspicious activities are crimes. If you observe these activities, call 9-1-1 immediately.

SUSPICIOUS ACTIVITY POTENTIALLY ASSOCIATED WITH TERRORISM**

- **SURVEILLANCE** – Recording or monitoring activities in a manner that would arouse suspicion
- **ELICITATION** – An unusual interest in attempting to gain information about daily operations, security alarms, access control, HVAC systems, etc.
- **TESTS OF SECURITY** – Intentionally causing false alarms to measure public safety response times to critical infrastructure or key resources
- **ACQUISITION OF SUPPLIES** – Acquisition and/or storage of unusual quantities of materials such as explosives, weapons, ammunition, cell phones, uniforms, passes or badges
- **REHEARSAL** – Putting people and resources in position to practice assaults or attacks
- **DEPLOYMENT** – Moving people and resources into place in preparation for committing a violent act
- **FUNDING** – Suspicious transactions involving unusual large cash payments, deposits or withdrawals

****These are not inherently criminal behaviors and may include constitutionally protected activities.**
