Winners will be notified via phone after the drawing has taken place. Fees will be due no later than June 7<sup>th</sup> at the Chamber Office. If your child is chosen and not paid by that date, we will choose one of the 5 backup contestants. NO EXCEPTIONS!**

The Pageant will be held on Wednesday, August 7, 2024, at 7p.m. at the Memorial High School Performing Arts Center. Daily practice times and location for the event will be announced at a later date.

The queen and all runners-up will be asked to ride on the float on Saturday evening at the SummerFest parade. The queen will also be participating in various additional parades.
