



RELEASE, HOLD HARMLESS AND INDEMNITY AGREEMENT

I understand the RISK of death or injury from hunting, shooting and other known and unknown events and activities and/or the use of the related buildings, structures, equipment, automobiles, firearms, weapons, ATVs, boats, tree stands, roads, bodies of water, land and all other real and personal property whether owned by Brian Bachman, Ray Crow, Travis Crowley &/or Arrowhead Wilderness Outfitters, LLC or others IS SIGNIFICANT, including the potential for death. While particular rules, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist. I am willing to assume the risks stated herein for the entire hunt, beginning _____ and scheduled to end _____.

I understand that the use or handling of firearms and other weapons by myself or by others is an inherently dangerous high risk activity, whether such firearms or weapons are discharged or handled by myself or others.

I understand that the hunting field poses certain natural dangers. I understand that during this hunt I will be on a variety of private and public land. The varied terrain of the land poses hidden dangers and obvious dangers of which I am aware. I understand that I may have to traverse difficult terrain during times of low light visibility. I understand the weather varies in the region and I am prepared for and understand the risks associated with extreme heat, cooler temperatures, winds or thunderstorms. I understand that there are natural animals that may pose additional dangers. I understand the risk of using elevated stands and responsibility for me and my guest(s) safety. I am willing to assume the risk of death, any injury and/or disease that I may contract from being associated with animals and natural hazards present in the hunting field.

I understand that if I, or my guest(s), has a medical condition of any type, it is my responsibility to advise Brian Bachman, Ray Crow, Travis Crowley &/or Arrowhead Wilderness Outfitters, LLC, its employees, volunteers and other guests of the hazards of my or my guest's condition and I agree I will take responsibility for my guest(s) and myself.

I understand that the consumption of alcohol, marijuana and/or other drugs, legal or otherwise, may impair my ability to safely and accurately operate weapons or participate in any hunts. I agree not to operate a weapon or participate in any activity while under the influence of alcohol, marijuana or any drug, legal, illegal or otherwise. If I do operate a weapon or participate in any activity while under the influence of alcohol, marijuana or any other drug, legal, illegal or otherwise, then I assume all risks associated therein

I understand the risks associated with traveling in automobiles and on All Terrain Vehicles (ATVs). I hold harmless and take responsibility for travel and rides in the field and release Brian Bachman, Ray Crow, Travis Crowley &/or Arrowhead Wilderness Outfitters, LLC, its employees and volunteers from any charge of negligence.

I knowingly and freely assume all such risks, both unknown and known, even if arising from the negligence of the Brian Bachman, Ray Crow, Travis Crowley &/or Arrowhead Wilderness Outfitters, LLC, or others, and assume full responsibility for my participation.

In consideration of being permitted to use land owned, leased, rented or borrowed (including public land) and related personal property for purposes of participating in and/or observing hunt activities including riding over said lands on ATVs, walking over said lands, remaining in a stationary position to hunt or observe hunt activities, or being allowed to shoot firearms or other weapons on the hunt being guided by

Brian Bachman, Ray Crow, Travis Crowley &/or Arrowhead Wilderness Outfitters, LLC, or otherwise, I, for myself and on behalf of my successors, heirs, assigns, personal representative and next of kin hereby release and hold harmless Brian Bachman, Ray Crow, Travis Crowley &/or Arrowhead Wilderness Outfitters, LLC, including its owners, lessors, officers, directors, officials, agents, employees, volunteers, guests, other participants and the foregoing individual's heirs, successors, or assigns from any and all liability from any death, injury or loss which may occur during OR as a result of shooting, hunting, observing or visiting the premises or related lands or use of related personal property during the hunt and afterward. I also agree to take full responsibility for my guest(s). All photos and videos taken are the property of Arrowhead Wilderness Outfitters, LLC.

I HAVE READ THE FOREGOING RELEASE, HOLD HARMLESS AND INDEMNITY AGREEMENT AND I FULLY UNDERSTAND AND VOLUNTARILY AGREE TO ABIDE BY ITS TERMS. I ALSO UNDERSTAND THAT THE WORD OF THE HUNTMASTER/GUIDE IS FINAL. I FURTHER AGREE TO ABIDE BY ALL STATE AND FEDERAL GAME LAWS.
