## 2. Historical society fireworks

Chari Burrell present- Asked if they can have fireworks at the Purple Park during the Ice Cream Social (as they have in the past) on the third Saturday in Julyapproved.

#### 3. Heritage festival parking

Chari inquired about use of the gravel parking lot at the Purple Park for vendors during September Heritage Festival- approved. Park Board plans to use the South parking lot for a fundraiser this year during the festival.

# 4. Baseball fencing, back stops, new fields

- B. Counterman: Our baseball program has outgrown our space and we need more playing room.
  - Quote \$1,200 for 4 dugouts
  - Huff family has volunteered to gather troops and help to build dugouts and fields.
  - Menards handout provided- \$448.09 for lumber for 2 backstops (might be double price to have 4)-11% rebate available to us at Menards
  - Falcon Steel-Handout provided- 5" Round tube (preference vs. 4")=\$1,509.48
  - Deville quote for (4) 5" Round tubes steel primed \$1,452
  - Total price to not exceed \$5,500
  - Pizzas and drinks to be provided for volunteers.
  - Probably going through Menards for materials.

Motion by Storey to make 2 new fields and 2 new dugouts 24 ft./each, less than \$5,500 on material, labor donated, Winder seconded.

<u>Fencing</u>- For adult ball games- Using a field we already have (field 1 up top). This will allow multiple fundraising opportunities.

- CCL Fencing and Outdoors quote provided. Total \$26,650 for 2 fields, \$13,390/1 field
- Carnahan-White guote provided \$33,600
- DJ's Fencing (email) quote \$14,890 on one field

Motion made by Winder, seconded by Patrick to put in fence and gate for adult softball on field one at or under CCL Fencing quote of \$13,390.
