RESOLUTION NO: SL – 02 - 2022

TITLE: Approval of US Department of the Treasury Homeowners Assistance Fund (HAF) Policy and Application

WHEREAS, the Summit Lake Paiute Tribe is organized, pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934 (48 Statue 984), as amended, with the Articles of Association, and approved by the Secretary of Interior on January 08, 1965, granting certain powers to the Summit Lake Paiute Tribal Council; and

WHEREAS, the Summit Lake Paiute Tribe is responsible for financial matters and the organization of operating policies to provide accountability of the benefits received by the Tribe on behalf of its members; and

WHEREAS, in the early part of 2020 continuing to date; multiple cases of the Coronavirus (COVID-19) have appeared throughout the United States causing the State of Nevada and many other states to declare a state of emergency which included a mandatory stay at home order in place for all persons excluding essential workers. The Coronavirus was declared a National Pandemic; and,

WHEREAS, US Department of the Treasuries Homeowners Assistance Fund (HAF), was established to mitigate financial hardships associated with the coronavirus pandemic by providing funds to eligible entities for the purpose of preventing homeowners mortgage delinquencies, defaults foreclosures, loss of utility or home energy services, and displacements of homeowners experiencing financial hardship after January 21, 2020, through qualified expenses related to mortgages and housing; and,

WHEREAS, Summit Lake Paiute Tribe was awarded \$3,835.30 from the US Department of the Treasury Homeownership Assistance Fund which is 10% of the full allocation;

WHEREAS, The Tribal Housing Program Manager proposes the following Summit Lake Paiute Tribe's US Department of the Treasury Homeownership Assistance Fund (HAF) Policy and Application, to enable the tribe to meet the needs of tribal members; and

WHEREAS, the Summit Lake Paiute Council has deemed it to be in the best interest of the Tribe, to adopt the US Department of the Treasury Homeownership Assistance Fund (HAF) Policy and Application to aid tribal members with Emergency Mortgage and Utility Assistance; and

NOW THEREFORE BE IT RESOLVED that the Summit Lake Paiute Council, the governing body of the Summit Lake Paiute Tribe of Nevada hereby approves the adoption of the US Department of the Treasury Homeowners Assistance Fund (HAF) Policy and Application.
