

An ordinance levying a special tax provisionally, to pay the cost of grading, curbing, guttering and paving Oak Street from the North line of Fourth Avenue to the North line of Second Avenue, in said City, except the intersections of Third Avenue and Oak and Second Avenue and Oak Street, in said City.

Be it ordained by the Board of Commissioners of the City of Garnett Kansas,

Section 1. That in order to provide for the payment of the cost of Grading, curbing, guttering and paving Oak Street from the North line of Fourth Avenue to the North line of Second Avenue, except the intersections of Oak Street and Third Avenue and Oak Street and Second Avenue, special assessments are hereby levied, provisionally upon the lots, parts of Lots and pieces of ground on either side of Oak Street liable for taxation to pay the cost of said improvement as follows:

Amount assessed against each piece of property to pay the cost of paving, curbing, guttering and grading of Oak Street.

Section 2. That the amounts set forth in the preceding section of
this Ordinance are hereby ascertained and fixed by the Board of Commis-
sioners as to the amounts to be assessed against each lot or parts of lots
or pieces of ground to pay the cost for the improvements above named,
which amounts may be paid to the city treasurer at any time within thirty
days after the publication of this ordinance.

Section 3. This ordinance shall take effect and be in force from and
after ten days from its final passage and publication in the official
paper in said city.
