Now Is The Time...

Baptist General Convention of Virginia, thru our Social Justice Commission, has launched at statewide Voter Registration Campaign in partnership with the State Chapter NAACP and the Virginia State Baptist Convention to increase the number of registered voters in the Commonwealth of Virginia.

Immediately, volunteers are needed who are certified, or desire to become certified, to register others to vote. Mandatory Training for Third Party Voter Registration "in-person" takes less than two hours. To request this training at your church, association or community organization please contact BGCVA at 804-228-2421 or eburke@bgcva.org.

Third Party Voter Registration Certification training is also available online. It only takes about 30 minutes to complete. Upon completion you will be listed with the State Board of Elections as eligible to accept voter registration (forms will be mailed to you). Online Voter Registration Certification is available at:

The President's Report

The past two months have proven to be the most faith-challenging season in my entire life in regards to the passing of my father, Rev. Henry Blunt on February 23rd of this year. As a family we are both spiritually and literally still "picking up the pieces" and it has been the tremendous advocacy and support of this convention, along with so many others, who have helped us throughout our healing process during these most difficult days.

I am immensely grateful to Vice President Howard, Rev. David Chapman, our Executive Board, our state staff, this august General Board, and our entire convention for all of the prayers, expressions of love, your presence at my father's funeral, and most importantly your provision of allowing me the latitude, the space, and the time to grieve as a son privately and with my family. I am eternally grateful for each of you and it is my distinctive honor to continue sharing with you in this tremendous labor of love.

Infrastructural Revisioning:

"God is Calling Us to Do Something Together That We Cannot Accomplish on our Own!"

"Start by doing what's necessary; then do what's possible; and suddenly you are doing the impossible." These are the words of the Patron saint of Italy, Francis of Assisi, who spoke these words centuries ago regarding the appropriate process for effectiveness and success. These words have truly become a canonical expression of the state, the direction, and the vision of our great convention as we have truly been working and striving to revision the infrastructural manner in which we approach ministry in this 21st Century.

- General Board Training: The praxis of requiring orientation/training for all General Board members is a necessary component in strengthening and reconstituting the successive direction of all that we hope to achieve by virtue of our convention's vision and mission moving forward. The constituted support and advocacy of the general board in fulfilling our roles as well as comprehending and upholding the vision/mission of the convention moving forward is critically essential to the life and effectiveness of the Baptist General Convention of Virginia.
- Programmatic Ministry Cohesion: In order for us to achieve both the "impossible" and the "possible" we have had to strategically approach how we execute the "necessary" when it comes to the programs and ministry



variables/opportunities that we provide throughout the state. History (recent) has proven to us that it is always to the detriment of the convention whenever we allocate individual platforms for our core ministry departments. Whatever blessings we reaped from those endeavors were abruptly dwarfed by the yawning ex-

penses that would befall the convention regarding the satisfaction of multiple hotel contracts and the indebtedness necessary to facilitate said events. The measure of revisioning our programmatic ministry approach was not only a stewardship principle but also a social justice imperative that required us to better position ourselves against being perceived as the proverbial "cash cow" in respect to institutional relationships that were one-sided in their relatedness with us.

This past February marked the successful emergence of a new programmatic paradigm where the Men's, Women's, and Clergy ministries of our convention came together in a UNIFIED mid-winter retreat that was held at the Hilton Mark Center Hotel in Alexandria. Virginia. Attendees from the retreat have yielded rave reviews as persons enjoyed the concerted interdisciplinary approach to the sessions, the structural flow of the entire experience, and the intentionality given to all three ministries operating autonomously underneath one unified vision. A very special thanks is to be given to President Taylor, President Pinchback, President Ford and their entire respective leadership cabinets regarding the tremendous orchestration provided during that venture as well as the corresponding sacrifices made for the whole by each ministry.

Executive Minister Search Committee: As we all know the faithful tenure of our current Interim Executive Minister, Rev. David Chapman, will conclude in December of 2017 next year. We have been truly blessed by Rev. Chapman's leadership and the imprint of his presence has proven to be more than its weight in gold in providing the continued stability that our convention has needed. We as members of the General Board should be very proud of our Interim Executive Minister for the body of work that he has done in the Name of our Lord and we should be very grateful considering the continual upward trend of our convention. However, it is now time that we continue the work of preparing to achieve both the "possible" and the

"impossible" by providing the next steps to that which is "necessary."

After much prayer and meditative dialogue with Vice President Howard, the following names have been selected to serve on the search committee for our next executive minister: Dr. Patricia A. Gould-Champ, Dr. Darrell K. White, Dr. Dwight Riddick, Dr. Curtis Strader, and Rev. David Chapman. Vice President Howard and I will serve within an Ex-Officio status on the said committee. I believe that it's pertinent that we have former presidents of our great convention serving in this dynamic as they will be able to both render and discern the appropriate navigation of this endeavor. It is our hope that we will have such a person identified by next summer so that there can be a period of months available for constructive mentoring in the ministry capacity.

Position of BGC Youth Director: BGC has been blessed with a rich lineage and legacy of leadership over the years and the position of our convention's Youth Director has been no different. The impact that Rev. Curtis Ballard has made within our convention and throughout the Commonwealth has been a testament to his ministry integrity, his uncanny anointing, and a proud continuation of that storied tradition. Rev. Curtis Ballard has recently been hired in a similar capacity with the St. Paul's Baptist Church here in Richmond. Our prayers remain with Rev. Ballard and it is our hope that the Lord will grace him to have a similar impact on his new assignment as he has had with us. Given the absolute "necessity" in maintaining the momentous momentum that has been achieved throughout our state youth ministry it is imperative that our new Youth Director be named immediately to prevent angst and anxiety to birth a counterproductive work in our convention. The Executive Board has unanimously agreed on the name of our next Youth Director and today we will share that name with the General Board.

General Board Giving & Financial Accountability: Finally, in order for us to achieve both the "possible" and the "impossible" it is imperative that we as a General Board take seriously what is required of us regarding what is absolutely necessary. It is extremely essential that we remember our responsibili-

ties in supporting the convention financially. We cannot continue to wait for others to do for our convention what we haven't done ourselves. The true measure of our leadership and the defining affirmation that we honestly believe in the efficacy and value of the BGC will be determined by how we lead our convention in sacrifice and in giving. It is our prayer that as a general board member you will leave your generous gift with the convention before you leave today as well as encouraging your church to remember to give to the convention on a monthly basis as well. Remember that "God is calling us to do something together that we cannot accomplish on our own!"

Again, I would like to thank each of you for ALL that you do for our convention and the Kingdom of our Lord, the Christ. I am both honored and humbled beyond measure to have been entrusted with the joy of serving as president. Let us continue to faithfully strive together to do that which is necessary so that we can accomplish through Christ both the "possible" and the "impossible."

Interim Executive Minister's Report

117th Annual Session and Congress of Christian Education

June 26-30, 2016

My report this Annual Session will highlight the many positive, progressive things that have and are presently taking place in the Convention. But just before I get to those positive progressive things, I am tempted to mention



two concerns before I go any further. Now if I would yield to this temptation, I would say that we need broader support from all areas of the Convention.

My prayer is:

That we would start getting 100% participation in giving from the General Board That Moderators and the Associations they

lead would seek to increase their contributions.

That the Convention's numerous churches that don't presently donate to the work of the convention would start with at least a hundred dollars a year.

But I want mention that.

The second thing I would be tempted to mention happens to be a belief that I have been encountering from facilitating a good number of leadership workshops and in general conversation with pastors. That belief or statement being made by too many church leaders, i.e., deacons and trustees is that the pastor is no more than a hiring or employee. If I was going to say anything on this I would without fear or biblical contradiction call this belief "a lie from the pits of hell". It is misguided thinking like this that greatly contributes, to the confusion and conflict in many of our churches. If I was going to say it I would recognize that I don't have the time to follow this up with a period of biblical clarity. So I won't mention it.

But there is an article in your packet that speaks more in depth to this topic.

So seeing that I am not going to mention those two concerns let me move on to the positive, progressive report I intend to give.

This past year (2015) has been another year of the Convention's positive recovery since the devastating events that threatened to sink us some five years ago. During two stints of Interims before me and for the two years and six months I have been on board many have worked hard to get the Convention to where it is today.

So, where is the Convention as we gather for this 117th Annual Session?

Our Youth and Young Adult Ministry has experienced a transition in leadership. The Reverend Curtis Ballard, who assumed the position in 2014 has transitioned to a new position as the Director of Youth and Young Adult for the St. Paul's Baptist Church, Richmond. I personally want to thank Rev. Ballard for his strong visionary leadership, his depth of incite and wise advice, not just with youth and young adult ministry, but across the board in all the ministry that takes place in BGCVA. On behalf of the Convention, we thank God for the awesome service he rendered in such a tender time in the life of the Baptist General Convention of VA.

His replacement is the Reverend Kaiya Jennings, a product of BGCVA, VUU and First

Baptist Church Mahan, Suffolk, VA. Rev. Jennings assumed the position on June 1. We look forward to her using her God given gifts and talent to spring from the foundation that has already been laid and take the BGCVA Youth and Young Adult Ministry to new and unimagined heights.

***The Convention's Commission on Social Concerns has been very active over this past year in addressing a number of Social Justice issues in collaboration with other Social Justice minded ministries and organizations. Under the direction of Dr. J. Elisha Burke, BGCVA's Director of Men, Health and Social Justice, and the active involvement of its cochairs the Reverend Dr. James Coleman and the Reverend Dr. Emory Berry the Commission is leading BGCVA to address issues such as:

- Criminal Justice
- Juvenile Justice
- Economic Justice
- Predatory Lending
- Gun Violence
- Healthcare Access for all
- Immigration
- Childhood Hunger
- Youth Financial Education
- Voter registration and turnout

In order to more effectively address these issues BGCVA is working in collaboration with:

BGCVA was represented at numerous meetings, training sessions, press conferences, the 2016 General Assembly and advocacy events in Richmond, Lynchburg, Waynesboro, Arlington, and Washington DC. by Staff and Commission members. One of the truly standout mission moments of the year was BGCVA's response to the Flint water crisis. Fourth Baptist, First African and Fifth Baptist of Richmond partnered with the Convention as drop off and collection spots. Water donations were accepted from February 15th until March 8th. BGCVA churches and Associations donated 2,155 multiple count cartons (that was approxibottles). mately 25,600 Additionally, \$6,000.00 in cash was donated by churches to aid in shipping (\$2,045.00 that had to be paid, in addition to, free shipping by St. Paul's Baptist Church, Richmond and Amtrak. The remaining funds (\$3,955.00) going to the Flint Child Health Project (medical care for children impacted by the tainted water).

Look for Dr. Burke's column in this issue of the Baptist Herald to read more about all that BGCVA is doing in the areas of Social Concerns and Health.

Christian Education (Faith Formation) is a constant, ongoing exercise with the entire ministry staff of BGCVA under the direction of Mrs. Sheryl Blowe-McDowney. Beginning each year with our Finance Conference, followed by the Mid-Winter Retreat, Annual Session, Youth Retreat, Regional Young Adult gatherings, the Leadership Conference, Fall Session, Association Visitations, Church School Conferences around the state and enumerable workshops on various subjects that enlighten and strengthen our churches to aid them in seeking to be relevant in the times in which we live.

Workshops conducted for BGCVA associations, individual churches, regional church clusters and even some non-BGCVA churches include but not limited to topics such as: teacher training, leadership (Deacons, Deaconess and Trustees), finance, prayer in worship and visitation, disabilities, missions, generations working together, ushers, conflict resolution, etc. This past year and in the months to come the most requested workshops are those geared toward church leaders (Deacons and Trustees). Developing church leaders and helping them to operate in their assigned lane is crucial to the overall health and growth of a church.

Because of Sheryl McDowney's leadership in Christian Education (Faith Formation) BGCVA is able to maintain partnership with ministry partners such as:

- Virginia Union University (Leadership Conference)
- Lott Carey Foreign Missions Convention
- Sunday School Publishing Board Church School Conference

As I move to complete my report, let me interject here a very exciting and important event that is taking place at the

BGCVA Men and Women's luncheons this week. Each ministry will be giving some \$3,000.00 in scholarships for students who attend the Samuel DeWitt Proctor School of Theology. Thank you to our Men and Women's Ministries and congratulations to the students receiving the scholarships.

In my report on last year I gave you a detailed report of the giving level of BGCVA churches for the year of 2014. Following is what I have for 2015: (there is a more thorough report in your messenger bag entitled 2015 Contributions to Ministry and Missions.

For 2014 I reported that 131 churches gave directly to BGCVA. For 2015 137 churches gave directly to BGCVA.

(Here's the good news, by the end of May of this year, with 7 months remaining, 84 churches have reported. That is already 61% of all that gave all of last year. If we continue to gain returning and new churches and those churches that are faithful every year report in with their gifts, I truly believe that my report next annual session will have a report of 200 or more of our churches reporting.

(Report amended on 7/19/2016) As this report is being prepared to place in the Baptist Herald I can report that as of today (7/19/2016) 129 churches have given directly to BGCVA. As you can see we are just seven churches away for eclipsing all of last year. The 200 churches or more are well within reach. If your church has not represented monetarily to the Convention this year won't you help us as we continue to move forward in restoring the Convention to an even greater level than ever before.

Overall giving for 2015 increased 14% over 2014 with the largest increase from ministry events. (Churches increased 10%, ministry events increased 26%)

Expenses were virtually flat (remained the same) when 2014 is compared with 2015.

The budget deficit for each year is shrinking dramatically. The deficit for 2014 was \$95,000.00, for 2015 it was \$22,000.00. With your support the Convention is on pace to erase the deficit at the end of this year.

Through May of this year (2016) the giving from our churches has increased by 30% (some \$27,000.00 compared to the same period in 2015.

We have gotten participation from some 24 (Amended 7/19/2016) 34 churches that had not given since 2012.

We have added for the first time in several years churches new to BGCVA. Six to be exact. They will be recognized during the Wednesday Evening Celebration where we hope you will be able to meet the pastors.

Again, thank those of you who make it your mission to support your Convention. Thank the Rev. Dr. Grady Powell and the Rev. Dr. Willis Johnson, two of our former presidents for chairing our Legacy of Generosity giving campaign for 2016. This campaign is geared towards individual giving. Individual givers rose from less than 30 in 2014 to 102 in 2015. We expect this number to drastically increase for this year (2016).

As we celebrate this 117th Annual Session, I am privileged to report that 568 persons registered for this session. Registration has increased each year since 2013. Prayerfully, this number will continue to increase until we reach the level of attendees before the crisis of five years ago.

Because of your financial support and higher registration numbers this year we CAME into this session with the financial resources to pay the Hotel and the Chesapeake Conference Center.

Next year (2017) Roanoke. Lord's will, we will see you there.



The 117th Annual Session and Congress of Christian Education attendance showed an exciting increase!

Of the 568 number of registered attendees:

- 53 attended morning prayer
- 250 attended the Tuesday morning Health Breakfast
- 430 attended the morning lectures
- 114 attended the same class all week
- 132 attended class on Monday
- 261 attended class on Tuesday
- 129 attended class on Wednesday

- 33 facilitators
- 32 teacher assistants




BGCVA 2015 Contributions to Missions and Ministry



Social Concerns Commission Resolutions Advocating for Issues of Social Justice

The Baptist General Convention of Virginia (BGCVA) Commission on Social Concerns is a "think tank" and advocacy group representing a cross-section of Virginia churches and associations, who exchange ideas, generate practical resources, and strengthen relationships and partnerships with BGCVA churches, associations and others of likemindedness in order to achieve greater collaborative and cooperative ministry. The commission empowers congregations and associations to embrace the mind of Christ in facing emerging social concerns and systemic justice issues that subtly and overtly deny the community full access to the rights and privileges of an enlightened society.

BGCVA has committed to advocate for social justice with respect to many issues including: education, healthcare, civil/human rights, poverty, racism, employment, drug addiction, mass incarceration, payday lending, fair housing, voter rights/registration, aggressive policing and other justice issues. We will provide leadership and join likeminded advocates in removing barriers/challenges that deny justice for all people.

Therefore, in keeping with the biblical demand for social justice, Baptist General Convention of Virginia adopts the following resolutions:

Resolved: BGCVA works to eradicate barriers that deny respect of our brothers and sisters because of their race, religion, education, gender, ethnicity, nationality, age, economic or social status, physical or mental disability or sexual orientation thereby maintaining the civil liberties/human rights

guaranteed for all citizens of the nation;

Resolved: BGCVA works to assure equal access to healthcare including effective and humane treatment of people with mental illness, ending homelessness and providing decent, safe, and affordable housing for all people;

Resolved: BGCVA works to end Mass Incarceration by modifying national/statewide drug policy to emphasize public health and deemphasize reliance on penal remedies with financial priorities focusing on individualized treatment, education and reform of the criminal justice system;

Resolved: BGCVA advocates for full employment, living/prevailing wage, equal employment opportunity, and fair lending practices;

Resolved: BGCVA works to promote immigration policies and practices that do not discriminate based on race, national origin or ethnicity;

Resolved: BGCVA works to support the enfranchisement and participation of all eligible voters and advocates broadening the base of the eligible voting population;

Resolved: BGCVA works to end racial profiling and overly aggressive actions toward minorities by law enforcement officials and other entities involved in policing.
