VISITOR CONCERNS AND STATEMENTS Kam Washburn	<ul> <li>County Commissioner Kam Washburn reported on recent activity and votes taken by the County Commissioners, including:</li> <li>Commissioners voted to begin construction on a communications tower in the southeast corner of the County. Funds for construction will come from the 911 surcharge.</li> <li>Commissioners voted to undergo interior work on Green Haven Youth Home, located within St. Johns.</li> <li>Commissioners are investigating options to fix the roof on Peck Hall, a building on the Clinton County Fairgrounds.</li> <li>As the County Commissioners Personnel Chair, Washburn helped negotiate and settle the County's contract with road patrol and corrections officers, as well as telecommunications (911 operators).</li> <li>Washburn reported that due to the passing of Greenbush Township Supervisor, Jim Jorae, the Greenbush Township Board has appointed former trustee Eugene Jones as Supervisor, and Roberta Smith as Trustee.</li> </ul>
Assessor Beth Botke	Botke reported that the Essex Township Board of Review went well, the Board reviewed eight petitions and three Disabled Veteran exemption petitions. Botke further reported that the findings of the Board of Review have been filed and settled with the County. Botke further explained that the Huston variance request reviewed by the Essex Township Board at the February meeting has been withdrawn. The property owners are considering combining two

	parcels, which will bring the property into compliance of the zoning ordinance. They are currently waiting for a survey of the land in question.
APPROVAL OF 2/18/2015 MEETING MINUTES	The reading of the 2/18/2014 meeting minutes was waived. Ferguson requested an addition of information under Supervisor's Report – WECS PPO. George moved to approve the meeting minutes as amended. Supported by Gavenda. Motion passed and carried (MPC).

TRUSTEE'S REPORT Website	Ferguson discussed recent activity on the Essextwp.org website, highlighting activity by suspected 'hackers'. Ferguson plans to remove old documents from the website, which seem most susceptible to hacker activity.
Suspicious phone calls	Gavenda reported there have been suspicious phone calls within the Township, with the callers claiming to be representing the IRS. The Clinton County Sheriff's Department is aware of the calls, and recommends residents hang up immediately if they receive a similar call.
TREASURER'S REPORT	George reported the General Fund balance is \$141,987.51. She reviewed income and expenditures since the last meeting. Nearly 95% of taxes have been collected. George presented the Board with a tax disbursement record for summer/winter billing 2014. Bunn motioned to accept the Treasurer's Report, supported by Gavenda. MPC.
CLERK'S REPORT	Bunn reported on expenditures #5434-5445 and income since the February meeting, and reviewed the general ledger for the fiscal year.
Notice of Intent	The Clerk was served with a Notice of Intent to file petition regarding the Township's Police Power Ordinance 16, signed by an
Notice of Drain Assessment	Essex Township resident. The Clinton County Drain Commissioner has notified the Township it will be assessed for Fowler Drain 2, which affects approximately 23 acres in the Southwest corner of the Township. Bunn does not expect the assessment to drastically affect the Township budget. Ferguson Motioned to accept the Clerk's report, supported by Gavenda. MPC.
