I am fully aware and acknowledge that horse sports and the Competition involve inherent dangerous risks of accident, loss and serious bodily injury including but not limited to broken bones, head injuries, trauma, pain, suffering or death ("Harm").

I AGREE to release the Santa Barbara County Riding Club (SBCRC) and its board members from all claims for money damages or otherwise for any Harm to me or my horse and for any Harm caused by me to my horse to others, even if Harm resulted, directly or indirectly, from the negligence of SBCRC or its board members.

I AGREE to indemnify the SBCRC and to hold them harmless with respect to claims for Harm to me or my horse, and claims made by others for any Harm caused by me or my horse at the Competition.

I AGREE I have read the rules of SBCRC and the Competition.

If I am a parent or guardian of a junior exhibitor, I consent to the child's participation and AGREE to all of the above provisions and AGREE to assume all of the obligations of this Release on the child's behalf.
