Old Business

- Standish Fire Department is planning on a controlled structure burn at 99 Chadbourne Road in Standish. We are invited to participate. This will be rescheduled to a future date. The time will be 9:00 AM, on March 21st.
- We have received money from Efficiency Maine for receipts submitted for light upgrade at Station 3. The money was added to station 3 reserve account.
- Forestry equipment receipts are in process for submission for grant reimbursement. Operating budget reflects money spent on forestry equipment but will be adjusted upward when reimbursement received.
- Standpipe management
 - Woods Mill standpipe is out of commission.
 - Quaker Brook standpipe is blocked by sediment. Kyle Estes will check with DEP, then determine a plan.
 - Standpipes on Douglas Hill road should be back flushed. Also need to check culvert that feeds the pond used by standpipe on Weeman Road.
- Pump testing on trucks that are due will be next Monday, Greenwood Apparatus. <https://www.greenwoodev.com/>
- The state requires annual mandatory training. Due to COVID-19 restrictions we will leverage jump drives again for self-directed training.
