PRIVACY POLICY

Collecting Personal Data

Personal data may be collected from you in various ways, such as:

Protecting Personal Data

- Without the consent or express command of this
- In case this is required by the law and/or by the Competent Authorities.

Generally, data collected by users of "HERMES" I.I.A.S.GE's electronic pages and "HERMES" I.I.A.S.GE's forms is not disclosed to third parties and is in not published or otherwise exploited.

"HERMES" I.I.A.S.GE is responsible for processing the personal data collected in the context of operation of its electronic pages, for as long as this is required for the purpose of processing.
