## TITLE: AN ORDINANCE AMENDING THE OFFICIAL ZONING MAP OF THE TOWN OF GREENWOOD, BY REZONING PROPERTY IN THE VACINITY OF THE 9100 BLOCK OF GREENWOOD RD, MORE PARTICULARLY DESCRIBED IN EXHIBIT "A" TO THE ORDINANCE, FROM R-A RESIDENCE/AGRICULTURE DISTRICT TO B-1 BUFFER BUSINESS DISTRICT AND OTHERWIDE PROVIDING WITH RESPECT THERETO

WHEREAS, an application was submitted to the Town of Greenwood Planning & Zoning Commission by Ms Ardenia Frederick, owner, for approval to rezone the property described on Exhibit "A" hereto from R-A, Residence/Agriculture District to B-1, Buffer Business District; and

WHEREAS, the recommendation was favorable for approval by Planning and Zoning Commission.

NOW, THEREFORE BE IT ORDAINED by the Board of Aldermen, Town of Greenwood, in due, legal and regular session convened that the zoning classification of the property described on the attached Exhibit "A" be and is hereby changed from R-A, Residence-Agriculture District to B-1, Buffer Business District
