



# WDA Activities Directors Special Meeting via video conference

President Schumacher called the meeting to order

Schumacher called for additions to the agenda.

Minutes of the May 13, 2020 (Annual) meeting were reviewed. Moved by D. Zittleman seconded by M. Wiest. All vote yes; **Motion carried.**

## Treasurer's Report

M. Mullally, executive secretary, presented current finances. Beginning Balance: \$26,592.65; Only expenditures were the two \$500 WDA scholarships awarded. Ending Balance: \$25,592.65 Moved by M. Lunde seconded by J. Roaldson to approve the current financial report as presented. All voted yes; **Motion carried.**

## Old Business

### 2020 Summer Camp/Training Programs

Discussion resumed moving ahead with summer camps/strength training programs.

Several ADs outlined what guidelines and requirements will be followed by participants and what procedures are being set up by Activity Directors and schools.

Many schools were set up to begin their outdoor camps/strength training programs (Sanford Power) as soon as June 1. Indoor school programs will begin in mid-June. More sport-specific camps will be held in July. S. Martin said he is still unsure when his athletes will be allowed on campus at TMCHS to begin preseason workouts.

The highlights included:

- Limiting the number of athletes in group sessions (Up to 15).
- Not allowing individuals to change groups/times.
- Athletes must come dressed no earlier than 5 minutes ahead of their scheduled time and supply own water.
- No locker rooms will be available.
- In the case of weight training, coaches will spot.
- Temperature reading stations will be set up for coaches/athletes.
- Some schools have made adjustments to move some weights/training equipment to gyms/larger rooms to comply with social distancing guidelines.
- Both custodians and/or camp coaches are responsible for cleaning/disinfecting rooms/surfaces between sessions.
- Schools are working with their strength training providers (such as Sanford Power) to draft a waiver form for participants/families to outline situations when an individual will be held out due to health/safety issues.

Discussion turned to how schools are going to handle transportation for out-of-town camps. M. Lunde said they are not allowing any school transportation with Minot athletes. In fact, programs there are centered around in-house program/training this summer.

Obviously, parents can provide transportation for their athletes to other camps out of the area. The reality, as many ADs pointed out, is there are very few local university program-sponsored camps going on in the area this summer.

### 2020-21 Sports Scheduling

B. Lervick reminded everyone that schedules will go "on-line" beginning June 1 for conference scheduling using RSchool programs.

G. Fridley asked when JV soccer matches are typically scheduled. Most take place prior to the varsity contests.

## New Business

### Athletic Review

The next regularly scheduled meeting is June 3, 2020. Here are Class A issues/recommendations/requests to the advisory board. P. Jundt reviewed the current items for discussion and action.

### Hockey

Move first allowable practice to Wednesday prior to current Monday start date. ADs were not in favor of that as well as the request for an additional game.

Tabled discussion until ADs could confer with coaches regarding a proposal to change the point value system in conference games. The request is to award 1 point to each team after regulation in the event of a tie score. And award a second point to the team that scores in the OT period or wins the shootout which would follow OT. Currently, teams must complete the overtime period before any points are awarded. If the game is tied after overtime now, the teams each would get 1 point and the winner of the shootout would get another point.

### Girls Hockey

Move the entire girls season one week later. Season would begin and end one week later than boys. ADs were in support of this, but understand there are issues to hash out regarding whether that would mean no TV tournament coverage.

### Wrestling

Reinstate the parade of athletes. ADs were in favor of it. They recognized that it will add another responsibility for tournament staff much like the parade of athletes in track.

Increase the event limit from 16 to 17 competitions. If there won't be a second day added to the region tournament, coaches would like another day of competition during the season. A majority of ADs were not in favor of adding another competition date.

ADs added they would encourage schools to continue or consider triangular events in the future. These create a better atmosphere and often means more wrestlers participate on that night. Single duals can often have many open weight classes. Obviously, triangulars can take away home dates for schools, but scheduling could be adjusted so schools still have home dates. G. Fridley and B. Dokken like the set up and believe they have been a good thing for their programs and the conference.

Allow athletes to wrestle six matches in a day. ADs were in favor of it. M. Lunde added South Dakota uses a time limit rather than a match limit for wrestling.

Increasing may mean the state would not be in compliance with NHSF.

Seeding teams, 1-5, for the Class A dual tournament. This would take the place of the traditional seeding bracket (1W vs. 4E; 2E vs. 3W; 1E vs. 4W; 2W vs. 3E). B. Schumacher asked if approving this would open the door for other Class A sports programs requesting an adjustment to seeding for other state tournaments (such as basketball)? It's likely that would be the natural progression.

ADs tabled the proposal to confer with coaches. Given the WDA's noted success in the sport right now, it would likely have several teams seeded in the top five. Whether changing the current format would actually be a detriment rather than a positive is debatable. The WDA has advanced all four of its participants to the semifinals of the dual tournament in each of the past four state dual tournaments.

*Swimming*

If an athlete has a documented allergy to scented oils and/or lotions, the coach shall notify meet management at least one day prior to competition. After notification, meet management will notify competing schools and only unscented oils and lotions may be used. ADs support only unscented oils be permitted during meets.

*Basketball*

Class A and B

Add one game to the number of allowable regular season games. ADs were not in favor of the proposal. Adding one more game would only create more challenges for some programs to find an opponent at this time.

**SID/Executive Secretary Report**

M. Mullally said the 2019-20 on-line yearbook is now posted on the website. This is the fifth edition of the yearbook. It provides a comprehensive look back on the season.

M. Mullally also thanked those who helped him reach out to former athletes to participate in the conference's website feature story series: Where are they Now? Six athletes were featured in the first segment. Another segment will be included later this year.

B. Lervick asked Mullally if he could again supply some more data regarding our website traffic for the past year.

Next meeting will be video conference (Google Meet) on Monday, June 15 at 10 a.m.

President Schumacher adjourned the meeting.

President Schumacher called the meeting to order

Schumacher called for additions to the agenda.

Minutes of the April 16, 2020 meeting were reviewed. Moved by S. Martin and seconded by G. Fridley to approve the minutes as presented. All voted yes; **Motion carried.**

## Treasurer's Report

M. Mullally, executive secretary, presented current finances. Beginning Balance: \$1,447.30; Ending Balance: \$26,592.65 Revenue for the recent West Region Basketball Tournament (\$27,945.35) was deposited into the WDA account. Noted expenditures: May SID/Executive Secretary payments. Moved by S. Nustad seconded by M. Wiest to approve the current financial report as presented. All voted yes; **Motion carried.**

M. Mullally presented the proposed 2020-21 budget. Projected beginning balance was \$19,592.65. Projected revenues are: \$47,192.65. Projected expenditures totaled \$41,350.00. Projected balance following the 2020-21 fiscal year is estimated at \$5,842.65. It was moved by S. Martin seconded by M. Lunde to call a first reading on the budget. All voted yes; **Motion carried.**

## Old Business

### 2020 Summer Camp/Training Programs

Discussion resumed on how to proceed with summer camps/training programs for the various activities and remain in compliance with current health and safety provisions in regard to COVID-19. Activities Directors were planning to meet with NDHSAA, state and local safety officials in the coming week to gain more insight on potential changes to the current state guidelines relating to social contact. How school facilities will be opened and the timetable on when access to those facilities will be granted. It's possible initial access to the facilities may be opened to small groups of athletes. This would enable some training/off season coaching to be conducted while remaining in compliance with health and safety guidelines. B. Lervick said it's important that we're doing all we can to insure these potential training opportunities are available to all athletes. We don't want issues of some having access and others not getting access. It would take some coordinating and scheduling to accomplish that. For now, coaches have been instructed to continue to provide information to athletes/parents relating to possible camps/training, but dates of the potential events have not been firmly established. Activities Directors agreed it's likely many of these camps will be pushed off until late July, if they are held.

### Future Coaching Contracts/Work agreements

M. Wiest asked how other districts are moving forward with future coaching contracts. Are they changing policy/adding provisions in the event future activities/seasons are shortened, suspended or not held due to COVID-19, or other issues? Some districts are putting language into the contracts/work agreements indicating payment may be adjusted in the future due to health or other issues that prohibit the seasons from starting or continuing. D. Zittleman said a good majority of coaches are reasonable and understand the financial ramifications facing the districts. It's not realistic to continue to fund coaching contracts when seasons are not held or shortened. Some pay adjustments are warranted.

## New Business

### 2020-21 Sports Schedules

By all appearances, the 2020-21 schedules are set. Some adjustments may be necessary for the spring sports seasons to align with new dates or work around activities that have yet to be finalized/planned (i.e. prom/end-of-year school programs). Much of this year's spring schedules will be "rolled over" into 2021. There may be a need to alter some of the non-conference schedules/opponents in baseball/softball. M. Lunde thanked those who made adjustments to the spring schedules and contacted EDC schools to set up next year's non-conference scheduling agreements.

G. Fridley said Dickinson is planning to conduct a JV schedule for girls' soccer in 2021. D. Mieure added that Williston will also play a JV schedule for girls' soccer in 2021.

### 2020-21 Executive Secretary/SID Contact

It was moved by M. Lunde seconded by M. Wiest to approve M. Mullally's 2020-21 executive secretary/SID contract. All voted yes; **Motion carried.** The contract will include, as earlier approved, a \$500 increase. Total contract is \$34,500. M. Mullally thanked the ADs for their continued support in his duties to provide these services to the conference.

### 2020-21 WDA Membership Invoices

M. Mullally said he will send out invoices for our 2020-21 WDA membership fee. Full member schools will again pay \$1,000.00. The rate for associate membership is \$50.00 (per activity).

### 2020-21 WDA Meeting Schedule/Dates

The proposed schedule of WDA director meetings for the upcoming activity year were released. Meetings will be conducted in August/November/January/March and June.

J. Roaldson proposed video conferencing be put in place for a majority of our regular meetings moving forward. The technology is there, and it obviously saves time/expense. In-person meetings are necessary, but perhaps just a couple a year.

Along with the idea of video conference taking the place of most of the in-person meetings in the future, M. Lunde would be in favor of more frequent meetings using video conferencing, particularly this spring until we get more issues worked out. Right now, there seems to be a lot of questions/issues left to resolve. It would be best to remain more connected. M. Wiest agreed staying in touch this spring would be a good thing. The ADs decided to conduct the next video conference for Wednesday, May 27 at 10 a.m. and again on Monday, June 15 at 10 a.m. (Using Google Meet).

Following the June meeting, ADs will assess whether more formal video conferencing is necessary until the planned August meeting.

Discussion moved to establishing the time/locations for the two in-person director meetings for the upcoming activity year. It was agreed the August 6, 2020 meeting will be held in Minot, beginning at 10 a.m. The other in-person meeting will be held in Bismarck on March 3, 2021, hosted by St. Mary's High School.

The dates of the video conferencing are planned for: Tuesday, Nov. 10, 10 a.m.; Wednesday, Jan. 6, 2021; and Thursday, June 10, 2021. All times are Central Time. Additional meetings may be called in the future, or changes to the meeting schedule may occur.

### **WDA/West Region Future Postseason Site Rotations**

Two changes are scheduled for the 2020-21 WDA/West Region postseason tournament schedule.

Watford City will host the 2020 W. Region volleyball tournament in place of Dickinson. G. Fridley requested the change in the postseason scheduling. Dickinson will host the event in 2021. B. Dokken said Watford City would be capable of hosting this year.

It was moved by M. Lunde seconded by J. Roaldson to make the post-season scheduling change. All voted yes; **Motion carried.**

In addition, St. Mary's will host the 2021 girls' soccer tournament in place of Mandan. Mandan will host the event in the spring of 2022. Activities directors also set sites/venues for several future postseason region events. Among them:

Girls' Golf: Jamestown, 2022-23; Williston, 2023-24

Girls' Swim-Dive: Bismarck, 2021-22

Wrestling: Williston, 2021-22; Minot, 2022-23; Watford City, 2023-24  
ADs are asked to compile a list of postseason region events they would like to host in the future and submit it to M. Mullally, executive secretary. These requests will be reviewed prior to setting future postseason sites at the annual meeting.

### **WDA Administrative Passes**

M. Mullally asked ADs to compile a list of administrators and their spouses (from each respective school/district) who will need to be issued WDA passes for the 2020-21. The list should include the administrator name/title as well as their spouses/partners name, if they have one. Mullally will create the passes and email them by file to each respective school. The school/districts will be responsible for printing, laminating and distributing them.

### **WDA Lifetime Passes**

M. Mullally asked ADs to forward him a list of former coaches/officials/school administrators/teachers who they deem worthy of a WDA Lifetime Pass. The names should be sent to Mullally by July 1 so he can make arrangements to have them ready for the August meeting.

### **Re-entry policy**

ADs are expecting information in the coming weeks from state and local school officials concerning re-entry policies at their respective schools (for staff/students/patrons). As information becomes available, ADs are encouraged to share it with their colleagues.

### **Athletic Review**

The next regularly scheduled meeting is June 3, 2020. Here are Class A issues/recommendations/requests to the advisory board.

#### **Hockey**

Move first allowable practice to Wednesday prior to current Monday start date.

Add one game to the number of allowable regular season games.

Require officials to apply to work postseason and have coaches vote after January 1.

Require officials to give coaches cards prior to each game.

Change point value for regular season overtime games - two points for winning team and one point for losing team.

#### **Wrestling**

Class A and B

Request by D. Dixon/TMCHS

Reinstate the parade of athletes.

Increase the event limit from 16 to 17 competitions.

Class A

Send three reps from each region to state seeding meeting. Co-coaches count as two reps.

Seed the state dual tournament using the Class B model.

Seed teams 1-5 and random draw other three.

#### **Swimming**

If an athlete has a documented allergy to scented oils and/or lotions, the coach shall notify meet management at least one day prior to competition. After notification, meet management will notify competing schools and only unscented oils and lotions may be used.

#### **Basketball**

Class A and B

Add one game to the number of allowable regular season games.

### **SID/Executive Secretary Report**

M. Mullally said the 2019-20 on-line yearbook will be posted later this month to the website. The yearbook is a comprehensive review of the past activity calendar and includes standings/scores/statistics/notes as well as other historical and pertinent information concerning the conference. This is the fifth on-line edition posted to the site.

Mullally has been able to complete several feature stories on the website focusing on former WDA standout athletes. Mullally thanked ADs for their assistance in tracking down some of these athletes.

Mullally requested ADs forward him the names and cell phone numbers and email addresses of their varsity coaches by July 15, if possible. The information will be updated on the coaches directory pages on the 2020-21 WDA AD Guide/Handbook.

Mullally said scholarship checks were mailed to this year's senior scholar recipients: Aaron Riopelle, Mandan; Alexis Dressler, Legacy  
As we move into summer, changes will be coming to the website as we transition to the 2020-21 season.

Next meeting will be video conference (Google Meet) on Wednesday, May 27 at 10 a.m.

President Schumacher adjourned the meeting.

President Schumacher called the meeting to order

Schumacher called for additions to the agenda.

Minutes of the March 4, 2020 meeting were reviewed. Moved by S. Nustad and seconded by S. Martin to approve the minutes as presented. All voted yes; **Motion carried.**

## Treasurer's Report

M. Mullally, executive secretary, presented current finances.

Beginning Balance: \$7,047.30 Ending Balance: \$1,447.30

There was no revenue that came in during this period. Revenue for the recent West Region Tournament will be deposited into the WDA account later this spring. Estimated revenue from the event is just shy of \$28,000, according to D. Zittleman.

Noted expenditures: March and April SID/Executive Secretary payments. Moved by D. Zittleman seconded by J. Roaldson to approve the current financial report as presented. All voted yes; **Motion carried.**

## Old Business

### 2019-20 Spring Schedules

In accordance with Gov. Burgum's directive of suspension of in-person schooling at public and private institutions due to COVID-19, the NDHSAA has also suspended all extra curricular activities until further notice. The NDHSAA Board of Directors will meet on May 1 and evaluate the current status of the Governor's mandate for in-school closures. The likelihood of returning to in-school for the remainder of the spring is uncertain at this time.

If schools are permitted to open, there would likely be a transition period (a week) for coaches/student athletes to hold structured practices/training before any competitions could be held.

As far as scheduling, ADs agree that teams should play out what games remain on their existing schedules. M. Lunde said this would be the easiest and most sensible approach instead of trying to configure a new abbreviated schedule. P. Jundt agrees that playing out the remaining schedule should be the plan. J. Roaldson said an issue to look at is making sure teams have about the same number of games to play. So adjustments may need to be made to assure teams have about the same number of games played prior to any postseason. G. Fridley said one idea to consider is perhaps having teams gather at one site (Minot and Bismarck) on a weekend in order to get several games played. This is something to consider, if it's evident some teams need to pick up more games.

M. Lunde said while getting back to competition is important for the students and teams, there isn't going to be a push to create a heavy slate of games in a short period of time. Students will have other school activities/events to work into the week in addition to school work. Prom and other end-of-school annual events likely will be worked in.

### Postseason Sites

In the event, the spring sports season cannot be played, the NDHSAA has decided that the host sites/venues for state tournaments for (2020) will be the sites for 2021 (next year). It was agreed that the conference will follow suit and regional host sites for this year's spring activities would be the hosts for next year. The appropriate changes will be made on the conference website.

## 2021 Football Plan

The NDHSAA Board approved last month moving forward with the new football classification/scheduling plan beginning in the fall of 2021. The plan was proposed by Grand Forks Public Schools AD M. Rerick. 11AA and 11A Divisions will consist of Class A schools and any co-op that contains 160 or more male students in grades 7-10 for two or more consecutive years. By Sept. 15 of this year, all schools have to decide what classification they will be in. A vast majority already know where they will fall in, but there are a handful of schools which currently have a choice to make, according to P. Jundt.

The plan still has some ironing out to be done, including the matter of teams having to play seven intra-conference games. Making sure that is possible means some scheduling adjustments need to be looked into. P. Jundt said some of the earlier issues raised by WDA ADs, including competitive imbalance of large-sized schools playing small-sized teams, continue to linger and have been mostly left unaddressed. B. Lervick added that he is also getting a sense that some of plan's backers are reluctant to have these conversations.

## New Business

### Middle School Season

G. Fridley asked how realistic is it for middle school activities to be conducted this spring, if we are not able to return to in-school contact prior to May 1? Fridley said most of his sub-varsity activities wrap up around May 15, so if there is a transition period of a week to get teams back into practice/shape, that would leave just a little over a week or so for a season. Fridley is considering a decision to cancel middle school activities in his district, but wanted to get some feedback from others ADs. He doesn't want any decision Dickinson makes to negatively impact/create confusion for other schools in our conference. M. Lunde said it would be best to hold off any decision and see what directive comes from the NDHSAA in the next couple weeks. It may save some phone calls and questions from patrons. The fact there is still a possibility of competing is keeping these kids engaged in their sport and doing some independent training, said D. Zittleman. And that is a good thing. ADs agree they don't want to give kids false hope, but it seems holding off any decisions on canceling seasons is a prudent approach at this time.

### JV Season

While most JV games/events also finish before the varsity schedule, there are similar questions about just how much of a season can be conducted if games/competitions don't begin until May. The ADs generally agree the best approach at this time is to hold off any decisions regarding canceling the season.

### Participation/Activity Fees

M. Wiest asked what other schools districts are deciding when it comes to activity/participation fees, if the season is canceled, or only a portion will be played. In the event a season is not played, M. Lunde said Minot will just roll over any fees into next year's activities for the participants who return. Graduating seniors would get a refund. Lunde said there is no plan to refund partial payment for an abbreviated season. Other ADs agree that the value athletes receive in terms of coaching/training is significantly more than the current activity fee rate.

### One-day Orchestra Event

It was moved by P. Jundt seconded by D. Zittleman to support a recommendation by region/WDA orchestra instructors to establish a one-day region orchestra event, beginning as early as the 2020-21 year. The event would be independent of regional/WDA choir or band competitions. The issue will come forward to NDHSAA directors for consideration. All voted yes, **Motion carried**



#### **EDC-WDA Crossover**

B. Lervick asked if schools would be OK with rolling over the WDA-EDC crossover schedule (Baseball) from this spring into next year in the event no cross-over games will be held. Additionally, ADs felt it would make sense to roll over all spring schedules from this year into next year as possible in the event the spring season is not held. No point in creating a new schedule.

#### **Fall Extra Duty Contracts**

Discussion about how school districts were handling extra duty (coaching) fall contracts, and how they are being implemented in their current salary schedule. Several ADs indicated that extra duty contracts will be separate agreements, and not tied into their teaching contracts due to the uncertainties of when fall activities would start, or if some duties won't be needed or will be reduced. Districts don't want the awkward situation of having to ask for/collect funds from teachers/coaches that have been paid out ahead of time.

#### **Summer Camps/Weight Room Access/Organized Training**

Since there is no clear indication at this time when sports activities will return to normal, schools are moving cautiously regarding summer camps and training programs. Planned summer camps are not conducting early registration or collecting funds at this time. Coaches/Programs don't want to have to refund money, if planned activities are canceled. Schools are allowing coaches to get information out to athletes/parents about possible camps and training programs, but no decision has been made as to whether they will be a "go" or not.

#### **Awarding letters**

With the prospects of no spring activities, a question raised was how to award letters to students. Most are of the opinion to go ahead and letter the students, despite no games/matches. While it may seem unconventional, most will understand given the present state of things. ADs will leave it to their coaches to determine which students likely would have been participating at the varsity level. M. Wiest said, if there is any doubt of whether a student who have played, side on awarding a letter/pin. It's a small price.

#### **Volleyball Scheduling Conference Opponents Once**

J. Roaldson asked what has been the common practice for WDA teams playing just once in the regular season. Sports, like boys' hockey, have allowed for teams to meet once for varsity points. Often, a second game is played but is designated as a "JV game" and does not count in the league standings. Both teams have to agree on this arrangement. J. Roaldson said his volleyball coaches are exploring options about playing an EDC opponent for a non-conference match, but that would likely mean it would have to drop one of its varsity matches with a conference team. Concerns were raised that could open the door for other teams to pursue playing some teams once for "double wins" in order to free up a match to be used for non-conference play. Will this create scheduling challenges then for those schools who are seeing the number of varsity matches reduced? Again, ADs stressed the arrangement has to be mutually agreed upon.

#### **Class A Review**

The committee will consider the request from Orchestra instructors to conduct a one-day orchestra competition. Another issue to review will be the postseason seeding procedures for wrestling and problems that arise with some wrestlers reaching match limits before the region tournament concludes. Subsequently, affecting seeding placement.

#### **Tournament Committee**

The 2021 Volleyball Tournament will be held in Bismarck. The decision was made by the NDHSAA tournament committee earlier in April.

#### **SID/Executive Secretary Report**

M. Mullally is working on the completion of our fifth on-line WDA yearbook. This is a comprehensive review of all our sports/activities as well as additional items, including listing team scholar awards and general WDA information. He is waiting for the fate of the spring sports season before the yearbook will be ready to be uploaded to our website. Also, he is working on a feature series of stories for the future, entitled, "Where are they now?" The series will be on former WDA standout athletes/coaches and what they are up today. If ADs have some possible candidates for the stories, let Mullally know.

### 2020-21 Basketball Scheduling

B. Schumacher said the plan is to go with the 2020-21 schedule plan that was initially put together earlier this year. There may be a need for some adjustments for some schools. J. Roaldson said in the future

Jamestown may entertain a plan to hold boys and girls games separately (no doubleheaders). A smaller pool of area officials to draw from is making it increasingly difficult to play multiple games on one night.

## WDA Senior Scholar Award/NDIAAA program

P. Jundt, who oversees the scholarship program on behalf of the WDA, requested the completed applications for the 2019-20 WDA Senior Scholarship program. As in the past, each recipient receives a \$500.00 scholarship and then will be eligible for the state scholarship. A selection committee comprised of ADs will review the applications and select a boy and girl recipient. Plaques will also be awarded to the recipients, courtesy of Farmers Union Insurance, who provides a match in funds. The winners will be formally recognized at the W. Region basketball tournament.

## HUDL review

HUDL representatives met with several Athletic Directors over the past few weeks to outline services and contract coverage. The break down consisted of a \$8,000 per-school rate. That equates to about 100 hours of video coverage for each level of each sport. That also includes the sideline/assist programs for statkeeping. S. Martin said there are other options available to look into that may enable more cameras to provide video/livestreaming services. One, would be NFHS. M. Lunde said Minot has used NFHS to provide a live streaming option and its been a good program for them.

## New Business

### Winter Sports Coaches Meetings

**Basketball:** The coaches elected not to submit names of officials to nominate for postseason tournament assignments. Some said they don't get the opportunity to see many of them work games, or don't see them until after the request to nominate officials is held. Many would like to see the sophomore tournament expanded to enable all teams to take part. Potential issues would be venue and officials availability as well as an odd-number of teams making it difficult for a true bracket tournament to be held.

**Boys' Hockey:** Coaches would like to move the region play-in game to the Saturday proceeding the West Region Tournament Quarterfinals. Currently the game is played on the Monday prior to the W. Region Tournament Quarterfinals. That recommendation will come to the NDHSAA for consideration. Also, coaches request officials leave the ice following the completion of games to eliminate the chances of after-game verbal altercations between coaches/players and officials. D. Zittleman said the officials are required in the rule book to remain on the ice following the game and handshake of teams. Therefore, no changes can be made until a rule book change is made at the NFHS level.

ADs expressed the need to "clean-up the colorful language" that is currently used often in hockey among the players, officials and coaches. This is not tolerated in other activities. Working with coaches and officials to take the lead on this issue moving forward was agreed on.

**Girls' Hockey:** A majority of coaches again expressed a desire to split away from the boys' state tournament.

**Wrestling:** A concern regarding the seeding process for the state individual tournament was raised by P. Jundt after some wrestlers were not able to finish region placing round matches (ran out matches). The system in place to seed wrestlers for the state competition has come under scrutiny. Procedures in place were not followed. As a result, seeding has become a clash of coaches, at times. P. Jundt asked what is the point of holding a region tournament if the seeding isn't going to be followed as intended under the current criteria. ADs asked if the NDHSAA can take a closer look at how the seeding is conducted to provide consistency. One

of the main points of contention is when there is an imbalance in talent in weight classes between the two regions. As a result, some individuals are forced to go into the tournament unseeded, or hold a lower seed. This could create early round matchups of wrestlers that should be meeting later in the tournament based on their head-to-head records and not the region seeding.

G. Fridley said Dickinson would like to be taken out of the rotation to host the West Region Wrestling Tournament for 2021-22. Given the need for a 4-mat minimum layout, the current gym at Dickinson would not be able to provide that set up as well as suitable seating.

**Gymnastics:** Only concern raised is the process of how coaches vote for senior athlete and coach of the year. If one individual is the coach of multiple teams should they be able to vote multiple times, or should they receive just one vote. D. Zittleman pointed out that in other activities each coach receives a vote for each team they coach.

**Boys' Swim-Dive:** No issues of consequence reported.

#### **Play-in Dates for Basketball**

ADS voted to rescind the current motion relating to schedule dates for West Region play-in basketball games. The current motion requires them to be completed by the Friday proceeding the West Region Quarterfinal Round. It was moved by J. Roaldson seconded by G. Fridley to rescind that motion. All voted yes. **Motion carried.**

A motion was made by J. Roaldson seconded by S. Nustad to allow the basketball play-in games to be completed by the Saturday proceeding the West Region Quarterfinal Round. The date and time of the games will be mutually agreed upon by the teams involved in the play-in contest. All voted yes. **Motion carried.**

#### **ADOTY Award**

P. Jundt was selected as this year's WDA/W. Region Athletic Director of the Year. A vote of the WDA AD members was conducted. Jundt will be formally recognized at the West Region Basketball Tournament.

#### **Proposed Football Plan**

ADs resumed discussion on the proposed new football scheduling plan for 2021 as presented by Mark Rerick, Grand Forks Public Schools Activities Director. The prospects of some current AA teams facing AAA teams in regular season play under this proposal raises immediate concerns regarding competitive imbalance and how this would be detrimental to programs with smaller roster sizes moving forward. There is also the issue of how these intra-class matchups would create issues relating to sub-varsity scheduling. Some AA schools may not be able to fill out a JV game for the week due to small roster size/injuries. As a result, some AAA may not have a game that week for its JV/sub-varsity roster. Several ADs prefer pursuing alternative plans that take into account all these issues. The topic will continue to be discussed among Class A athletic directors this spring.

#### **League of Student Councils**

S. Martin proposed a project that would bring student council leaders from the WDA/W. Region together to share ideas and review issues the students face in each respective schools. Also, to address any misconceptions there may among the member schools in terms of culture, identity and interests. The idea was proposed to S. Martin by his student council. The other ADs felt this was a good idea and plans are in the works to find a time when the representatives can meet.

#### **SID/Executive Secretary Report**

M. Mullally said the winter sports season, which is wrapping up, went well in terms of coverage/content on the website and social media. No significant issues to contend with at this time.

#### **NDIAAA**

The next NDIAAA meeting will be March 28-30, Fargo.

#### **Outdoor Track-Field Meets**

D. Zittleman added that if weather conditions continue to improve, the plan would be to forego planned indoor meets and compete outdoors.

Next meeting (Annual Meeting) is Thursday, June 4, 2020 at 11 a.m. at TMCHS Belcourt.

President Schumacher adjourned the meeting.

## Old Business

### 2019-20 Schedule Items

#### Basketball

Due to injuries, some teams may need to adjust sub-varsity schedules accordingly.

#### Girls' Soccer

Dickinson will likely be fielding two JV teams this spring.

#### Baseball

B. Lervick reviewed/outlined the 2019-20 schedule plans which will include non-conference games at the beginning of the schedule, weather permitting. The region play-in games will be scheduled for the Monday preceding the W. Region Tournament.

#### Third-Party Live Streaming

Continued discussion on the issue of third-party live streaming of events. Schools officials/ADs continue to monitor the activity. Some schools/districts have, or are considering adopting in-house policies to address live-streaming/taping events. As of now, the conference has not established a policy regarding the matter.

As for NDHSAA-sponsored postseason activities, live-streaming is prohibited and offenders could be removed from the event and/or fined. ADs agreed it would be a good idea to include a spot in their postseason programs/booklets to remind fans that live-streaming is prohibited under NDHSAA rule

## New Business

### Proposed Football Plan

A proposal/idea for a change in future football AAA/AA scheduling was recently forwarded by Grand Forks Public School Activities Director Mark Rerick for consideration. The proposal would result in a schedule where AAA and AA teams would play some "cross-over" games between the two classes.

The prospects of AA teams facing AAA teams under this proposal does create immediate concerns regarding competitive imbalance; how will this be received by schools/patrons used to playing only schools/teams within their enrollment size; and logistically is it possible due to the difference in current number of AAA and AA teams.

One of the ideas behind this proposal is to alleviate some travel issues, mainly for some AA programs. The proposal would be a four-year plan. The idea behind four years instead of the customary two-year football scheduling plan is to limit having to re-hash and work out schedules more frequently. The Class A committee will review it and make recom-

mendations to the NDHSAA at a future meeting. Any changes to scheduling would not begin until the fall of 2021.

### 2020-21 basketball scheduling

G. Fridley asked if this would be a good time to begin discussions with all Class A schools to establish a state-wide non-conference schedule plan. Would be similar to what is established in football. WDA schools only have one non-conf. game due to the current double round robin WDA schedule. However, even one game is not easy to fill. Williston and Watford City faced each other earlier this season because neither could find a non-conf. opponent. Fridley said in future years Dickinson won't have the option to schedule a S. Dakota/Montana opponent due to changes in scheduling in those states. Many WDA teams have a current arrangement to play an EDC school. However, some EDC schools have opted to play teams in Minnesota making it more challenging to pick up the extra game. Fridley said he would entertain playing an EDC opponent in Bismarck to help cut down on travel concerns from EDC teams. The issue will be brought up with Class A ADs at a future meeting.

### WDA logo/trademark registration

M. Mullally said with the expanded use of the conference logo, it would be a good idea to officially register the trademark with the ND Secretary of State. This would assure ownership of the brand/logo for its conference members. ADs instructed Mullally to move forward on the matter.

### WDA Senior Scholar Award/NDIAAA program

Applications will become available to each AD/member school for the WDA's annual senior scholar award. A senior boy and girl will be awarded a \$500 scholarship. WDA business partner, Farmers Union Insurance, is again providing a match in funds. The scholarship guidelines are established under the NDIAAA program and details can be obtained by going to the NDIAAA website. The winners of the WDA award will then be eligible for the state scholarship. P. Jundt is overseeing the application process on behalf of the conference. Applications should be turned by prior to the ADs Feb. 29 meeting. A selection committee will be created to review the applications. The winners will be formally recognized at the W. Region basketball tournament. Since 2009, the WDA has been recognizing two scholars.

### ADOTY Award

The annual vote/selection of West Region athletic director of the year is approaching. Mullally will create a AD ballot which will be handed out at the Feb. 29 meeting. As custom, the ADOTY will be recognized at the West Region Basketball Tournament.

### 2020-21 Boys' Hockey Scheduling

As of now, both association boys' hockey members -- Hazen-Beulah and Bottineau-Rugby -- plan to have JV teams in addition to varsity next season. S. Nustad said schools should make schedule plans accordingly.

### Date change for June WDA AD meeting

Due to some conflicts with other meetings/events, the date of the June WDA meeting has been moved to Thursday, June 4. The meeting is hosted by Belcourt, beginning at 11 a.m.

### Athletic Review

P. Jundt went over some of the items of consequence as discussed/reviewed by the committee.

Boys' Soccer: Move the starting date to Aug. 1...Coaches and head referee would need to complete a match report following games and submit to NDHSAA.

Football: Move the start practice day from Wednesday to Monday (essentially provide two additional practices).

Girls' Golf: Set the start date to four weeks from Labor Day...Establish two in-season state qualifying meets to enable more golfers the chance to qualify individually for the state meet.

Volleyball: Make revisions to rule/guideline language as to who should be representing teams at the pre-match captains/officials meeting.

**Sub-varsity baseball, softball tournaments**

If weather permits, the WDA will again hold sub-varsity baseball and softball meetings this spring. Plans are for Bismarck to host the JV1, JV2 baseball tournaments, May 15-16. Minot will host the JV2 softball (May 15); and JV1 softball (May 16). Once participating schools know how many sub-varsity teams they will field this spring, officials should contact the tournament hosts so plans can begin on setting up the tournaments.

**HUDL review**

Officials from HUDL are planning to meeting with a number of WDA schools in the coming weeks to review the service and discussion payment plans. Some schools within the conference use the video/stat highlight program more than others. One issue ADs would like to resolve/have answered is if a consistent cost/price and payment schedule can be adopted for members.

**NDIAA Report**

M. Lunde attended the national event in December and said North Dakota was well represented at the convention. Lunde said it's nice to see North Dakota be involved in the national leadership positions. Next year's event is in Tampa, Florida.

**Tournament Committee**

G. Fridley expressed disappointment in the recent change of venue for the 2021 cross country meet from Dickinson to Jamestown. Fridley said it's becoming increasingly more difficult for his community to receive state tournaments other than gymnastics. While it's evident some communities/cities can't host the larger/more prominent state tournaments (basketball, football), those smaller communities should receive consideration in the tournament selection of other smaller events. One of the reasons for the change in the CC venue, was to move it to a facility/site which could better accommodate the Class B portion of the meet which involves more teams/runners/spectators.

**State Volleyball**

The 2020 state volleyball tournaments will again be held in Fargo. This past year's event in Fargo was well-attended and produced a sizable profit for the NDHSAA. Minot, which has hosted the event as well, is on the schedule to host the 2021 event. Bismarck is a potential site for a future tournament, but no formal decisions have been made.

**SID/Executive Secretary Report**

M. Mullally said there have been no major issues to report regarding website maintenance/content upload. During this time of year, boys and girls basketball weekly stat recording becomes an added task. Stats are taken from each school's respective HUDL accounts and put in pdf form to make it easier to read/follow for media/teams/patrons.

## Treasurer's Report

M. Mullally, executive secretary, presented current finances.

Beginning Balance: \$15,917.59 Ending Balance: \$16,854.34

Noted revenue was \$1,370 for WDA Cross Country Championships; \$2,466.75 for WDA Boys' Soccer Tournament; \$6,000 for WDA membership fees (BHS, Century, Legacy, Minot, Watford City, Williston). Noted expenses were: \$8,400 to M. Mullally for three months of WDA executive secretary/SID services.

D. Zittleman said the conference had about a \$500 loss this year in its WDA Girls' Swim-Diving Meet. Moved by S. Nustad seconded by B. Lervick to approve the current financial report as presented. All voted yes; **Motion carried.**

## Old Business

### 2019-20 Schedule Items

#### Basketball

Members shared the number of sub-varsity teams they are anticipating this winter for basketball.

Discussion turned to postseason sub-varsity tournaments. It was moved by M. Wiest and seconded by B. Lervick to limit the field of tournament teams for Sophomore A boys and girls to eight teams. This would enable equal number of games per team and make tournament planning easier. In the event Mandan, the tournament host, finishes ninth, a play-in game would be held. All voted yes. **Motion carried.** Any teams that do not finish in the top 8 of standings, they would be permitted to be seeded in B tournaments, if tournaments are scheduled. In the event no tournaments are planned, schools can arrange additional B-games.

#### Hockey

M. Lunde said Minot would be willing to plan JV girls' hockey games this season with teams. Games would precede the varsity contest.

#### Track

D. Zittleman said track scheduling has been completed, but there likely will be a few changes. Schedule updates will come at future meetings.

#### Girls' Soccer

TMCHS and Williston will again field JV girls' soccer programs this spring. Dickinson will also field a JV program.

## E-Sports Update

M. Wiest and D. Mieuire gave update on how E-sports programs are doing in their respective schools (Mandan and Williston). This is the first year of the program, and as expected, there has been some growing pains. D. Zittleman added that there just hasn't been a significant interest in starting programs in Bismarck schools. Other ADs echoed the interest level in developing programs is not high. Given all the glitches, and unknowns still to work out, Zittleman believes this program really isn't ready to be launched as a NDHSAA-sanctioned activity.

## New Business

### 2019 Fall Sports Review/Coaches Meetings

#### Volleyball

At the coaches meeting, a concern was again expressed about the unbalanced schedule and the match ups for one-point and two-point contests. Also, concerns about the current tie-break criteria involving more than two teams when the teams have not played an equal number of matches.

The conference completed year two of a five-year schedule rotation established to provide better travel equity for programs outside the Bismarck area. As a result, teams play a double round robin schedule against 8 teams and then single matches against 2 teams. In those instances, the matches are worth 2 points/2 wins in the standings. Bismarck-Mandan schools play both 2-point matches on the road. M. Wiest would like to see the five-year schedule plan completed before coming forward with any new schedule changes. Obviously, there are drawbacks when there is not a double round robin schedule. As a result, two of the matches needed to be designated as a double counter to establish the needed balance when it comes to addressing any ties. Which teams play twice and/or once against certain opponents during a season can greatly affect the potential finish in standings, but arguments could be made (pro or con) by any team about the current arrangement.

This season, instead of "doubling the wins" in the standings for those matches involving teams that met just once, points were awarded. Teams received 1 point for a win against a team it played twice and 2 points for a win against a team it played once. However, this arrangement allowed for the potential for a team to be above another team in the standings with more points, but fewer wins. P. Jundt said this very situation almost played out on the final night of regular season play. And this would have created confusion and warranted criticism in regards to how postseason seeding was established by the conference. Fortunately, that did not occur, but a change for next year is needed to avoid this situation again.

The options available to remedy the unbalanced conference schedule are not appealing. Teams could play a double round robin schedule, but would have to give up an in-season tournament. Teams could play just a single round robin schedule, but that would force teams to pick up a half-dozen matches to fill out a schedule. Some programs would not be in a great position to fill out their schedules. And then there is the issue of playing conference teams in non-counters which is not a popular proposition among many coaches/ADs. Discussion about counting each match for 1 point and then using an alternative tie-break criteria was discussed. ADs were presented with a tie-break criteria presently used in the GPAC (collegiate conference). It was moved by J. Roaldson to count each match in the standings as 1 win (No double counters adjusted in the standings) and then adopt the tie-break criteria presently used in the GPAC. Motion died for a lack of a second.

It was moved by P. Jundt seconded by M. Wiest to count single matches in the standings as double wins/double losses. Tie-break would be adjusted to double wins in the case when teams only play once. Also, next season, the standings displayed on the conference website would not feature a points or matches played column. **Yes:** P. Jundt, M. Wiest, S. Nustad, B. Lervick, S. Martin, D. Mieuire, B. Dokken, B. Schumacher, D. Zittleman **No:** J. Roaldson, M. Lunde; **Abstained:** G. Fridley. 9-2 vote. **Motion carried.**

#### Girls Golf

D. Mieuire said no issues were brought up at the region meeting in Williston prior to the region tournament. Coaches reviewed the tentative 2019 schedule which will include Watford City hosting a JH event for the first time. Following the season, some coaches expressed concerns

with the lack of an adequate practice area at the Dunseith Garden Gate G.C. (TMCHS Invite). Players don't have an area to hit range balls/work on short game prior to start of the tournament. Also, a few holes pose safety concerns as players on the tee box can't see groups in front of them (due to hills). Concern of tee shots being hit into the groups. S. Martin said he was assured by golf course management that plans have been made to complete a sufficient practice area. No action taken on the matter.

P. Jundt said the plan is for scoring marshals/volunteers to accompany playing groups at the individual state qualifier that will be hosted by Legacy next season. This would enable golfers to play without the need to monitor other golfers scores and would head off any honest scoring mistakes and/or deter shaving strokes/cheating.

#### **Boys Soccer**

With the addition of Dickinson to varsity play next season the regular season conference schedule will expand by two matches and the WDA Tournament will now feature eight teams. A majority of coaches still do not support a postseason conference tournament. There are concerns about the potential for injury in hosting the event prior to the state tournament. Also, some believe the regular season top four finishers should be rewarded and automatically qualify for state. ADs support conducting a tournament and its many benefits to athletes/programs. It will continue to be held. Coaches did express a desire to change the tournament format. And in the future, allow other schools/cities to host the event. Postseason proposed tournament schedule: Thursday (Play-in matches at the higher seeded site; No. 8 at No. 5 and No. 7 at No. 6. Saturday (State qualifiers at the tournament site). Winner of 5/8 match would play No. 4; Winner of the 6/7 match would play No. 3. Championship would be No. 1 vs No. 2. Both those teams automatically qualify for the state tournament by way of a top two regular season WDA finish. Moved by M. Lunde seconded D. Mieure to adopt the coaches recommendation for the WDA Tournament format. All voted yes. **Motion carried.**

#### **Cross Country**

G. Fridley said no issues were brought up at the coaches meeting prior to the conference meet. Dickinson hosted the meet after snow/wet conditions prevented Jamestown from holding the event. There was discussion about moving future state meets off of golf courses completely due to frost concerns. Fridley said he can't recall this being problematic. The concern of having future meets solely on trail courses/recreation areas is it limits where these meets can be held. And thus, takes many communities out of the possible rotation to host.

M. Lunde added future schools/towns that host the state meet should plan to hold its pre-state meet/reg. season meet earlier in the season to allow time for race course to recover from any wear and tear from the regular season meet.

#### **Boys' Tennis**

D. Zittleman no issues were brought up by coaches at the region meeting held in conjunction with the conference tournament in Bismarck.

#### **Girls' Swim-Dive**

D. Zittleman said there was discussion about possibly conducting the WDA Championship over two days (Friday night/Saturday). Concerns would be additional rental costs and paying tournament officials as well as finding enough volunteers to cover two days. This year's meet was conducted in Bismarck over one day and was completed by 6 p.m. Another discussion point among coaches/officials is to assure consistency in order of events/procedures of holding the event from one site/venue to another.

#### **Cross Country/Track Entry fees**

D. Zittleman said there should be consistency in team entry fees for track-cross country events throughout the conference. He would establish suitable fee rates for (Varsity/JH events) and forward it to ADs for consideration.

#### **JV Hockey**

J. Roaldson asked what our end-of-game procedures should be for tied games at the JV level. Conduct an overtime period? Don't have an overtime period? Go directly to a shootout? There should be consistency across the conference. It was moved by J. Roaldson seconded by B. Lervick to implement a 3-player shootout following regulation. All voted yes. **Motion carried.**

#### **NDHSAA Controlled substance violations**

B. Lervick said with Cannabidiol (CBD) is becoming a more prevalent substance. Should it be specified by NDHSAA in its policy of controlled substance violations? Schools need to address this to its students who are involved in activities. As of now, it is not.

#### **Student Prescriptions-Medication**

J. Roaldson inquired how other schools/programs address students in activities that also have medication/prescription needs.

#### **Girls participating in Wrestling programs**

WDA ADs were asked to compile potential girl participation numbers for wrestling at the varsity-middle school levels. Several schools indicated they would have a handful participating at the varsity and/or MS level.

#### **Future W. Region/WDA site rotation**

Brief discussion on whether the current rotation of schools/sites for future WDA/W. Region postseason tournaments be adjusted to enable Bismarck schools to be in the rotation more than once every 6/7 years. Under the current arrangement, Bismarck is in the rotation (collectively) among the other conference schools. St. Mary's would like opportunity to be able to host some events in the future. Proposal/possible changes will be reviewed at the June meeting when future postseason venues/sites are determined.

#### **rSchool schedules**

B. Lervick reminded ADs of the Dec. 1 date to have spring 2019-20 scheduled uploaded on the site.

M. Wiest also said coaches should be checking the r-school sites on their team pages in the event of any changes to schedules.

#### **SID/Executive Secretary Report**

M. Mullally asked ADs to forward any contact numbers to him regarding Fine Arts advisors. The website provided information/results for these activities. Mullally wanted to get a current list.

ADs are reminded to have their basketball coaches included Mullally on the HUDL account as a coach/administrator, if they have not done so already. This will enable him access to stats which are compiled weekly on the conference website during the seasons.

#### **Athletic Review**

P. Jundt reviewed current NDHSAA athletic review items.

Of the noteworthy items.

-A second individual state qualifier would be permitted in the Class A girls golf season, beginning in 2020.

-Boys' soccer coaches again requested a start date of Aug. 1....Coaches and head referee would need to complete a match report following games and submit to NDHSAA.

#### **NDHSAA State Tournament Committee**

D. Zittleman said any WDA schools/communities interested in hosting future state tournaments/events, should contact him prior to the next state tournament committee meeting in mid-December.

President Schumacher adjourned the meeting.

Minutes of the June 3, 2019 meeting were reviewed. Moved by J. Roaldson seconded by Ben Lervick to approve the minutes as read. All voted yes; **Motion carried.**

## Treasurer's Report

M. Mullally, executive secretary, presented current finances. Beginning Balance: \$16,220.01 Ending Balance: \$15,917.59 Noted revenue was \$774.04 from the 2019 WDA Baseball Tournament. TMCHS, St. Mary's and Jamestown submitted 2019-20 WDA membership fees of \$1,000. Note expenses were \$5,000 to M. Mullally for final two payments for Executive Secretary/SID services for 2018-19. Moved by D. Zittleman seconded by S. Martin to approve the current financial report as presented. All voted yes; **Motion carried.** A second/final reading was held on the 2019-20 WDA operating budget. Projected revenues total \$43,517.59 with expenditures at \$40,865.00. Moved by S. Martin seconded by D. Zittleman to approve the 2019-20 budget. All voted yes; **Motion carried.**

## Old Business

### 2019-20 Fall Sports-Activities News/Notes

#### Volleyball

The annual Freshman Tournament will be held in Jamestown, Aug. 30. Schools planning to participate should contact J. Roaldson regarding scheduling.

#### Cross Country

Minot is hosting this year's 2019 Class A-B Meet. The order of running will for 'A' will be Boys and then Girls. The Aug. 26 meet, will be held at Souris Valley G.C.

#### Boys' Soccer

J. Roaldson said with the increasing challenges to get teams to commit to the event, this likely will be the final East-West Crossover hosted by Jamestown. Roaldson said some teams request to play on a specific day and/or only wanted to play one match. These requests made it difficult to put together a schedule. With the increased number of boys' soccer teams, not every varsity program can take part in the event. This year's event is Aug. 16-17.

#### Live Streaming Events

Discussion resumed about establishing a conference policy for requests to live-stream WDA postseason events. The policy would align with fees/regulations already in place by the NDHSAA regarding postseason events.

At the June meeting, schools were encouraged to adopt their own "in-house" policies to address requests by individuals to live-stream events to outside audiences. Despite this being a public event, schools have the right to limit and determine who will be permitted to live-stream/broadcast its activities. These policies could set a fee as well as other requirements (i.e. the need to formally contact the school/AD ahead of time as well as determining where live stream operators could be stationed at the venue so not to infringe on those attending the event).

Although live-streaming does enable audiences that could not attend

the event to view it, it does take away revenue and attendance. "Tape-delay" of these events would better serve the school. P. Jundt said this practice should be encouraged to these individuals who are live-streaming. Even if the events were downloaded/video streamed the moment after the event finished. No action was taken on drafting a policy. The matter will continue to be reviewed.

#### By-laws/Constitution

M. Mullally has requested directors review our current by-laws/constitution, which is posted on-line on the website, to determine if any policy changes/updates are necessary. Issues will be addressed at a future meeting.

#### WDA 2019-20 Membership

M. Mullally reminded directors to submit their 2019-20 WDA membership payment by Sept. 1. The fee is again set at \$1,000.00. An invoice was included in the June meeting packet, but a new one could be forwarded, if requested.

## New Business

### 2019 WDA Boys' Soccer Tournament

With the addition of Williston to varsity competition this season, the number of teams has again reached seven for WDA play. Therefore, the WDA Tournament will again be held over two days, Oct. 3 and 5 and hosted by Mandan. The play-in match will be on Oct. 3; Two state qualifiers and the championship will take place on Oct. 5.

In the future, the event likely will be expanded to three days with the addition of new varsity programs.

#### rSchool On-line Scheduling matters

Directors revisited the matter of posting schedules/side notes with the rSchool on-line schedule program. Challenges remain when posting sub-varsity events among schools. Not every schools has the same number of sub-varsity teams. This can create some confusion at times for patrons when teams from two different levels are playing. (for example: a Sophomore A team from one schools is playing a JV team from another). These schedules may appear different on different team schedule sites.

#### Class A West Article

J. Roaldson said our conference/region needs to submit an article for an upcoming NDIAAA magazine. Any number of issues/topics could be written. It will need to be submitted by Jan., 28, 2020. M. Wiest volunteered to write the article on behalf of the conference.

#### 2019-20 WDA/West Region Coaches Meetings

M. Mullally submitted a listing of the 2019-20 tentative dates for region coaches meetings. One likely change will be for football. The proposed date may conflict with current scheduling. As customary, meeting minutes should be taken by the coaches and submitted to the AD in attendance.

#### e-Sports

M. Wiest said progress continues to be made on the e-Sports program at Mandan which will be launched this school year. A lab/classroom has been set up and a coach/advisor is close to being hired. A number of schools across the state are in the process of establishing programs. It's likely this will become a NDHSAA sanctioned activity in the near future. There still continues to be a number of questions to work out with this new activity. Among them: What e-games will be offered? How are teams/competitions established? What is the cost for coaches/advisors as well as gaming equipment? How to accommodate for a large number of participants? How does this new activity align with the school and district philosophy in establishing learning opportunities and experiences for students? D. Zittleman said there are just so many unknowns right now. It's not an activity we're familiar with and until more programs get started, planning and establishing a budget will be challenging.



**JH Basketball officials payment**

D. Zittleman said in Bismarck the pay fee for JH basketball will be set at \$38.50 for 14-minute halves for this school year. Districts can establish their own payment schedule but a consistent fee rate across the region may be good to have to avoid confusion/questions.

**Volleyball Warm Up Rule**

Concerns were raised regarding the regulation that a team captain No. 1 must attend the pre-match conference with officials. If this is not followed, a coach could be issued a yellow card penalty. M. Lunde said the rule seems to be unnecessary and should be revised. Directors will contact the NDHSAA to determine if this could be changed in the future.

**Off-Season Volleyball Uniform Use**

Many athletes take part in spring/summer volleyball tournaments.. Under current rules, teams cannot wear school uniforms. This has made it difficult/challenging at times to get matching uniforms. B. Lervick asked if we could work to remove/change the language in the rules to permit teams to wear school uniforms.

**Pre-game music played at events**

D. Zittleman asked what other districts pay for/use for computer programmed music for pre-game activities. Some indicated they use the program "Sound Director".

**Girls participating in Wrestling**

With the growing interest in girls participating in wrestling, our WDA programs should be keeping track of the number of girls interested and/or will take part in the sport. This will enable schools to make the necessary plans on whether to hold additional matches involving girl participants during hosted duals/tournaments. Mullally will send an inquiry to ADs/Wrestling coaches this fall to determine the level of interest in girls participating in the sport this upcoming season.

**SID/Executive Secretary Report**

M. Mullally said the 2018-19 WDA on-line yearbook is now posted on the website. This is our fourth yearbook released.

Mullally also emailed the latest on-line 2019-20 AD/Coach activity handbook for quick reference. It includes some additions from last year. WDA lifetime passes are in the process of being made and will be mailed to those who made requests for them.

This year, the website will feature JV standings on the volleyball page. Mullally will contact coaches to make arrangements to get the results.

**Athletic Review**

P. Jundt reviewed current NDHSAA athletic review items that were brought up for vote in June.

Of the noteworthy items that did not follow the recommendation of this committee:

- Separating the girls' hockey state tournament from the boys event.

Voted down by the board, 9-1

- The board approved bringing back the parade of athletes for the state track meet.

**The Fall NDIAAA Workshop**

Directors are reminded the NDIAAA Fall Workshop is approaching. It will again be held in Mandan in mid-September.

President Schumacher adjourned the meeting.

A tour of the new St. Mary's school was then held to those interested.

Zittleman called for additions to the agenda.

Minutes of the Feb. 27, 2019 meeting were reviewed. Moved by J. Roaldson, seconded by M. Lunde to approve the minutes as read. All voted yes, **Motion carried.**

## Treasurer's Report

M. Mullally, executive secretary, presented current finances. Beginning Balance: \$5,611.19. Ending Balance: \$11,145.54. Noted revenue was \$19,450.49 for the W. Region Basketball Tournament; \$2,224.87 from the WDA Girls' Soccer Tournament. Noted expenditures was \$5,000 for SID/Executive Sec. contract fee and \$1,000 for the WDA Senior Scholar Recipients. Moved by S. Nustad seconded by B. Schumacher to approve the current financial report. Additionally, Mullally presented the proposed 2019-20 budget. Projected beginning revenue of \$11,220.01. Total projected revenue of \$42,820.01. Projected ending expenditures of \$36,890. Moved by M. Lunde seconded by M. Wiest to approve a first reading on the proposed budget. All vote yes, **Motion carried.**

## Old Business

### 2018-19 Spring schedules Concerns/Issues/Review

#### Baseball

Coaches expressed a desire to play non-conference games early in the season as well as in the final week of the regular season. This would leave the middle portion for conference play. A start date for WDA games would be around April 14. The concerns for this request is it doesn't give many options for makeup dates and there are other school activities that could conflict with the schedules.

With the increase of field turf fields, coaches/ADs want to "phase out" the use of metal cleats. The can cause damage to turf fields. ADs believe it appropriate to establish a grace period before a hard date on when players will no longer be allowed to use them. This would also be followed for softball. This issue would be brought forward to NDHSAA, EDC colleagues. Also, given the large group of coaches, it was advised that only one spokesperson per team be permitted to speak/discuss issues in future coaches meetings. Assistant coaches/others would continued to be allowed to sit in on the annual coaches meeting, but not participate in the discussion. An assistant coach is permitted to take the place of a head coach at the meeting, if necessary.

The plan moving forward is to again plan for JV tournaments at the end of the season, but leave the option to schedule additional two games, if threat of inclement weather is likely going to disrupt/cancel the tournament.

#### Softball

Despite the need to move the W. Region/WDA Tournament to Minot due to uplayable field conditions in Dickinson, the event went well. Having two turf fields permitted the consolation and semifinal games to be played at the same. Coaches said plans for next year is to attempt to schedule a regular season tournament (Fargo), if possible, to create more non-conference play. Also, make efforts for some local umpires to also be part of crews working postseason tournaments.

#### Tennis

Coaches expressed a desire to continue to hold the tournament in

Minot or Bismarck. The 2020 is tentatively planned for Jamestown. Some coaches were concerned about the condition of some outdoor courts there. J. Roaldson said this concern has never been brought to his attention, and believes the primary outdoor courts used in Jamestown are fine. Perhaps the secondary outdoor courts may need to be examined closer. However, the new indoor facility in Jamestown has four courts. Couple that with the primary outdoor venue (Bollinger Courts) and there is adequate facilities to host the region event.

#### Track-Field

Athletic.net, the program used by track/cross country coaches to report athletes' meet results, has caused some issues, at times, in getting accurate information linked to the site. Coaches need to better monitor the site to make sure accurate listings are posted and names not left off. Coaches expressed a desire to return the Parade of Athletes event prior to start the state track meet. This event has been difficult to organize given the large number of athletes and creates added work to tournament staff right before the meet is to begin.

#### Girls' Soccer

Coaches again requested an additional week to spread out matches and provide more time to prepare for the postseason. With the addition of teams to the conference in the future, expanding the WDA Tournament into three days may become necessary. When the time comes to do that, the current format for seeding and advancement to the state tournament may need to be revised. Currently, the top two regular season placewinners automatically qualify for the state tournament. And the other state tournament seeds are determined by a state qualifier. To align with other WDA/region tournaments, all teams would have to play their way into the state tournament, starting with quarterfinal matches/loserout/semifinals/state qualifiers and championship. Seven schools will again field a varsity program next spring with plans to increase that number in the future with the addition of Williston, Dickinson and TMCHS.

## New Business

### Live Streaming Events

Some schools continue to have issues with patrons/individuals live-streaming events. These individuals often don't notify schools ahead of time of their plans to live-stream. And often, they make requests for a designated space in the stands/arena or need additional equipment or access to electricity. This can cause additional work for ADs/event hosts, as well as some costs. Each school will adopt its own "in-house" policies relating to live-streaming its events. And set up fees, if it wants. Despite this being a public event, schools have the right to limit and determine who will be permitted to live-stream/broadcast its activities. P. Jundt said releasing it on a tape delay basis is always an option for those who are interested in videstreaming.

For live-streaming WDA postseason events, a daily fee schedule will be adopted and in line with the NDHSAA rate/regulations. Moved by D. Mieure and seconde by M. Wiest to establish a fee schedule for live-streaming postseason WDA postseason events. All yes, **Motion carried.**

### By-Laws/Constitution Revisions

M. Mullally requested that ADs take time over the next couple of months to review the WDA's existing by-laws and rules (posted on the conference website). Any potential changes/adjustments will then be formally acted on at a future meeting.

### Three-person officiating basketball crews for JV

Each school will have to determine if this is something it wants to adopt or put into practice. Several issues discussed include whether it is necessary for that level. Whether there are enough officials. Whether it's something that can be done consistently with both boys and girls games. And what the additional costs.

### **One-day region/state orchestra event**

ADs are advised to discuss with their band/music instructors to determine if holding a one-day region music event will provide a better experience and format for students. A survey was sent out this spring to outline a change as a result of needing a suitable host venue to allow the event to be held for one day.

### **Finalize 2019-20 Fall and Winter Sports Schedules**

Boys' Tennis: The annual JV tournament will be moved to the Saturday proceeding the week of the West Region Tournament.

Boys' Hockey: Hazen-Beulah will return to varsity play in 2019-20. Teams will have the option to play them twice (3 point games) or once (6 point game). Also, playing their JV team vs. H-B for region points.

Boys-Girls' Basketball: The dates for the sub-varsity tournaments schedule have not yet been set. Looking at potentially moving the freshman tournaments up a week. However, how this would impact remaining games scheduled regular games has not yet been resolved. Issue to be revisited in August.

### **Athletic.net**

An Athletic.net subscription fee is necessary in order to see all times/distances recorded for track. Without it, only a limited number of results throughout the spring are available for the general public. Patrons/Coaches can sign up with Athletic.net to view the postings, but it only lists the top 25. A subscription fee is needed to sell all the listings. Is there something could be done to provide a place on our website each week to post a thorough listing of the times/distances for each event for girls and boys. One possible solution is for the M. Mullally to have a subscription and then list those results by pdf link to the track pages.

### **SID/Executive Secretary 2019-20 Contract**

After discussion, the board approved the 2019-20 SID/Executive Secretary contract for Matt Mullally. The 12-month contract, beginning in August, 2019 is \$34,000 and includes a \$500 stipend toward a new computer. New contract will be prepared. Moved by B. Lervick seconded by D. Mieure. All voted yes, **Motion carried**

### **2019-20 WDA Membership Reminder**

M. Mullally reminded the ADs that the annual WDA membership fee should be made payable by Sept. 1, 2019. The cost \$1,000 for full members and \$50 for associate members. As part of the meeting packet, an invoice is available for each school as a pdf.

### **2019-20 WDA AD Meeting Schedule**

Dates/times were set for the upcoming 2019-20 AD meeting schedule.

### **Finalize 2019-20 West Region/WDA Postseason Schedule**

ADs reviewed and formally adopted the 2019-20 WDA/West Region postseason championship/tournament schedule. In addition, sites were selected for future region/conference events in activities. The updated listing of future sites can be viewed on the conference website.

### **Administrative Passes for 2019-20**

WDA members will be responsible for printing and laminating its conference administrative passes for 2019-20. In previous years, the passes were made by Image Printing, Bismarck. The decision to make the passes "in-house" will save approximately \$500. Mullally has created the pass design. Each schools will send him their list of administrators/spouses to receive passes. Mullally will create the passes and then email/and or mail a pdf file of the passes to each school. Schools will then print them out and laminate them.

### **Lifetime WDA Passes**

WDA members who would wish to provide a WDA Lifetime Pass to someone deserving from their city/area, can contact M. Mullally by July 1. Passes are customarily handed out to former coaches, ADs, school officials or other workers/volunteers who have made significant contributions to high school activities in their area/state.

### **SID/Executive Secretary Report**

Mullally said our fourth on-line yearbook will be released by mid-June. The yearbook provides a thorough year-in-review for all 22 sports as well

as several Fine Arts activities/team scholar recipients as well as other information about the conference. The previous three yearbooks are also available to view on the WDA website.

Mullally, also sent out a draft of the 2019-20 AD/Coaches handbook. Several changes/revisions were made. Mullally would like to update the coaches contact sheet as part of the handbook. Several new coaches have been hired and more will be hired over the summer. ADs should send Mullally a contact information sheet of its coaches for 2019-20. They will be added to the handbook for quick reference. Also, Mullally will provide the ADs sport-specific information from the handbook prior to the start of the season. This can then be reviewed at AD/coaches meetings prior to the start of the season for reference.

### **Girls Wrestling**

With the continued increase in girls participating in the sport, more opportunities for the athletes to compete is needed. Teams/programs that have these athletes are encouraged to look at scheduling matches, when available.

### **Trapshooting, archery, figure skating**

G. Fridley asked how other members are handling letters/student recognition for non-traditional sports, including trapshooting, archery. Some award letters if they provide some form of funding. Other schools allow the activity to use the school name but do not award/recognize letter-winners.

### **E-sports gaming**

M. Wiest said Mandan has approved funding to purchase gaming devices/hardware for future e-sports gaming opportunities for students.

### **Athletic Review**

Recommended changing the Region Track Meet from a set date to a deadline. This will create greater flexibility in avoiding inclement weather.

Recommend using the next region placer in each respective weight class to fill a open spot at the state wrestling tournament. This will serve as the region's "silent nine" in the event a seeded wrestler is unable to compete.

Recommend not adding an additional game for for the 2019-20 boys and girls' hockey seasons.

Recommend moving the entire girls' hockey season one week later, beginning with the 2020-21 season. Season would begin and end one week later than the boy's season.

Allow a six-dive score of 170 or higher to be a state-qualifying standard as long as the diver has completed an 11-dive list at some point during the swimming-diving season.

Recommend not adding an additional game for for the 2019-20 boys and girls' basketball seasons.

President Zittleman adjourned the meeting.

The next WDA meeting will be Thursday, Aug. 8 in Bismarck, beginning at 1 p.m. Location to be determined. Bruce Schumacher will begin his term as president.

## Treasurer's Report

M. Mullally, executive secretary, presented current finances.

Beginning Balance: \$7,611.19. Ending Balance: \$6,511.19

Noted revenue was \$500.00 from Farmers Union Insurance as a match for the WDA Senior Scholarship program. Noted expenditures included SID/Executive Secretary payments for January, totaling, \$2,500.

D. Zittleman discussed a request from outside enterprises/people to live stream some of the region basketball games. It's allowed under NDHSAA rules/guidelines. However, the fact that games are being allowed to be viewed via Internet web stream opens the possibility of losing admissions/gate revenue. In light of this, it should be the right of the conference to receive one-half of the revenue NDHSAA takes in for the allowing the video live streams. Currently, the WDA receives one-half of revenues from the tournament under the agreement with the NDHSAA. The board believed getting a portion of the live stream revenue fee is a reasonable request. The issue will be brought up at the next NDHSAA Tournament Committee meeting. Moved by Martin seconded by M. Wiest to approve the current financial report as presented. All voted yes, **Motion carried.**

## Old Business

### 2018-19 Spring schedules Concerns/Issues/Review

The board will monitor closely the weather in the coming weeks before determining whether changes/adjustments to the spring activity calendar will be necessary.

### Baseball

J. Green said Watford City will be fielding only a varsity team this spring. **Track**

The indoor season will begin in mid-March. The WDA will again split its two conference indoor meets on March 29. Bismarck will be one of the sites with Williston the other.

### Girls' Soccer

S. Martin said TMCHS will again be playing a JV schedule.

### Sub-varsity tournaments

Weather permitting, JV baseball tournaments will be scheduled in late May. Sites and brackets will be determined based on the number of participating teams. Minot and Bismarck will be potential hosts.

Weather permitting, JV softball tournaments will be scheduled in late May. Sites and brackets will be determined based on the number of participating teams. Minot and Dickinson will be potential hosts.

Weather permitting, Bismarck will host the JV girls' tennis tournament on Monday, May 21.

## WDA Senior Scholarship/NDIAAA scholarship program

P. Jundt said four boys and girls applications were received for the annual WDA Senior Scholarship program as sponsored through NDIAAA. A committee of ADs, who do not have an applicant from their school, will review the applications and select one boy and girl recipient. The winners will receive a \$500 scholarship and be eligible for the state scholarship award. As customary, the students will be recognized on the final day of the West Region Basketball Tournament. P. Jundt said some prob-

lems exist with the on-line application form by NDIAAA. In the future, a change should be made to the application to make it more user friendly.

## Adjustments to the West Region Tournament bracket schedule

Resumed discussion on whether hosts of region baseball, softball and volleyball tournaments should have the discretion to adjust (i.e. flip) the tournament bracket to enable the host team to play its quarterfinal game/match in the evening. As discussed earlier, this could allow more local fans to attend that first game, boosting gate revenue. Some support adjusting the bracket because it gives schools/towns that host region events sporadically the assurance the host school will have a more favorable opening game time. Some believe the region tournament bracket schedule should be consistent from year-to-year and activity-to-activity. It's not an in-season tournament, but a region tournament that should take into consideration all the teams participating. Moved by J. Roaldson seconded by S. Martin to allow the host the discretion to change (i.e. flip) the bracket pairings to allow the host school to be in the evening time slots for baseball, softball and volleyball regional quarterfinals. **Yes:** G. Fridley, M. Wiest, D. Mieure, J. Green, B. Schumacher, S. Martin, J. Roaldson, S. Nustad. **No:** B. Lervick, P. Jundt, D. Zittleman. **Motion carried, 8-3.**

## JV baseball and softball game limits

Resumed discussion on setting consistent inning limits on JV baseball and softball games.

Proposal was that JV1 and JV2 baseball games should be five innings in length with no time limit. No extra innings will be permitted. Proposal for JV1 softball will be five innings and no time limit. For JV2 softball, five innings and a 90-minute time limit. A six-run per-inning rule will be applied for both JV1 and JV2. No extra innings will be permitted. It was moved by M. Lunde seconded by M. Wiest to approve the proposals. All voted yes, **Motion carried.**

## New Business

### Winter Season

**Wrestling:** The region tournament in Belcourt went well. First year the event was held there. Coaches were satisfied with the venue and how it was conducted. No major issues discussed among coaches regarding the season/tournament.

**Boys' Hockey:** The region tournament in Minot went well with no major issues among coaches discussed regarding season/tournament. Region tournament now adopts the four official system, M. Lunde said.

**Girls' Hockey:** Coaches meeting conducted during the state hockey tournament. Discussion about moving the girls tournament to a different location/city and/or different weekend was discussed. A majority of coaches would prefer this option.

**Gymnastics:** The conference tournament held in Minot. One issue is to adjust how the vault judging point system is administered. Should develop more of a point spread to those who perform more difficult vault attempts.

**Boys-Girls Basketball:** The region tournament will be held in Bismarck. Coaches meeting was conducted in Mandan. Boys coaches want to establish, through NDHSAA, a joint officials-coaches gathering prior to season to go over points of emphasis regarding officiating standards. These meetings could be held in a number of sites...Discussion about changing the conference schedule to establish set days for conference games to create more equity...Some coaches wanted to make sure Saturday games are played as early as they can to allow teams to return home at a reasonable hour...A point for future consideration is whether coaches should not permit co-senior region athletes of the year as it may cause for split votes at the state level for senior athlete of the year honors. This year there were co-boys senior athletes, but not on the girls side.

Zittleman called for additions to the agenda.

Minutes of the Nov. 20, 2018 meeting were reviewed. Moved by Nustad, seconded by Martin to approve the minutes as read. All voted yes, **Motion carried.**

## Treasurer's Report

M. Mullally, executive secretary, presented current finances. Beginning Balance: \$8,367.32. Ending Balance: \$7,611.19. Noted revenue was \$3,880.40 from the WDA Cross Country Meet; \$472.10 from the WDA Girls' Swim-Dive Meet. Noted expenditures included SID/Executive Secretary payments for November and December, totaling, \$5,000.

Moved by Martin seconded by Fridley to approve the current financial report as presented. All voted yes, **Motion carried.**

## Old Business

### 2018-19 Schedule Concerns/Issues/Review

#### Winter

Six region play-in games (3 boys games/3 girls games) will be held between Feb. 21-23. There is the potential the games could require some facility changes/adjustments to sub-varsity tournaments that are customarily held in Bismarck-Mandan during the weekend of the play-in games. If Bismarck teams are in play-in games, that could mean sub-varsity tournaments have to be moved to another site or times adjusted. As the regular season winds down, and the play-in game matchup scenarios become clear, activities directors will collaborate on the sub-varsity tournament schedule and venue options.

Coaches worked on the 2019-20 wrestling season at the annual Bismarck Rotary Tournament. Tentative plans have Dickinson hosting a tournament in mid-January, 2020. Minot would then host an early bird tournament in late November. Jundt asked how the reception has been in scheduling triangulars to generate more crowds, atmosphere and competition. Some teams are currently scheduling them and the feedback has been mostly positive. The challenge is trying to balance schedules so teams are not "home heavy" one year and not the next.

Martin said Turtle Mountain Community College will be the site of the 2019 West Region Tournament. Martin said the facility is more than capable to hosting the event and will provide plenty of amenities for athletes, fans and tournament officials.

#### Postseason Tournaments

Concern was expressed how TV coverage of the postseason events could adversely affect gate admission/tournament revenue for some state/region events. M. Lunde said admission/revenue was noticeably down at the recent Class A-B Volleyball Tournament in Minot. BEK Sports provided coverage of all the matches. While the coverage has its benefits, and generates revenue for the NDHSAA, it does affect attendance/gate numbers.

A concern moving forward is, if the NDHSAA grants permission to broadcast the West Region Basketball Tournaments, how that potentially affect the admission/tournament revenue? Revenue the conference counts on to cover a good portion of yearly expenditures. The WDA presently receives half of the proceeds from the combined boys-girls tournament. TV broadcasting of some, or all of the games likely would affect admission numbers, and subsequently, tournament proceeds. The NDHSAA would receive the broadcast revenue, but would some of that be shared by the conference/region schools? Zittleman has shared

these concerns with NDHSAA officials.

## Adjustments to the West Region Tournament bracket schedule

Tabled the issue so activities directors can discuss the matter with coaches. It will be revisited at the Feb. 27 meeting.

The pros and cons of allowing the region tournament bracket to be adjusted (i.e. flipped) for sports like baseball, softball and volleyball were considered. This point is whether the tourney host should have the option to play in the evening session on the first day. This could allow more fans to attend that first game, boosting gate revenue. It currently is in use for baseball and softball but could it be opened to other region tournaments. Some support adjusting the bracket because it gives schools/towns that host region events sporadically the option to place the host school in the evening session. Some believe the region tournament bracket schedule should be consistent from year to year. It's not an in-season tournament, but a region tournament that should take into consideration all the teams participating. Switching the bracket to allow the host to move its game to the evening will effect three other teams that have been moved from the afternoon to the evening session. It may also create confusion to the public who are used to the current region bracket order of games on the first day (1-8, 4-5, 2-7, 3-6).

## New Business

### Spring Schedules

#### JV baseball and softball

Discussion began about a reasonable amount of sub-varsity games and plans for postseason play. G. Fridley said he sets up between 20-22 softball dates for the JV. That arrangement works in scheduling during the short window of dates in the spring. Tentatively, the plan is to again hold JV baseball and softball tournaments in May. M. Lunde said Minot would be willing to host either sport. Bismarck would again also be a host. Dickinson could host one of the softball tournaments. The size of the tournament and its format will be determined on the number of teams each program is expecting to field this spring.

Tabled discussion on establishing guidelines on innings/time limits for JV baseball-softball games until ADs can discuss with coaches. D. Zittleman said it would be good to provide direction to umpires/teams. This would head off any confusion or questions as to length of the games.

### Track scheduling

M. Lunde is hopeful more emphasis can be placed on establishing a consistent JH/JV track meet schedule in the future. This will insure these athletes are getting more opportunities to compete.

### Soccer

Pending school board approval next month, Fridley said Dickinson will begin sponsoring boys and girls soccer programs, beginning in the fall of 2019. JV schedule would be planned for the boys in the fall of 2019 and JV for girls in the spring of 2020. No timeline set on moving into varsity scheduling.

### WDA Swimming-Diving Championship future site schedule

Adjustments were made to the site rotation for boys and girls swimming-diving championships. Bismarck, Williston and Jamestown are the three sites that currently host the events. At the June annual meeting, the new rotation schedule will formally be approved.

### Future Scheduling/Greater emphasis on conference-wide equity

Mieure would like to see more emphasis placed on what's best for the conference over what's best for schools/programs when it comes to scheduling and the availability of playing conference opponents in sub-varsity sports or non-counters vs. conference teams.



Some schools have greater flexibility in their scheduling options while others do not. This is creating issues that are hard to overcome for some schools.

Mieure said he respects everyone's hard work in putting schedules together. He knows it's not easy to do and there is a lot to account for, but is there a way to do it that provides greater equity?

One area of concern explained was some schools, Williston, Watford City and TMCHS, often having to play a majority of their basketball games on weekends, due to travel time. Often playing back-to-back dates.

These weekend schedule arrangements were requested years ago by some ADs to reduce the number of trips taken. Limit the amount of missed class time and avoid late night returns on school nights. However, there is a competitive advantage issue when one team did not have to play the night before, according to Green. Are there options to resolve this situation in the future? Green realizes Watford City's location is going to mean added travel time. That can't be helped, but are there solutions/options to insure more equity?

A few years ago P. Jundt drafted a basketball schedule proposal that essentially set up Friday-Saturday dates. At the time, it did not draw much support for a number reasons/concerns. Among them was finding enough officials to work those games, especially when some also work collegiate games that often take place on weekends. Facility availability was another issue. And some schools wanted to take advantage of playing games on other nights. Roaldson believes there are advantages to having to play on back-to-back dates. It prepares teams for postseason play, for one.

Geography is something that can't be overcome in the conference. Some are going to have competitive advantages simply because of their location.

A question raised was whether this is a basketball issue or concerns about how scheduling, in general, is set up for other activities?

D. Mieure thinks it's something that should be looked into in other sports. However, the current volleyball schedule plan put in place has been good. It takes into consideration the additional travel incurred by some conference members by making the Bismarck-Mandan schools be on the road for 2-point matches.

Nustad said BHS is willing to play teams on weeknights, if that is going to help create more scheduling flexibility for some schools. He pointed out that BHS' boys hockey team came to Williston on a Tuesday to play. Establishing a "Tuesday-Friday" conference schedule, for instance, may sound good and equitable, but whether that can be achieved is another matter.

ADs don't want to have kids return home well after midnight on school nights, regardless of the school involved, Jundt said. There are other activities that share facilities. Lervick said each school is unique and has many activity commitments (like Fine Arts) to account for. Already it's a challenge to fit everything in.

Martin said his programs often are playing on weekends. A main reason is the TMCHS school district adopted a Monday-thru-Thursday class schedule. That has made weekend travel more appealing for activities, since it avoids missing class on Fridays. He shares sentiments about the back-to-back issues and the competitive advantage it allows for some teams that only play once on that weekend. Can we get closer to an equitable schedule. That's what he would like to see moving ahead.

### **Changes/adjustments to BHS fall volleyball scheduling**

Due to construction of a new gym at Bismarck High, venue changes will be necessary for volleyball in 2019. The secondary gym at BHS will be available to host some contests. Other matches may be scheduled at other gyms in Bismarck during this period.

### **Game times on Saturday**

Fridley asked if we can make more effort to start Saturday games earlier to allow teams to return home earlier. Some schools schedule early afternoon events while others prefer having games later on Saturday. The reasons for that include challenges in finding sufficient help to work/supervise the games, keeping home events from overlapping.

### **2020 WDA Gymnastics Meet**

After visiting with other ADs and coaches, Wiest said the Mandan gymnastic facility is just not suitable to host the conference meet. There isn't enough seating, and the current seating, doesn't provide the best sight lines. Dickinson has tentatively agreed to host the event in 2020. Formal approval will come at the annual June meeting.

### **2019-20 Hockey Schedule**

Due to the 2019-20 NDHSAA activity calendar starting a week later, the WDA hockey schedule has to be adjusted. ADs agreed to keep the already-scheduled games on the same days but adjust to the new dates.

### **NDIAA Scholarship Program/WDA Scholarship Program**

P. Jundt reviewed the procedures for the NIAAA/NDIAA Student Scholarship and application. Students must type the application to be eligible. Students are only eligible if the AD is a member of NIAAA/NDIAA. The applicants are selected by each school and forwarded on to the WDA/W. Region ADs for review and selection. The deadline line for completed applications is Feb. 28. As customary, ADs which do not have an applicant, will serve as the selection committee. One boy and one girl will be awarded a \$500 scholarship. The WDA premiere partner, Farmers Union Insurance, will provide matching dollars. The WDA/region scholarship recipients will be recognized at the West Region Basketball Tournament.

### **ADOTY**

Mullally informed ADs they can begin to send him via email their nominee for 2018-19 West Region Athletic Director of the Year. Nominees will be announced at the next meeting (Feb. 27) where a formal vote will be conducted. The recipient will be announced during the West Region Basketball Tournament.

### **SID/Executive Secretary Report**

Mullally provided some statistics on current website traffic to the conference website. Google analytics provides the break down. Traffic has seen an exceptional increase in the past calendar year. In addition to the website, the conference Twitter account presently has 4,600 followers. Mullally explained the Hudl statistics software the schools use in basketball has been good, for the most part. There have been some delays in getting access to the Hudl stats. There has also been a few occasions when the stats had to be adjusted to take into account stats missed when video was cut off, or some jersey numbers could not be clearly seen to properly record stats. Mullally provides weekly conference and team statistics on the website for boys and girls basketball using the Hudl program.

### **Athletic Review**

P. Jundt addressed topics expected to come up at the next Class A Review.

-Change first girls' golf practice date to Aug. 5 and move up state meet from Oct. 7-8 to Sept. 30-Oct. 1. ADs support the recommendation.

-For team matches at the region and state tennis duals, once match has been decided, the remaining individual match/matches that have not started a third set will play a super tie-break for the full third set. ADs support the recommendation.

-A rostered member of the volleyball team shall attend the coaches/captain meeting. ADs support the recommendation.

### **Tournament Committee**

D. Zittleman said the committee made recommendations for site locations for the 2025-26 year.

WDA ADs recommend the NDHSAA draft media etiquette guidelines for NDHSAA-sponsored events.

ADs took no position on whether tournament team hosts should be formally recognized during introductions at state events/tournaments.

President Zittleman adjourned the meeting.

The next WDA meeting will be Wednesday, Feb. 27, at 2 p.m. CT in Bismarck

Minutes of the Aug. 6, 2018 meeting were reviewed. Moved by S. Martin seconded by S. Nustad to approve the minutes as read. All voted yes, **Motion carried.**

## Treasurer's Report

M. Mullally, executive secretary, presented current finances.

Beginning Balance: \$11,016.32 Ending Balance: \$8,367.32

Noted revenue was \$1,279.28 from the WDA Boys' Soccer Tournament; \$4,100 in 2018-19 WDA memberships. Noted expenditures included SID/Executive Secretary payments for August, September and Oct totaling \$7,500; and reimbursement of \$543.28 to M. Mullally for payment to Go Daddy Inc., for a two-year contract for Website Domain Host Services.

D. Zittleman turned in a check for \$3,880.40 and the financial statement for revenue following expenditures for the 2018 WDA Cross Country Championships.

Discussion ensued clarifying what the tournament manager fee should be when hosting WDA/W Region postseason tournaments/events. It was determined a \$150 (1 DAY)-\$250 (2 DAY)-\$350 (3 DAY) formula should continue to be followed. The exception is a \$100 fee for those that host a play-in game/match. If changes/or circumstances require an adjustment to that formula, it will be reviewed at a future meeting.

Moved by G. Fridley seconded by M. Wiest to approve the current financial report as presented. All voted yes, **Motion carried.**

## Old Business

### 2018-19 Schedule Concerns/Issues/Review

#### Winter

Activities Directors (ADs) reviewed the number of sub-varsity teams their respective schools would field for the upcoming boys and girls basketball and hockey programs.

S. Martin said the current plan is for the 2018-19 region wrestling tournament will be held at the new Belcourt Fine Arts Center which is presently being constructed. In the event that facility will not be ready in time for the Feb. 9 tournament, the event will be held at the Turtle Mountain Community College in Belcourt. Martin said that facility is more than capable of hosting.

#### Spring

M. Wiest said its likely Mandan will not be playing baseball games this season at Veterans Memorial Ballpark. The facility is undergoing major renovations. Games may be played at an adjacent baseball field at the complex, or renting/using facilities in Bismarck.

The region boys' golf tournament will be held in Dunseith and hosted by Belcourt. Adjustments were made/creation of new tees to ensure the course will meet the distance requirements as set by NDHSAA.

The region girls' tennis tournament will again be hosted by Minot. This WDA girls' soccer tournament will be hosted by Mandan (Tuesday and Thursday event).

## RSchool Scheduling

Discussion held about how multi-entry tournament/meet events are entered into the RSchool on-line conference schedule. G. Fridley said this has created some confusion and redundancy in the conference RSchool listing. Is there a way to alleviate this issue? A remedy would be to

list/designate these events as non-conference. This appears to only be an issues for such events as track/cross country/swimming and gymnastics. M. Lunde said we should do a better job of keeping an eye on this and make sure we are not adding more entries when it's unnecessary. A continued concern is when scheduling is left to others to post on the conference site. This may result in games/events inadvertently being changed or omitted without the knowledge of those affected teams. ADs are reminded that Dec. 1, 2018 is the deadline to post spring schedules on the RSchool site.

## W. Region NDHSAA Director Position

The open NDHSAA W Region director position will be voted on in December. P. Jundt has agreed to represent the region in this capacity. D. Zittleman encouraged ADs to recommend/vote for Jundt for this position.

## Soccer expansion

Beginning in the fall of 2018, Williston will be fielding a varsity and JV boys' soccer team for competition. This will bump the number of participating varsity teams in conference play back to seven. Dickinson is on pace to begin a boys and girls program, beginning the following year. It will likely begin with a JV boys' schedule in 2019 with potentially a JV girls' schedule in the spring (2020). Watford City may also be sponsoring soccer in the not-so-distant future. TMCHS Belcourt sponsors girls soccer and will again play a JV schedule in the spring of 2019.

## New Business

### Fall Sports Reports

#### Volleyball

The issue of scheduling for 2019 was held. M. Lunde said there is three options for matches given the 11-team conference. 1. Play a double round robin schedule. 2. Play a single round robin schedule; 3. Continue to have an unbalanced schedule with some matches counting for 2 points. At the coaches meeting, the group was in favor of continuing the 18-2 format (18 matches and 2 in-season tournaments). Coaches preferred adjustments to the tie-break criteria to address the unbalanced schedule and not have some matches count for 2 points. A couple of tie-break options addressing an unbalanced conference schedule were presented and reviewed. At the coaches meeting, B. Lervick presented the order of finish in the standings using the current structure (1 pt and 2 pt matches) and if matches counted for 1 point. It revealed little change this year in order of finish and seeding for the region tournament. However, the 1 and 2 pt match set up does have the potential to impact the standings, as illustrated in the EDC this year. A team could drop 1 or more spots with a 2 pt. loss. As a way to provide concessions to teams that have more travel, the majority of the 2 point matches were hosted by those teams with more travel. J. Roaldson said some teams, including his program, would prefer to play teams twice (1 point each) that are traditionally at, or near the top of the standings. Unfortunately, that preference is not possible for all teams. P. Jundt added teams need to worry less about whether matches are worth 1 and 2 points, and just go and play the matches. Teams should not prepare any differently when facing an opponent regardless of the 1 or 2 pt match.

It was moved by M. Lunde seconded by S. Martin to have all single matches worth 2 points in the WDA standings and all Home/Away (double round robin) matches to be worth 1 point in the WDA standings; and follow the current five-year schedule plan which was adopted in the fall of 2017; Furthermore, the current tie-break procedure will remain. **Yes:** P. Jundt, G. Fridley, M. Wiest, S. Nustad, B. Lervick, S. Martin, J. Green, D. Mieure, M. Lunde, B. Schumacher, D. Zittleman. **No:** J. Roaldson  
**Motion carried**

An issue raised was how the length of the volleyball season makes it challenging for some athletes to make the transition into winter sports. There is very little break for athletes. At a time when participation numbers are decreasing in girls sports, is this an area where changes are warranted to help with that? Any adjustments to schedules would be daunting, since it would affect schedules and postseason events of other activities.

D. Mieux said is there any possible way to adjust how the W. Region Tournament bracket is set up to allow the host site to play a later match/game (i.e. flip the bracket)? Williston hosted this year's tournament and happened to play two afternoon matches. A number of students were excused from class to attend. This issue was not well received by some teachers/staff. Could this be alleviated or changed if the home team can move its opening round match the evening? B. Schumacher and J. Roaldson indicated that would not necessarily promise better crowds/support. Some feel students are more likely to go to the afternoon match, if it means an excused absence from school. Baseball is the only W. Region event that the NDHSAA allows flipping the bracket to enable the home team to play in the evening session on day one. The driver for this was an increase in gate revenue. Since it's not an option now for other tournaments, should it then be allowed for baseball? The issue will be tabled and discussed at a later meeting.

### Golf

J. Roaldson said there was discussion about using the iWannamaker program for scoring at region/state postseason events. Coaches expressed concerns about the 2019 schedule beginning a week later. This would result in more school missed and potentially affect tournament scheduling with golf courses. This concern has been brought forward for Athletic Review. Coaches also in favor of allowing individual state qualifiers to participate independently at the regional meet.

### Tennis

Tournament was held in Minot. No issues brought forward by coaches.

### Boys' Soccer

Coaches want the East-West crossover matches to be designated as scrimmages. Currently, they are not full 40 minute halves. They play 30 minute halves. They count only in overall record (non-conference). Coaches also want to recognize a "player of the match" for both teams after each regular season match. Coaches also interested in using Hudl for their programs.

### Cross Country

Advisory asked that the conference meets should not be in the same location of the state meet. Reasons for this was, in case of bad weather, the race course doesn't get torn up. Also, hosting at the same location (often on a golf course) is tough/damaging to the rest of the course. And this means additional meet management duties in a short time frame.

### West Region Tournament Admission Fees

Discussion about uniformed pricing for region postseason tournament fees. The NDHSAA-set price scale for daily admission is \$8 for adults; \$5 for students. Some postseason events also offer three-day passes while some are not clear about allowing them. ADs will discuss this issue of passes at an upcoming NDHSAA Tournament committee meeting. Once this discrepancy is cleared up, it will be revisited at a future meeting to set prices.

### West Region Baseball Play-in Games

This 2019 West Region baseball postseason will feature two region play-in games. It was moved by G. Fridley seconded by S. Nustad to set the region play-in game schedule to the Monday prior to the start of the West Region Tournament. In the event of inclement weather, the play-in games would move to Tuesday or Wednesday. This year's tournament is in Bismarck. Postseason pitch counts apply to the play-in games. All voted yes, **Motion carried.**

### West Region Tennis Tournament Host Site

With the recent opening of Jamestown's indoor recreation facility which includes four indoor tennis courts, J. Roaldson said the school/community wants to be part of the rotation to host boys and girls tennis regional events. At the June annual meeting, Jamestown will be formally added to the future rotation of region tennis tournament sites.

### West Region Wrestling Tournament Host Site for 2019-20

The 2019-20 West Region Wrestling Tournament was tentatively scheduled for Minot, but a scheduling conflict at the MSU Dome prevents Minot from hosting. The directors tentatively approved Watford City hosting this event for 2019-20. At the June annual meeting, Watford City will be formally added to the future rotation of region wrestling tournament sites.

### All-state player recognition

M. Wiest asked if there is a procedure plan to release all-state teams following the season/postseason tournaments. And which organization/association is tasked with releasing it to the media? There was a delay this fall in releasing the all-state soccer teams. The NDHSCA handles all-state and postseason awards, and should take the lead to release this information. ADs will visit with NDHSCA officials in the future to affirm this should be the plan moving forward.

### All-State Tournament Volleyball Team Selection Process

The all-tournament team for the Class A volleyball tournament was selected by four coaches (two from West Region; two from East Region) as established by coaches in the two regions. Question was raised as to why there needs to be designated coaches to complete this duty. Currently, the four coaches of the teams that lose state qualifier matches at their respective region tournaments, serve as the panel to select the all-tournament team. As a result of this arrangement, some schools/programs incur lodging/meal expenses. B. Schumacher said perhaps costs could come from the tournament budget. Another possibility is for workers/volunteers or other coaches that are attending to conduct the selection in the future. Other state tournaments have media or tournament officials oversee the selection.

### Coaching Evaluations

G. Fridley asked for some feedback regarding end-of-season evaluations by student-athletes. Several schools use a variety of on-line or computer-based survey programs. Fridley is in the process of making changes to Dickinson's evaluation process.

### SID/Executive Secretary Report

M. Mullally said some additions, corrections were made to the WDA AD/Coaches on-line guide. Mullally asked ADS to review this again forward any changes or updated coaching contact information. Mullally made the arrangements with Watford City coaches to receive access to their current Hudl basketball accounts. This was necessary as we prepare for the season and weekly stats to be posted on the web-site.

### Athletic Review

P. Jundt said one item that will be discussed is changing the tie-break procedure at state tennis. Allow a super tie-break after two sets when the outcome of the 3-2 dual match has been decided. This change would allow for the match to end sooner.

### Tournament Committee

At its next meeting, committee will look at potential state sites for 2025-26 and consider need updates to its state tournament policy manuals. Another issue to address is change of site for the 2019-20 boys' state golf meet from Hawktree in Bismarck to another course.

President Zittleman adjourned the meeting.

The next WDA meeting will be Wednesday, January 9th at 10 a.m. CT in Minot. (Note: That is a week earlier than initially planned to due a scheduling conflict with a NDIAAA meeting)

President Zittleman called the meeting to order

Zittleman called for additions to the agenda.

Minutes of the June 4, 2018 meeting were reviewed. Moved by M. Lunde seconded by S. Nustad to approve the minutes as read. All voted yes, **Motion carried.**

## Treasurer's Report

M. Mullally, executive secretary, presented current finances. Beginning Balance: \$6,307.53 Ending Balance: \$8,016.32 Noted revenue was \$2,568.18 from the WDA Girls' Soccer Tournament; \$945.65 from the West Region Softball Tournament; \$4,000 in 2018-19 WDA memberships. Noted expenditures included the final two SID/Executive Secretary payments for the 2017-18 year, totaling \$5,000 as well as administrative service expenses such as WDA passes \$304.61 and championship signs \$236.43. Moved by B. Lervick seconded by B. Schumacher to approve the current financial report as presented. All voted yes, **Motion carried.**

A second reading was held on the proposed 2018-19 WDA operating budget. Projected revenue totals \$34,221.36. A majority of this comes from WDA membership fees as well as tournament revenue. The general agreement is revenue after expenditures of postseason tournaments would be returned to the conference. The estimated revenue from tournaments is conservatively estimated at \$18,000. It was moved by J. Roaldson seconded by M. Wiest to direct revenues after expenditures from WDA/Region postseason tournaments to the conference general fund. All voted yes, **Motion carried.**

Projected expenditures total \$37,532.76. Mullally pointed out that the budget includes \$5,000 in built-in contingency funds to cover unforeseen expenses associated with fall, winter and spring activities. Only on rare occasions, have these funds been tapped into.

Moved by M. Lunde seconded by S. Martin to approve 2018-19 budget as presented. All voted yes; **Motion carried.**

In the interest to save future expenses, it was proposed by P. Jundt to have each school responsible for making administrative passes, beginning with the 2019-20 school year. In previous years, WDA passes were made by an outside printing company (Image Printing, Bismarck) at a cost of about \$1.50 per laminated pass. M. Mullally would provide a pass template which would be forwarded to each school. The schools would then add names/titles and laminate them. Moved by P. Jundt seconded by M. Wiest. All voted yes; **Motion carried.**

## Old Business

### 2018-19 Schedules/Review

#### Baseball

B. Lervick is in the process of putting together the 2019 schedule which will include non-conference date options with EDC opponents. He will forward the schedule draft when it is ready.

#### RSchool Scheduling

P. Jundt point out there are times when discrepancies on the RSchool team calendars need prompt attention. In order to make those changes swiftly and avoid confusion as to who should make corrections/additions when dealing with multi-team entries, ADs authorized B. Lervick to go in and make the necessary changes on RSchool team calendars. Lervick is the conference's leader for RSchool.

ADs were reminded of upcoming deadlines to post future schedules on RSchool. Dec. 1 for spring activities. June 1 for fall/winter.

## New Business

### Boys' Soccer Postseason

The 2018 WDA Tournament will be held on Saturday, Oct. 6 in Mandan. Three matches will be played (2 state qualifiers and the championship).

### 2018-19 WDA Membership

M. Mullally reminded members to turn in their 2018-19 WDA membership fees by Sept. 1. Annual fee is \$1,000.

### 2019-20 Wrestling West Region Tournament

Minot is hosting the 2020 West Region wrestling tournament. Initially it was planned again for the Minot State Dome, but likely will need to be moved to the Minot Auditorium because the MSU Dome will be in use that date, according to M. Lunde.

### NDHSAA Director Seat Nomination

P. Jundt has agreed to represent the West Region/WDA on the NDHSAA board of directors. The next step in the process is for Jundt to be formally nominated in October.

### All-Conference, All Academic Certificates

M. Mullally sent ADs a PDF template of the All-Conference Certificates and Academic All-Conference Certificates. Schools are responsible for presenting the certificates to their respective student-athletes who earn these honors. On the WDA website, a listing of all-conference selections are posted.

### Drop Box

M. Lunde reminded ADs to use the shared Drop Box program to download rosters and other pertinent information for the 2018-19 year.

### Softball-Baseball Sub-Varsity

Tabled discussion on sub-varsity tournaments for baseball and softball until next spring when participation numbers become known.

### WDA On-Line Guide

Introductions were made to Jim Green, new Watford City activities director.

Zittleman called for additions to the agenda.

Minutes of the Feb. 28, 2018 meeting were reviewed. Moved by J. Roaldson seconded by S. Nustad to approve the minutes as read. All voted yes, **Motion carried.**

## Treasurer's Report

M. Mullally, executive secretary, presented current finances. Beginning Balance: \$2,404.90 Ending Balance: \$6,307.53. Noted revenue was \$14,436.95 from the 2018 West Region Basketball Tournament (March 1-3). That amount was significantly less than previous revenue totals from the tournament. (**2017:** \$21,159.03; **2016:** \$21,394.21; **2015:** \$18,540.60; **2014:** \$26,725.16). To offset the potential for continued revenue declines, directors generally agreed that moving revenues, after expenditures, from other regional tournaments is an option. Proceeds from the basketball regional go toward operating expenses for the conference. Directors will review past region tournament proceeds to get a better idea of what potential revenue would be generated from other regional events in 2018-19. And if possible, deposit those funds into the WDA account.

Mullally presented the proposed 2018-19 WDA operating budget. Directors will give it a final reading/passage at its August meeting. Moved by S. Martin seconded by M. Lunde to approve current financial report as presented. All voted yes; **Motion carried.**

## Old Business

### 2018 Spring Sports Review/Coaches Meetings Soccer

Discussion item for coaches was avoiding three matches in a week, if possible. Proposed plan was to have WDA matches on Tuesdays and Fridays. Extending the season a week (An earlier start date for matches) could alleviate the concerns with multiple games in a week. P. Jundt said he would draft a schedule. Also, will check with EDC schools to determine potential dates for crossover matches.

At the regional coaches meeting, a majority were not in favor of a conference tournament. Rewarding regular season play, avoiding late-season injuries were among reasons for having top four seeds qualify for the state tournament. If a conference tournament is continued, a double-elimination format would be preferred. That would align with other sports/regional tournament formats. ## Softball

Directors said the single round robin schedule, which was adopted this spring due to weather/shorter season, went smooth and assured a balanced schedule. Coaches liked it as well, and therefore, this will format will be used again. Moved by M. Lunde, seconded by P. Jundt to continue the single round robin schedule (18 games with the addition of Watford City) next year. All voted yes, **Motion carried.**

## Track

2019 schedule will be drafted this fall. Bismarck hosted the WDA Championships and Dickinson will host the event next year.

## Tennis

At the region coaches meetings, no issues were brought up by coaches. Minot hosted the West Region Tournament. Coaches like the event there as all matches can take place, weather permitting, at Hammond Park.

## Boys' Golf

Dickinson hosted the West Region and Class A Tournament. This spring, the East-West Classic was held in Fargo. No word yet on where next year's event will be held. Next year's schedule will feature similar format with the Bismarck schools partnering to host 2 tournaments, likely on consecutive days. Watford City will be participating next spring.

## Softball-Baseball Sub-Varsity

Continued challenges with end-of-season sub-varsity tournaments (Available umpires, venues, volunteers, costs and time spent in planning). Some ADs would prefer discontinuing the tournaments in favor of extra games built into the schedule. Topic will again be revisited.

Move the entire girls hockey season one week later, beginning in 2019-20. This would alleviate current challenges, including overlapping of the fall/winter seasons for some athletes. Provide a separate venue/tournament. Recommendation: Yes

*Swimming:* Change the boys' diving standard from 235 to 275 for an 11-dive meet. Recommendation: Yes

Allow transfer students to compete in regular season varsity swim meets as unattached individuals. Board members said there needs to be clearer language on this rule and its potential impact on other sports.

*Basketball:* Change the boys shot clock to 30 seconds to match the girls. Recommendation: Yes

Increase the number of allowable basketball games by two. Recommendation: No

*Tennis:* Allow each school to enter a third doubles team to participate in region and state individual tournaments. Recommendation: No

Send protests to NDHSAA office within 24 hours of competition instead of at the region meeting. Recommendation: Yes

*Girls' Soccer:* Allow players on 22-person roster to be replaced during state tournament. Recommendation: Yes

*Track-Field:* Add Olympic-style qualifying standards. Recommendation: Yes

Adjust 300 Hurdles standards to :42.44. Recommendation: Yes

Utilize athletic-net as the mandatory state qualifying reporting site. Recommendation: Yes

*Softball:* Combine the Class A and B tournaments into one site. Recommendation: No

*Review Recommendation in regard to Boys and Girls Soccer Seasons:*

Extend the girls' season by one week by adding to the beginning of the season. Set the start date for the boys' season as August 1 or 2. If Aug. 1, is on a Sunday. Recommendation: Yes

Discussed whether provisions should be put into place regarding team personnel eligible to be on the bench/sideline/dugout during games/matches. Should it only be high-school-aged and older personnel. In the interest of safety, should children be prohibited from being this close to the action?

Also discussed crowd control at the conclusion of tournament championship games and the issue of safety for athletes/officials/tournament staff as well as spectators that storm the court/playing area.

Dickinson hosted the WDA Championships. Jamestown was the site of the state event. Coaches strongly encourage two judges be used in regular season meets/competitions.

#### Boys Hockey

Minot hosted the West Region Tournament and again will host in 2019. Event went well with few issues.

Coaches resumed discussion on a potential two-tier hockey classification. The intent is to provide more competitive games within the state.

#### Girls Hockey

Discussion again on having a separate site/date for the state tournament. Possibilities could be to hold the event a week after the boys' tournament. This could also alleviate the concern with athletes coming off the volleyball season in the fall. Moving the season start date back could create a better transition from one season to the next for those athletes. Allow athletes a little time in-between seasons.

#### Basketball (Boys and Girls)

Coaches again requested the return of a morning "shoot around" prior to the start of the Class A Tournament to get acclimated to the venue. Currently, teams conduct a brief shoot around at halftime of games. Coaches want to re-seed the West Region Tournament following play-in games. Beginning next year, there will be three play-in games (6 vs. 11; 7 vs. 10; 8 vs. 9). Under the current bracket format, the No. 1 seed would play the winner of the 8-9 game. If the 11 seed would upset the No. 6 seed, they would play the No. 3. One of the advantages of being the top seed should be to get to play the lowest seed. Re-seeding would present challenges in scouting future opponents. No longer teams could watch one game. Currently, the NDHSAA does not permit re-seeding of bracketed tournaments.

Issue raised by girls' coaches is why shot clock (time) is different than the boys. Should it be the same.

In regard to sub-varsity postseason tournaments, the plan moving forward is to seed the top four teams for the freshman tournaments and then have a random draw for the remaining teams in filling out the bracket. It's not necessary to come up with specific seeds for each team. Mullally met with the coaches to discuss stat keeping using Hudl/Hudl Assist and getting more additional information on the team pages on the conference website.

#### Boys' Swim-Diving

WDA Championships were hosted by Bismarck Public Schools. D. Zittleman said Bismarck would be willing to host the event each year, provided coaches-ADs are fine with that.

## Tie-Break Criteria for regional seeding

Currently, NDHSAA has tie-break criteria in place for regional seeding purposes for some sports (including football and boys'-girls' hockey). The WDA has tie-break procedures for other sports (basketball, tennis volleyball, for example). Additionally, the EDC also has separate tie-break criteria for many of its sports.

In basketball, for example, the tie-break in terms of point differential is different between the WDA (maximum of 10 points) and EDC (a maximum of 13 points). Perhaps a consistent/uniformed tie-break criteria should be implemented, since its used to determine seeding of NDHSAA-sponsored regional events. Should the NDHSAA establish those criteria?

#### **Life-Track Surveys**

Lunde said a new coaching evaluation program to consider is LifeTrack Services, Inc. It's a fast, efficient way to process this information.

#### **Sub-varsity Soccer Tournament**

Mandan will host the event this spring. Specific dates/times will be determined at a later date. TMCHS Belcourt is beginning a girls' soccer program this spring, and will compete in sub-varsity play.

#### **Conference logo change**

With the addition of Watford City, our conference logo had to undergo a subtle change. An additional "star" was added in our three-dimensional 'A' lettering.

The first band of stars represent the conference charter members (Bismarck High, Dickinson, Mandan, Minot, Williston) with the second band representing the remaining full members. JPGs of the new WDA logo design in school colors were forwarded to the ADs for use, beginning this next school term. The logo can be used at the discretion of directors.

#### **SID/Executive Secretary Report**

—Mullally met with Kevin Ressler, state marketing/sales representative for Farmers Union Insurance. In addition to providing a match toward the annual senior scholar award, Farmers Union will fund other promotion projects next year, including outdoor banners for each school with the conference logo. Also, fund items such as travel mugs and provide shirts/pullovers for schools which will include the new logo.

—The project to include Fine Arts items to the WDA website is moving forward. Several photos (music/drama) were added to the Fine Arts page and Mullally has been in contact with many Fine Arts instructors from schools about providing additional information on this site, including event schedules and results of music contests, speech events, student congress as well as photos and video. It's a work in progress but in time could be a great addition to the site and attract more followers.

—Prior to the start of the West Region Tournament, our WDA Twitter Account reached 4,000 followers! This has become another important resource in providing information about WDA activities/events.

#### **East-West Items**

Wiest asked if we should consider setting parameters on a competitive dance season? Is the season too long and varies too much from program to program? Perhaps more consistency is necessary among participating schools.

#### **Athletic Review**

Discussion on potential changes in the girls' shot clock (time) is expected.

#### **NDHSAA Tournament Committee**

April meeting will review future state tournament locations/sites.

President Zittleman adjourned the meeting.

Next meeting is Monday, June 4, 11 a.m. at Jamestown High School.

Roaldson will visit with Justin Fletschock of NDHSAA to again discuss WDA's position/interpretation on the matter of pitch counts and how they affect the region play-in game. It was moved by M. Lunde seconded by J. Roaldson to have the play-in game on the Thursday (day one) of the West Region Tournament which will be held in Williston. Concerns were brought regarding travel and whether the play-in game could be held at a more convenient time/location for those teams involved. P. Jundt pointed out that next year the play-in game(s) would need to be moved off the opening day of the tournament since two play-in games would be necessary to get the region bracket to eight teams. Voting yes to have play-in game on Thursday of Tournament: M. Lunde, J. Roaldson, G. Fridley, S. Nustad, D. Mieux, M. Wiest, B. Lervick. Voting No: P. Jundt, B. Schumacher, D. Zittleman. Abstaining: S. Martin; **Motion carried, 7-3.**

Sub-varsity baseball tournaments will be scheduled at a future time when programs have a better idea of how many teams they will field this spring. G. Fridley note that lack of umpires/officials living in his area will make it unlikely for Dickinson to again host a sub-varsity tournament (Baseball or Softball) the spring.

D. Zittleman said discussion will resume on scheduling the sub-varsity tournaments at the next meeting.

#### Boys Golf

Schedule for 2018 has been set with the East-West Tournament scheduled for Fargo. WDA officials want to see the event moved back to Jamestown. Watford City will be added to the schedule of meets. A decision will be needed at some point on how many regular season meets the conference wants to set up. And whether there should be a schedule rotation, if it's not possible for every school to host a tournament during the regular season due to tournament limits.

#### Volleyball

The 2018 schedule has been set and teams have determined which in-season tournaments they will compete in. The conference schedule will feature 11 teams with the addition of Watford City and three scheduling groups for an unbalanced schedule. Schedule format was adopted this past fall with collaboration from coaches.

#### Boys Swimming-Diving

## Future WDA/West Region Postseason Events

WDA officials reviewed the proposed schedule of 2018-19 WDA/West Region Tournament locations/venues. The plan will be forwarded to NDHSAA for final approval.

Some changes were approved. The West Region boys' hockey tournament will be held in Minot. (Initially, scheduled for Bismarck). The tournament will return to Bismarck (2019-20 season).

Bismarck will host the West Region Baseball Tournament. St. Mary's School will co-host with Bismarck Public Schools. The 2018-19 postseason schedule can be viewed on the conference website -- [wdasports.org](http://wdasports.org)

## Graduation Requirements

J. Roaldson discussed how changes in graduation relating to extra-curricular activities/participation could affect how programs determine participation opportunities for student-athletes. Issue will continued to be monitored to see if schools need to address language in its policies pertaining to participation in extra-curriculars activities.

## Postseason Tournament Schedule

Tournament managers/host do have the right to adjust the schedule of opening round tournament games to allow the host team to play in the evening. This practice already occurs in some activities/sports (baseball/softball) and is allowed by NDHSAA. Other region tournament brackets generally have stuck to the 1-8, 4-5, 2-7, 3-6 order of quarterfinal games.

## Future broadcasting of West Region Basketball Tournaments

Plans are calling for 2019 West Region boys-girls basketball tournaments to be broadcast by BEK Sports/BEK Communications as approved by the NDHSAA. WDA officials expressed concerns about how this may affect attendance, and essentially, tournament revenue. Revenue generated from the event helps to cover annual WDA expenditures/services. Most prominently, funding the conference's executive secretary/SID position. D. Zittleman will visit with M. Fetsch, NDHSAA executive secretary, about these concerns and whether the conference will receive some of the proceeds of the broadcasting contract.



#### **Sub-varsity game limits for basketball**

With the addition of Watford City a question was posed as to whether it would affect the total number of sub-varsity games available, i.e., continuation of postseason tournaments. The additional two games on the will not mean the discontinuation of end-of-season tournaments. Players are allowed a predetermined number of quarters to play. Coaches will need to monitor these quarter totals to assure players will be eligible to participate in the Sophomore and JV tournaments.

#### **WDA Scholar Award**

Applications and Nominations for the annual WDA Senior Scholar Award must be completed by Feb. 28 in partnership with NDIAAA. One senior boy and senior girl will receive \$500. Selection committee will review applications and select this years scholar winners.

The recipients will be announced at the West Region Basketball Tournaments in Bismarck. Recipients will be recognized at halftime of the boys' championship game, and/or during halftime of a game which involves schools of the scholarship recipient. M. Mullally will be on hand to take a photo of the recipients. The new scholarship winners will be posted on the Team Scholar Award page.

At the conclusion of the girls and boys championship games, the all-WDA teams will be announced. Coaches will select the teams at the Sub-varsity tournaments a week earlier.

#### Spring

—B. Lervick reviewed the planned varsity baseball schedule. The plan is for conference games to primarily be played on Tuesdays. A single round robin doubleheader of two 7-inning games will be implemented. The home team will have last at bats in both contests. Lervick is also setting up non-conference doubleheaders with EDC opponents as well as non-counters with WDA teams to fill out schedules. —Minot will be hosting the West Region girls' tennis tournament. It was moved from Bismarck. The event will be held Thursday, May 25 thru Saturday, May 26, 2018

—S. Martin said TMCHS is beginning a girls' soccer program. The team will be scheduling JV matches this spring with intent to go to varsity in a couple years. Bismarck will be hosting the first West Region girls soccer tournament. The event will be held on Tuesday, May 22 and Thursday, May 24.

—J. Roaldson earlier forwarded the 2018 softball schedule. Current pod

set up will remain. Minot Bishop Ryan will remain in the WDA for the upcoming season. Changes to the pod system/ or other scheduling changes will be addressed after 2018 with the addition of Watford City to the conference. It's not known if Minot Bishop Ryan will remain in Class A or move to Class B, following this season.

—The 2018 East-West Classic boys' golf meet will be held in Fargo, April 27-28. Event was traditionally in Jamestown.

## Watford City transition to Class A and WDA

Randy Cranston, Watford City activities director, attended to discuss plans for Watford City move to Class A and the Western Dakota Association, beginning in the fall of 2018.

Sports in which WC will sponsor include: (Fall) Football (AA); boys and girls cross country; volleyball; and girls golf (Winter) boys and girls basketball; wrestling; (Spring) boys and girls track, baseball, softball, boys golf.

At this time, no plans for Watford City's Junior Gold (club) hockey to request becoming a school-sponsored activity. Soccer potentially could be a sponsored activity in the future.

Cranston would like to continue and expand scheduling now of sub-varsity and JH activities so his teams/programs can get acclimated to WDA-level competition.

—No board action has yet been taken to formally add Watford City as a full member to the conference, beginning in 2018-19.

## New Business

### Fall Sports Review

**Volleyball:** The 2018 schedule will feature 11 teams with the planned addition of Watford City. As a result, a new scheduling format is needed. A schedule proposal was presented by Dickinson. It would feature an unbalanced schedule using "three scheduling groups". The format presents one-point and two-point matches since not every team plays each team twice.

Additionally, there was discussion on which regular season tournaments WDA teams would participate in. Bismarck hosts a tournament in late August (first weekend of play). Dickinson hosts a tournament in later September while Fargo has a tournament the first weekend in October.

Under a new scheduling change, teams would have to scale back to two tournaments. If Bismarck decided to discontinue its tournament, would Fargo move its tournament to the opening weekend? Dickinson would like to continue its tournament, but any change of date could jeopardize them getting teams from Billings, MT. Directors will draft the 2018 WDA schedule. In regard to in-season tournaments, the directors request feedback from coaches following their region meeting. 2018 scheduling will be revisited in January.

**Girls' Golf:** Dickinson hosted the West Region Tournament. Scheduling for 2018 will feature nine meets plus the West Region Tournament.

P. Jundt said having an official present to monitor holes/scoring at future tournaments/at least the state qualifying tournament, should be considered. There has been issues, both in girls and boys competitions, regarding accurate scoring kept by golfers and proper rule interpretations. An idea pitched is that at the first meet teams would play together and coaches closely monitor their rounds to teach/instruct proper playing procedures and application of rules. These Items to be revisited again at January meeting.

**Boys' Soccer:** A majority of coaches at region meeting again want to dis-continue the WDA/W Region tournament. They additionally requested an additional week to the season to spread out matches. Discussion about players required to have matching color undershirt/garment. J. Roaldson said the 2018 East-West Crossover again will be a two-day event in Jamestown, Aug. 17-18.

**Boys-Girls' Cross Country:** Williston hosted the WDA Championships. 2018 scheduling reviewed. D. Mieux said the only issue to come out of the region meeting was a tie for senior athlete. Next year's conference meet will be in Jamestown.

**Football:** AAA 2018 scheduling in place. Coaches requested facilities be equipped with a data/stat program to provide statistics following games. Directors took no action.

**Boys Tennis:** Bismarck hosted the West Region Tournament. No issues from coaches at region meeting.

#### **2018-19 Basketball Scheduling**

B. Schumacher presented the planned 2018-19 boys and girls basketball scheduling. A double round robin schedule for 11 teams (Watford City added). There may be some tweaks needed due to facility availability issues.

#### **West Region Tournament additions/changes**

President Zittleman said the addition of a West Region girls' soccer tournament as well as a site change of girls' tennis from Bismarck to Minot in the spring requires official notification to NDHSAA. Zittleman will draft a letter to NDHSAA informing of the additions/changes.

#### **Changes to future WDA meeting dates**

To avoid a conflict with the a January NDIAA meeting, President Zittleman set the next WDA regular meeting will be held on Wednesday, January 10, 2018 in Minot, beginning at 10 a.m. Location will be determined at a later date.

Winter Sports: 3.6 GPA in 3rd nine-week grading period or 4th six-week grading period.

Spring Sports: 3.6 GPA in 4th 9-nine week grading period or 6th six-week grading period.

Roaldson proposed formally adopting it into the by-laws. It was moved by Lunde, seconded by Roaldson to include academic all-conference criteria in the WDA by-laws. WDA dual tournament to determine the four seeds to move on to the Class A Dual Tournament?

Often matches take very little time to complete. Some of the reasons for that is due to open weight divisions due to low numbers or injuries. And some due to coaches electing to hold out kids to avoid a match with another wrestler. Does it warrant the expense in traveling/facility costs?

Some programs like duals as an opportunity to get home matches draw support/awareness to the program. Hosting a triangular is possibility to remedy some of those problems. It adds the possibility of another match. J. Roaldson said one option is invite a strong Class B program from the area to take part. S. Martin said last year TMCHS had Class B Rugby participate in a triangular with BHS.

D. Zittleman said some coaches like duals, especially those early in the week (Tuesdays) because it provides early weigh before weekend tournaments. D. Zittleman added that from his experiences that wrestling people seem to put up with the issues that affect their sport; i.e., having these duals that don't take long or have limited matches. Also, having to travel distances to one match.

Some pointed to other sports like golf and gymnastics where there are low participation numbers, but we still travel regularly to events.

### Spring Sports Review

Girls' Soccer: B. Lervick will draft a schedule framework for 2017. The earliest a regional tournament would be added is 2018.

Softball: J. Roaldson will draft a schedule framework for 2017. This year's W. Region Tournament will be conducted over three days and is hosted by Jamestown.

Baseball: M. Wiest will draft a schedule framework for 2017.

It was decided at the June 6 meeting to again count both games of the varsity doubleheader in the 2017 season. The first game is five innings and the second is seven.

J. Roaldson said given the decision to go back to metal bats should revisit this issue of counting both games. There is concerns that metal bats will create longer games and tax pitching staffs. Should we go back to the first one counting and the second a non-counter in the WDA standings? Perhaps one option to consider is going to 1 varsity counter. National Federation only allows a seven inning game.

Some ADs have indicated we simply have too many games in such as small window of time. Perhaps the one game will alleviate many issues relating to pitching and overuse of players. ADs will gather feedback with coaches about future scheduling options.

D. Zittleman said we seem to have this discussion regularly on when/where and what postseason awards should be announced at events.

In recent years, our conference has made it commonplace to announce all-conference honors at the conclusion of the region tournament. This has been the case in volleyball/hockey. Outside of boys and girls' regional basketball, an all-tournament team is usually not put together by tournament management. In the case of football, all-conference awards are not released to media outlets/public until the season is complete.

All-state awards are usually released after state tournaments. Do we need a standard policy/agreement as to what our conference will announce and recognize at postseason events to create uniformity among activities? This could be a discussion topic at future tournament committee meetings.

## Old Business

### Fall Sports Reports

**Football:** Scheduling for 2017 should be set. 7 teams to compete in AAA West Region.

**Girls' Golf:** Bismarck Public Schools is starting to have issues with local courses about scheduling high school events on Saturdays.

**Boys' Soccer:** Coaches meeting again indicates no support to continue West Region Tournament. Reasons include it's not allowing sufficient preparation time for state tournament; regular season should determine the top four seeds; EDC does not have a regional tournament; it makes it difficult to space out matches knowing it has to set aside the first weekend in Oct. for the regional.

M. Lunde said should we have an "official vote" of coaches to determine their position. P. Lunde said he's listened to the complaints and it sounds like a "sport's problem" to coaches not legitimate reasoning for discontinuing the tournament. Lunde added we shouldn't be talking about not having a boys' regional tournament, but rather why we don't have a regional tournament for girls soccer? It seems we should providing that same postseason experience. And given issues with Title IX, should we ensure are providing the same postseason opportunities. D. Zittleman said we've come to this discussion before and this group feels strongly the benefits counter what some coaches are saying.

B. Schumacher said this season saw a lot of parity in the conference, especially between seeds 2-5. It would've been ashame not to give that No. 5 seed an opportunity to compete for a state berth. And even seeds No. 6 and 7 provided a competitive play-in match. Other concerns expressed is how do coaches keep a team/players motivated to train and compete the right way if they know there is no end-of-season opportunity to qualify. B. Lervick said we should meet with our soccer coaches and get their feedback/input on this issue before moving forward with scheduling and making any formal decisions on postseason plans. Another concerns was spacing out more days between matches to en Many matches are scheduled now on Tuesday and Thursdays. Soccer is a grueling sport and the current schedule doesn't present a lot of recovery time. P. Lunde said he would like to look into possibly a Monday and Thursday schedule to allow additional day of rest/preparation. Of course, that hinges on facility and referee availability. Soccer has traditionally avoided Friday matches due to football. Saturdays are an option, but again, it comes down to facilities and referees.

Some ADs indicated they will not be participating in the West Fargo Tournament in future seasons.

### Boys' Tennis

M. Lunde said there was no issues to report on the season. Coaches did

share their support of Minot being the site of W. Region Tournaments because of its ideal facility (Hammond Park). It allows all matches to be held at one site. Lunde said certainly other communities can host this event in the future. He's just reporting the feedback from coaches.

Construction on an indoor recreation facility in Jamestown is underway, J. Roaldson said. And when complete, that will include indoor tennis courts. And thus, another facility option for regional play.

## Boys/Girls Cross Country

D. Zittleman said there was nothing of consequence to report on this year's season. He added Jamestown did a great job hosting this year's state event. Next year's meet will be in Valley City.

## Girls' Swim/Dive

Nothing to report as of this time.

## Volleyball

Recommendation is for coaches to set up 2017 schedule which again will include 16 conference matches and three tournaments. A formula based on the regular season order of finish will be used to determine which teams will play two less matches against two other teams. Those matches, however, will count double in the standings.

G. Fridley said he will develop the framework of a future scheduling system which would adopt a 18-2 model (double round robin WDA schedule).

Adopting the double round robin schedule and dropping one in-season tournament will have an affect on in-season tournaments. If several WDA teams elect not to take part in the Fargo Scheels Tournament in early October, than its likely many EDC teams will not participate in the Bismarck Invite in late August or Dickinson's tournament in late September.

WDA coaches indicated disappointment in the Scheels Tournament in Fargo. Several teams ended up playing conference foes in pool and placing round matches. B. Lervick did discuss this matter with Todd Olson, Fargo Public Schools AD. Olson was not involved in this year's tournament scheduling. He agreed changes need to be made to prevent teams playing conference foes, if possible.

## RSchool Today Posting of Varsity Schedules

A reminder that the deadline for posting 2017 fall varsity events on the site is approaching. That deadline is Dec. 1.

The deadline to post winter varsity events for 2017-18 will be April 1.

P. Jundt said he's concerned about the potential for errors in posting schedules when multiple individuals are posting events. An incident occurred where he set his schedule and one of his event dates were changed unbeknownst to him. It created an issue/confusion. He said if a mistake is going to be made in posting schedules it better come from him. It's important that schools stick to the guidelines in properly posting schedules.

## Winter Sports Review

**Gymnastics:** The 2017 WDA Championships will be held Minot, Feb. 17.

**Boys/Girls Hockey:** It was raised whether Hazen-Beulah will be fielding a varsity program this year. They will have a varsity team.

**Wrestling:** Coaches/ADs are reminded that skin checks are required at dual and tournaments.

G. Fridley said this year's Dickinson Tournament will only be one day/individual (Saturday). He expressed disappointing in having to scale back the tournament as a result of a drop in teams taking part, especially conference members. Some are competing in other tournaments that week.

Discussion was raised again on conference duals and whether they are necessary part of the WDA schedule. G. Fridley said is better to have a

WDA dual tournament to determine the four seeds to move on to the Class A Dual Tournament?

Often matches take very little time to complete. Some of the reasons for that is due to open weight divisions due to low numbers or injuries. And some due to coaches electing to hold out kids to avoid a match with another wrestler. Does it warrant the expense in traveling/facility costs?

Some programs like duals as an opportunity to get home matches draw support/awareness to the program. Hosting a triangular is possibility to remedy some of those problems. It adds the possibility of another match. J. Roaldson said one option is invite a strong Class B program from the area to take part. S. Martin said last year TMCHS had Class B Rugby participate in a triangular with BHS.

D. Zittleman said some coaches like duals, especially those early in the week (Tuesdays) because it provides early weigh before weekend tournaments. D. Zittleman added that from his experiences that wrestling people seem to put up with the issues that affect their sport; i.e., having these duals that don't take long or have limited matches. Also, having to travel distances to one match.

Some pointed to other sports like golf and gymnastics where there are low participation numbers, but we still travel regularly to events.

### Spring Sports Review

Girls' Soccer: B. Lervick will draft a schedule framework for 2017. The earliest a regional tournament would be added is 2018.

Softball: J. Roaldson will draft a schedule framework for 2017. This year's W. Region Tournament will be conducted over three days and is hosted by Jamestown.

Baseball: M. Wiest will draft a schedule framework for 2017.

It was decided at the June 6 meeting to again count both games of the varsity doubleheader in the 2017 season. The first game is five innings and the second is seven.

J. Roaldson said given the decision to go back to metal bats should revisit this issue of counting both games. There is concerns that metal bats will create longer games and tax pitching staffs. Should we go back to the first one counting and the second a non-counter in the WDA standings? Perhaps one option to consider is going to 1 varsity counter. National Federation only allows a seven inning game.

Some ADs have indicated we simply have too many games in such as small window of time. Perhaps the one game will alleviate many issues relating to pitching and overuse of players. ADs will gather feedback with coaches about future scheduling options.

### Sixth Grade Track/Travel

G. Fridley asked how other members set up events/meets for sixth grade track. Do they take them to out-of-town meets. M. Lunde said in Minot they only have in-house competitions. This common practice at others in the conference. Fridley said they are in the process of setting up schedules and he wanted to check on what other programs are doing.

### All-Region, All-Tournament, All-State recognition

D. Zittleman said we seem to have this discussion regularly on when/where and what postseason awards should be announced at events.

In recent years, our conference has made it commonplace to announce all-conference honors at the conclusion of the region tournament. This has been the case in volleyball/hockey. Outside of boys and girls' regional basketball, an all-tournament team is usually not put together by tournament management. In the case of football, all-conference awards are not released to media outlets/public until the season is complete.

All-state awards are usually released after state tournaments. Do we need a standard policy/agreement as to what our conference will announce and recognize at postseason events to create uniformity among activities? This could be a discussion topic at future tournament committee meetings.

Typically, a camera technician is present at the games to set up cameras. The broadcast announcers and the technical work for the broadcast is run from the BEK studio. Lunde asked about whether contracts/agreements need to be signed prior to events. Bulawa said BEK is comfortable working with schools and don't require contracts. He understands the concerns school officials have regarding broadcasts taking away from admission/concession revenue from schools. Schools have the final say on determining which events they want to cover, or indicate which contest they specifically don't want broadcast. Bulawa said BEK is wrapping up their schedule and would be interested in broadcasting WDA events this school year. Broadcast schedules would have to be established soon.

**Girls' Tennis:** Coaches again are requesting an additional week to fit in scheduling matches in 2017. This season featured a few examples where some teams were playing three, sometimes four WDA matches in one week late in the season. More time would ease that build up of matches.

P. Jundt asked why we are not playing a double round robin WDA schedule. Why are we playing so many non-conf. matches? Board recommends going to a double round robin WDA scheduled for the 2017-18 season. Will get feedback from coaches as whether those matches should be 9 or 5-point matches.

**Softball:** JV/Varsity postseason tournament brackets should note that higher seed in all instances will be the home team.

**Track/Field:** Coaches requested that eight placewinners at WDA Meet qualify for the Class A Meet. Currently, top six qualify. D. Zittleman said N.D. currently has the largest participation levels of any state track meet. Additional qualifiers (by place) are not necessary. There is qualifying standards are in place.

**Girls' Soccer:** Coaches requested again adding another week to the season to spread out matches. (Request was turned down at the boys' level). Another issue is whether a time clock/scoreboard time should be displayed during JV matches. Currently, official time is kept by the referees.

**Boys' Golf:** Coaches discussed is there any suspension procedure for players who are found to be skimming strokes (cheating on score) during meets. Should they be ineligible for upcoming meets/postseason awards (All-WDA)? Currently coaches and activities directors are addressing this issue in-house with its players that are found/suspected of skimming strokes.

There was some discussion on moving the East-West Classic Tournament to other locations. It's been held in Jamestown. Coaches want to keep it there as it's fairly centrally located for both conferences.

**Baseball:** Several issues brought forward by coaches. One, going back to the first game of the doubleheader (7 innings) counting in the standings and the second game (5 innings) is a non-region counter. L. Jungling reported that coaches voted 5 to 4 to go back to the one game count and the second game does not.

J. Roaldson said his coach is a proponent of going back to the initial schedule, indicating it's been difficult to develop pitchers, get more kids participating in varsity games. According to the coach, Why was there a need to change something that was working?

S. Nustad said prior to the sport getting NDHSAA-sponsorship there was club teams and usually just one, so the two doubleheaders were set up 7 inning and 5 innings. The first second game was sort of a defacto JV game since those programs didn't have a lot of numbers. Now, with more participants and JV teams, there are other opportunities to develop kids (in JV games). P. Jundt said it bothers him to set up a varsity WDA schedule where half the games count.

Discussion extended as to whether both games should be 7 innings, but no action taken.

It was moved by P. Jundt-seconded by B. Lervick to keep the current schedule format (Both games in the doubleheader count in the WDA standings). First game is five innings and second game is seven innings.

**8 yes, 1 no; (Roaldson), Motion carried.**

Second issue brought forward was returning to metal bats. L. Jungling said coaches voted 5-4 to keep wood bats. Board agreed to go along with coaches and keep wood bats. Third issue, coaches in favor of having the play-in games be held prior to the region tournament. Board earlier approved scheduling play-in games on the Monday or Tuesday before the tournament.

#### **SID/Executive Secretary Contract**

The 2016-17 SID/Executive Secretary contract for M. Mullally was reviewed and approved. Moved by L. Jungling-seconded by G. Fridley. All yes. **Motion carried.** Concerns were raised as to funding the position and the current procedure of payment. The drafted contract sets up payment schedule. Revenue from West Region tournaments are now going into the WDA account help fund the SID/Executive Secretary duties/services. M. Lunde said the position is not permanent and wanted Mullally to be aware.

#### **Fan Conduct**

Discussion about whether WDA should look to establish a uniformed policy regarding fan behavior/sportsmanship expectations. NDHSAA code of sportsmanship already read prior to activities, so whether a banner or policy will have much affect is debatable. If there are unruly fans, WDA officials support each other in taking necessary steps to address incidents at their respective sites.

#### **2016-17 Scheduling**

Board discussed getting varsity schedules posted on the R School today site. Set the fall scheduled for Friday, June 10 with the winter and spring schedules to follow later this month.

#### **All-WDA selection process**

Should there be more uniformity in all-WDA selection of athletes? Some sports (football) give an allotment of all-conf. sports to teams based on their finish in the standings and each team is represented. Some sports (hockey) have a designated number of selection sports based on position (forward-defense). Coaches nominate athletes, but can't vote for their own athletes. M. Lunde said he would look into the issue to determine if changes are in order.

#### **WDA Lifetime Passes**

M. Mullally said nominations are open for WDA lifetime passes. The passes also include a guess to accompany the honoree. Dan Smrekar and Lorell Jungling were nominated and selected to receive passes. It was agreed that each school can select up to three individuals for passes. Selections should be emailed to Mullally so he can arrange for the passes to be made.

#### **WDA Membership Dues**

After discussion, it was moved by S. Martin seconded by D. Zittleman to increase the annual conference membership dues to \$1,000 per school. All Yes, **Motion Carried.** Scott Nustad moved-seconded by S. Martin to increase associate member dues to \$50. All Yes, **Motion carried** The current fee was \$625 (full member) and \$25 (associate member). M. Mullally will send out changed membership fee invoice/bill letter. Fees are due by Sept. 1, 2016.

#### **WDA Administrative Passes 2016-17**

M. Mullally is requesting a list of administrators from each respective school/district who will need 2016-17 administrative passes. Mullally will send the form via email by (June 10). List should be returned as soon as possible so Mullally can make arrangements for the passes to be made.

#### **Proposed WDA/W. Region coaches' meeting scheduled**

M. Mullally presented a schedule for upcoming WDA/W. Region coaches' meetings for the 2016-17 year. Board asked to review and finalize meeting location/times and which AD will be in attendance to oversee the meeting. Schedule will be discussed at August meeting.

#### **WDA/West Region postseason site rotation**

Board made recommendations and approval for future WDA/W Region postseason tournament/championships. The updated list will be posted on the conference website.

#### **2016-17 WDA year**

Beginning at the August meeting, the new term for WDA officers will begin. Current president M. Lunde has a year left on his term. Bismarck High board representative S. Nustad will fill vice president spot.

#### **Williston AD position**

L. Midthun, who is leaving Williston for the activities director position in Big Lake, MN, said as of June 6 there was no timeline for hiring his replacement.

#### **Mandan AD position**

Mark Wiest will take over activities director duties at Mandan later this summer, replacing L. Jungling, who is retiring.

#### **St. Mary's AD position**

Bruce Schumacher has taken over activities directors duties at St. Mary's. Dan Smrekar will continue to assist in some of those duties over the next season.

## NDHSAA

### Class A Review items

- \*Will consider returning to metal bats in baseball
- \* Recommend facemarks for ast pitch for softball.

### Athletic Review items

- \*An increase in tennis matches.
- \*Random of draw of which weight class should begin matches at state tournament. Currently, random draw now used for regular season duals.
- \*Addition of consolation round matches at state dual wrestling tournament.
- \*Review state track provisional qualifying standards.
- \*Additional two games for the boys'/girls' hockey season.
- \*Designate more time for shoot arounds at Class A basketball tournament (prior to a team's first game). Currently, the shoot arounds are schedule at halftimes of other games during first day.
- \*Begin girls' soccer season a week earlier.
- \*Review proposed changes to football classification, beginning in 2017. Under proposal, WDA would have seven AAA playing members (BHS, Century, Dickinson, Legacy, Mandan, Minot, Williston) Three AA members (Jamestown, St. Mary's, TMCHS (Belcourt).

### Tournament Committee

- \*Should seventh place consolation games be eliminated from Class A competition entirely? Some sports still play out a seventh place match/game. Examples, Volleyball and Baseball.
- \*Recommendation that spring tournaments sites be equipped with lights.
- \*G. Fridley addressed his concerns that Dickinson is not getting enough consideration for hosting state tournaments. Fridley understands some events are needed to be hosted in a few locations due to venue size and other factors. However, he feels his community is not getting the same amount of opportunities to host events as other cities. Was asked to submit a list of state tournament events the community is capable of hosting in the future. It will be forwarded to the NDHSAA Tournament committee.

### SID Report

M. Mullally recommends renewing the Go Daddy website service contract which is expiring this summer. Improved services has enabled updates/changes to the website to be conducted with no glitches. May 2016 produced the most monthly traffic to the site, just shy of 37,000 views. The estimated cost for the Go Daddy contract is \$180 a year. B. Lervick asked if more specific user traffic google analytic statistics could be made available.

M. Mullally is completing a comprehensive 2015-16 statistical yearbook for all 22 sponsored activities. Standings, postseason review, in-season news and notes, statistics and team-by-team results will be featured. Additionally, there will be other information pertaining to the conference, including tie-break criteria, team scholar recipients and WDA Scholar award program/winners. The 2016-17 postseason schedule and future WDA/W Region postseason sites will also be included. Mullally has discussed the project with a number of ADs. Request for project to be printed and sold to patrons. A printing estimated has been obtained and Farmers Union Insurance has agreed assist in the costs. Approximately 750 books would be available. Additionally, the project would be posted on the website, if file size is permitted by web provider.

P. Jundt wondered if posting it to the site would be the better as opposed to publishing the yearbooks. B. Lervick asked if preseason guides for each sports season (fall, winter, spring) could be completed/printed. A fall guide was completed and posted on-line the past years by Mullally. However, the short window of time between seasons to complete the winter and spring guides makes that a difficult endeavor.

### WDA Branding/Logo

M. Mullally arranged and custom polo shirts be made for board of directors with the conference logo and respective school logo/and colors. Paradise Screen Printing LLC/Bismarck-Mandan completed the project. The cost of the shirts were \$338.67. Moved by J. Roaldson-seconded by S. Nustad to approve payment of the shirts. **Motion carried**

President Lunde adjourned the meeting.
