PUBLIC NOTICE FOR THE OPENING AND CLOSING OF THE WAITING LIST

THE DANIA BEACH HOUSING AUTHORITY WILL BE ACCEPTING APPLICATIONS FOR THE SECTION 8 HOUSING CHOICE VOUCHER WAITING LIST

Preliminary applications must be completed online beginning Wednesday, September 1, 2021 at 9:00 AM and the list will close automatically after two hundred successful submissions of preliminary applications online. To be eligible to be placed in the waiting list, the Head of the Household **MUST** be 18 years of age or older. The total household annual gross income **must not** exceed the **very-low-income** limits for the appropriate family size as listed in the Income Limits Table appearing at the end of this Public Notice.

If you wish to apply, you will need to logon to <https://daniabeach.housingmanager.com/> and press the **APPLYING FOR HOUSING** button on the landing page. Please ensure that you complete **all** the required fields, or the application will not successfully be submitted at the end.

Pre-Applications WILL BE ACCEPTED ONLINE ONLY.

Pre-Applications must be completed beginning Wednesday September 1, 2021 at 9:00 am until the system has successfully accepted/received two hundred (200) pre-applications. After that, no additional applications will be accepted.
Hand delivered or Mailed applications **WILL NOT** be accepted.

For the Section 8 HCV Waiting List:

The first two hundred (200) completed pre-applications submitted online will be added to the waiting list. If you successfully are added to the waiting list and have any changes to address, phone number, income, or any other information, you must log back into the application and **EDIT** the application by entering the new information.

- Placement on the waiting list will be determined by the order of submission on-line of a completed pre-application.
- Duplicated applications will be removed.
- Incomplete applications **will not** be submitted.
