Monthly Report for May 2019

This is the monthly report for the Month of May 2019 from the Bloomfield Police Department. It is the police department's goal to keep the citizens of Bloomfield Township/Village informed as to the police department's activities, statistics, and community projects. It is very important that the citizens be aware of the various concerns that have and are occurring within our community.

On Thursday, May 2nd at approximately 11:16pm officers executed a traffic stop on Hwy 50 for a traffic infraction. At the conclusion of the traffic stop a 17-year-old female was issued traffic citations for speeding and operating a motor vehicle without a valid driver's license.

On Saturday, May 4th at approximately 6:35am officers responded to the area of Bloomfield Rd and Brevers Lane for a hit & run vehicle versus tree crash. At the conclusion of the investigation a 31-year-old female was issued a traffic citation for vehicle owner's liability for failing to stop at the scene of an accident.

On Sunday, May 5th at approximately 7:48pm officers responded to the 1000 block of Geranium Rd for a disorderly male subject. It was determined that the disorderly male subject had fled the scene prior to officers' arrival. At the conclusion of the investigation, charges of disorderly conduct and criminal damage to property have been referred to the Walworth County District Attorney's office for a 48-year-old male subject.

On Tuesday, May 14th at approximately 4:40pm officers executed a traffic stop in the area of Pell Lake Drive and Hwy 12. At the conclusion of the traffic stop a 26-year-old female was issued a traffic citation for operating after suspension and operating a motor vehicle without insurance.

On Wednesday, May 15th at approximately 7:50am officers responded to the area of Hwy H and White Pigeon Road for a personal injury crash. At the conclusion of the investigation a 21-year-old female was issued a traffic citation for an automobile following too closely. There were non-life threatening injuries associated with this crash.

On Wednesday, May 15th at approximately 11:50am officers responded to the area of Hwy H and Lake Geneva Hwy for a personal injury crash. At the conclusion of the investigation a 75-year-old male was issued a traffic citation for an automobile following too closely. Additionally, a 42-year-old female was issued a citation for vehicle operator failure to wear a seatbelt. There were non-life threatening injuries associated with this crash.

On Sunday, May 19th at approximately 1:03am officers responded to the 100 block of Lilac Ave for a report of a disorderly subject. At the conclusion of the investigation, a charge of disorderly conduct has been referred to the Walworth County District Attorney's office for a 51-year-old female subject.

On Wednesday, May 22nd at approximately 3:59pm officers issued a citation to a 27-year-old male for operating after suspension after observing him drive to his municipal pre-trial conference.

On Thursday, May 30th at approximately 4:22pm officers responded to the 700 block of Violet Road for a battery that had occurred. At the conclusion of the investigation charges of battery and disorderly conduct have been referred to the Walworth County District Attorney's office for an 18-year-old male subject.

On Thursday, May 30th at approximately 7:22pm officers responded to the 1000 block of Iris Ave. for a disorderly male subject. At the conclusion of the investigation a 29-year-old male subject was arrested and confined in the Walworth County Jail. A charge of disorderly conduct has been forwarded to the Walworth County District Attorney's office.

On Friday, May 31st at approximately 9:40pm officers received an operating without owners consent complaint. At the conclusion of the investigation it was determined that a 53-year-old male had taken and operated a motor vehicle without consent from an address in the 800 block of Roman Lane. A charge of operating a motor vehicle without owner's consent has been referred to the Walworth County District Attorney's office.

During the month of May 2019, the Bloomfield Police Department responded to 793 calls for service compared to 856 calls for service during the month of May 2018. During the month of May 2019, the police department affected 147 arrests for various violations of Bloomfield Municipal Ordinances and Wisconsin State Statutes compared 113 arrests during the month of May 2018.
