Also, check the Villages Daily Sun Rec News, published the Thursday before our scheduled meeting, which is the second Tuesday of the each month, with a social hour at 6:00 pm and the meeting at 7:00 pm, as to time, place and what is scheduled for food. The Rec News does limit our space to 50 words or less and must edit comments exceeding that. We will try to put the menu in the Rec News announcement, and include what we are asking members to bring, guest speakers, guests, entertainment, and dignitaries scheduled to attend (if any).

We were dark for July and August, officially, but due to the COVID- 19 VIRUS, much longer. The official guidelines for the Villages Community Development Districts and use of the recreation centers, or park, is reprinted here for all to follow (NOT JUST WHERE WE MEET AT HIBISCUS BUT EVERYWHERE IN THE VILLAGES):

TO RESPONSIBLY VISIT A RECREATION CENTER OR PARK, PLEASE KEEP TO THE FOLLOWING (THIS IS ALL APPLICABLE DURING COVID TIMES):

1. IF YOU ARE SICK, OR HAVE SYMPTOMS OF FEVER, COUGH, SHORTNESS OF BREATH OR BEEN RECENTLY EXPOSED TO THE COVID-19 VIRUS, PLEASE DO NOT COME TO ANY RECREATION CENTER OR PARK UNTILL YOU HAVE A DOCTOR'S CLEARANCE.
2. STAY AT LEAST 6 FEET AWAY FROM OTHERS (SOCIAL DISTANCING), ALWAYS KEEPING THIS MINIMUM SPACE BETWEEN YOURSELF AND OTHERS.
3. WEARING A MASK IS REQUESTED, (IF CLOSER THAN 6FT, MASK IS REQUIRED) AND APPROPRIATE ATTIRE FOR THE ACTIVITY. SOME BUSINESS FOLKS REQUIRE A MASK FOR ENTRY.
4. WASH YOUR HANDS WITH SOAP AND WATER FREQUENTLY (20 SECONDS OR LONGER).
5. BRING YOUR OWN WATER BOTTLE.
6. BRING HAND SANITIZER AND DISINFECTANT WIPES.
7. COVER COUGHS AND SNEEZES WITH TISSUE THEN THROW TISSUE IN TRASH.
8. AVOID TOUCHING EYES, NOSE AND MOUTH.
9. CLEAN AND DISINFECT FREQUENTLY TOUCHED OBJECTS AND SURFACES.
10. BRING YOUR OWN EQUIPMENT/SUPPLIES CONDUCIVE TO THE ACTIVITY.
11. LIMIT ACTIVITY TO 1 HOUR.

From me:

Duties: We still need (as always) a backup for our officers and workers. Just because one person does a particular task, that does not mean nobody else needs to know how he conducts that task. Where do you go for the paper drive? Who is the paper drive coordinator? Who are the store managers and their phone numbers, are but a few items to write down and share with another worker. This club does well in having a 2nd Vice and a 2nd Vice in training, and 1st Vice so things go well year after year. We just need to have folks lined up to take those and other positions, such as Committees and know what their duties entail. The primary question is: "How do you do what you do"? We need to have an orderly relief of every person who has stepped up to any volunteer position by providing them with sufficient information to enable them to do that job. President Emmett Mills

Beginning with High School, I attended Shrine High School in Royal Oak, Michigan and graduated in 1965. After High School, I attended the University of Georgia Tech, where I was also a student athlete, and received a BS in electrical engineering and later, a Master’s Degree at Oakland University.

I entered the U.S. Navy in 1967 and served until September 1972. During my time in the Navy, I served with Seal Team #2 and specialized in underwater demolition, as well as satellite communication. Injured in 1972, while serving in the Vietnam Campaign, I was medically retired the same year.

My Masonic career began in 1992, and I was Master of my home lodge in 1996. I joined the Valley of Detroit, Ancient and Accepted Scottish Rite in 1993, and was coroneted a

33rd Degree Mason in August 2008, and am no affiliated with the Valley of Ocala. My Shrine affiliation began in 1993 in Detroit, where I am also a member of Court No. 28, Royal Order of Jesters, and upon moving to the Villages, affiliated with Bahia Shrine. I have been High Priest of my Royal Arch Chapter, Thrice Illustrious Master of the Council of Royal and Select Masons, and am a member of Priory No. 22, and a KYCH. I have been privileged to serve as Commander of Detroit Commandry No. 1, Knight Templar, and have been awarded the Grand Commander's Service Award and shoulder cordon for first line signing of over 35 members. I served as Right Eminent Grand Commander, Knights Templar of Michigan, 2006/2007 and was awarded the Knight Commander of the Temple from the Grand Encampment of the United States.

Additionally, I am currently serving as the Secretary of the Villages Masonic Lodge #394, and as Chairman of the Grand Encampment of Knights Templar of the United States of America as the Chairman of the Holy Land Pilgrimage Committee, sending ordained ministers to the Holy Land as one of the Knight Templar philanthropies.

Also, when not doing something of a Masonic relation, I attempt to enjoy retirement in The Villages and play 72 holes of golf per week.
