Opening – Scott Lauder:

- Scott called the meeting to order at 7 pm with the Pledge of Allegiance.

Secretary's report – Jon Speck:

Treasurer's report – Scott reporting for Bill Means:

- Bill Means is excused tonight, his wife is having shoulder surgery
- Outstanding invoice for fire insurance on the rental home of about \$480
- Had not received final accounting from Dora for the state Pistol Championship

Membership report – Steve Close:

Rental – Scott reporting for Tony DelFrate:

- Tony has had some interest in the property, 2 inquiries and 2 showings
 - One of the distractors to the property is the lack of high speed Internet options
- Bill Means recommended, via email, a rent adjustment to \$750 stating some income is better than no income for the property. It's been a year since it was last rented.
 - Rent adjustment was approved.

Match Director – Dora Potekin:

- Wisconsin State Indoor Championship

 - Dan Gutknecht (*out of state*) is the match winner (1706 – 39X)
