Limited crating will be available in the building with social distancing rules in place and masks required while in the building.

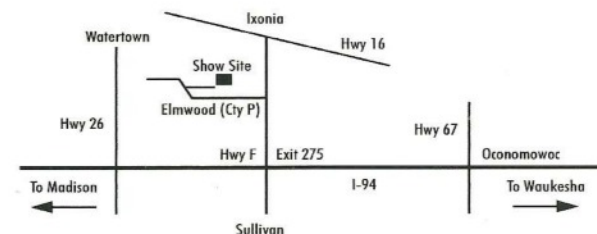

### **DIRECTIONS TO TRIAL**



From Hwy 16: Take Hwy F South through Ixonia. After R-R tracks, turn right/west onto Elmwood Ave/Hwy P; go about 1/2 mile to Cedar Drive. Building at end of drive.

From I-94: Take Exit 275, (Sullivan/Ixonia) and go north about 4.5 miles on Cty F to Cty P (Elmwood Dr). Turn left about 1/2 mile to Cedar Drive. Building at end of drive

- Jump heights will be in order small to tall.

- Please bring your own chair. There will be marks on the floor for you to place your chair ensuring 6 ft between chairs. Bring your chair in and set up without your dog.

**Covid-19 guidelines will be in place. Subject to change depending on the State, Local and National regulations at time of trial.**

- If you are feeling sick, have a fever, cough or are sneezing before leaving for the trial, please stay home. If you have recently been in the presence of someone who has either tested positive for Covid-19 or has the symptoms mentioned above stay home. You can text the trial secretary if you are unable to attend. (Text 414-339-1860)
- There will be entrance and exit doors marked.
- No spectators will be allowed in the building.
- Check-in will be as you arrive at the building at a common location. You will receive a check-in time with instructions after entries close.
- Masks will be required at all times in the building when you are not able to maintain social distancing, when checking in, and when approaching the stewards table.
- Masks are required at the judge's discretion for exhibiting your dog in the ring.
- Should the trial be canceled due to COVID regulations, entry fees will be returned to the exhibitor.
- There will be an entry gate and an exit gate for the ring.
- Surfaces will be disinfected between dogs and as necessary.
- There will be hand sanitizer and wipes throughout the building.
- We will follow state guidelines and UKC Obedience/Rally guideline
- Classes will be scheduled throughout the day to help keep the numbers in the building to a minimum. Times will be determined once the entries close
- There will be no food available for exhibitors. Please bring your own. Stewards and judges will receive a box lunch.
