# Make It Personal

It was a dark day on April 12th, 2018. That was the day the Task Force on the United States Postal Service lead by executive order was created. Its directive was to evaluate the operations and finance of the USPS and report back to the President.

The Task Force consisted of the directors of the Office of Management and Budget, OMB, Mick Mulvaney, and the United States Office of Personnel Management, OPM, Jeff T H Pon, and chairperson Secretary Treasury, Steven Terner Mnuchen. They issued their findings on December 4<sup>th</sup>. An even darker day.

The findings of their investigation on this mandated report is not good for postal employees, their families, retirees, customers, or communities. It threatens our unions, postal salaries and benefits and will hinder service for individuals and businesses. It lays the groundwork for privatization which is opposed by members of congress on both sides of the aisle.


This report suggests selling access to mailboxes to other delivery companies and removes cost caps on mail and package delivery. It recommends re-defining the USPS Universal Service Obligation. The USO is what ensures service to everyone no matter where they live. These are obvious steps toward privatization. The Task Force also supports removing compensation for collective bargaining, or, in other

words, busting our unions. Reforming the federal government pension system by raising employee contributions and continuing the mandate for pre-funding retiree health benefits are also included in the plan.

We have to do what we can to put a stop to this. We need to keep calling and writing our representatives and senators, continue and increase our donations to COPA which supports our lobbyists, and talk, talk, talk. Talk

to your families, friends, neighbors, co-workers, acquaintances, business owners, anyone who will listen. Make it personal. Tell everyone who will listen just how privatization of the post office will directly affect them. Lay it all out about the effects it would have on their pocketbooks, on their local economies, the ability to reach all corners of the world through the mail. How actually adding services, such as postal banking, could improve their lives. Encourage them to reach out to congress.

We as a whole, the unions, postal employees and retirees, auxiliary members, and customers fought and defeated Staples. Together we can make a difference.

# Impasse

Negotiations are at an impasse. The contract between the APWU and the USPS expired on September 20, 2018. There have been four extensions since talks started in July, but to no avail. The next step is Interest Arbitration. Its scary to think about a third party helping to decide matters concerning employee salaries and benefits, but President Mark Dimondstein and the APWU are ready to present a strong case to protect what has already been earned and to defend our further demands. He has stated that it may be necessary to invoke the Federal Mediation Conciliation Service as Interest Arbitration is a slow lengthy process. He urges all of us to stay strong and keep those Contract Action Teams going. Auxiliary members can help by staying informed and continuing to get community support. The current contract is still in effect until an agreement is reached and a new contract is ratified. Many of us have been through this before. We have to hang in there and keep fighting.



Most member's dues expire January 1. That means several states and locals will begin sending their dues to the treasurer very soon. We have a few requests that will insure they are credited correctly and with a lot less guessing.

When possible, type the list. Spreadsheets work great, if, the font is large enough to read without a magnifying glass. Try printing the sheet landscape if you need the space.

Sorting the members by local, then last name and first name is a huge help. We have a few states that have members with exactly the same name but a different address. It can become a guessing game when we try to credit the member. We don't know if the member moved or if they are a new member. Please do not sort your state membership by alphabetizing their last name.

We need to know how much each member submitted, if it is the same for each member, it does not need to be notated. Locals and states that have a set dues year (i.e.: January to January or May to May) please, note that for us. We will do our best to comply with your request.

Membership lists can be obtained from the treasurer upon request.
