APPLICATION FOR SINGLE FAMILY RESIDENTIAL WATER CONNECTION

I (we), the undersigned, do hereby make application to the Fruitland Special Service District ("FSSD") for a culinary water connection to be installed upon the following described real property which is situated within the boundaries of the Special District and which is owned by me or by the entity which I represent:

The water dedication requirement for a standard residential connection is 1.2 acre-feet of water, which includes water for one residence and for the irrigation of up to 0.25 acres of landscaping. The water right(s) or share(s) must be acceptable to FSSD and approved for use in FSSD's system by the Utah Division of Water Rights ("DWR"). Applicant is responsible for filing the necessary change application and obtaining FSSD and DWR approval thereof.

The connection and impact fees will be determined when the application is approved and the fees are paid. The connection fee will include material for a normal installation of a meter on your property line, a maximum distance of 50 feet. (LOCATION TO BE DETERMINED BY FSSD). There may be additional costs if excessive distance, rocky soil conditions, if crossing of any roadway, county, state or private road and if there are any other extenuating circumstances encountered during the meter installation. Currently water rates are \$60.00 per month for a 3/4" meter and up to 12,000 gallons per month. See the FSSD Fee Schedule for the overage rates and other applicable fees. This monthly fee becomes payable immediately upon approval of the application, whether a meter is installed or not. In ordinance of the Utah code R309-105-9(3), R309-540-5(4)(c), and R309-550-11 (3) individual home Booster pumps are not allowed for any individual service from the water supply main. Use of a Home booster pump will cause service to be terminated.

Only one single residence may be serviced per meter
FSSD requires the installation and inspection of a backflow prevention device and recommends that the Customer install a pressure regulator and a stop & waste valve on the Customer's side of the meter. All other rules and Regulations of FSSD shall also apply.

A HEALTH DEPARTMENT APPROVED septic system must be installed before the water is hooked up and documentation of the final approval of the septic system must be sent to FSSD.
