SET UP TIMES: Friday July 2nd —Set up will start at 11am, opening to the public at 3pm. -
 Saturday July 3rd, Booths will open to the public at 11am.
 Vendors can stay open as late as they wish in the evening of the 2nd. We do ask that everyone stay until 5pm on July 3rd.

PAYMENT OPTIONS: Upfront payment for both days \$90 or you may pay a \$50 deposit payable when you submit your form and another \$50 due Saturday morning. **Make checks payable to: Buhl Chamber of Commerce** There will be no refunds once you have been assigned a space. Any refunds issued after full fee has been paid and before June 12th are subject to a \$15 processing fee. All returned checks are subject to a \$30 returned check fee. We must have your completed tax declaration and your temporary food permit (where applicable) returned with your registration. A temporary event food permit must be acquired from the Buhl City Hall prior to selling food at our Sagebrush Days events.
