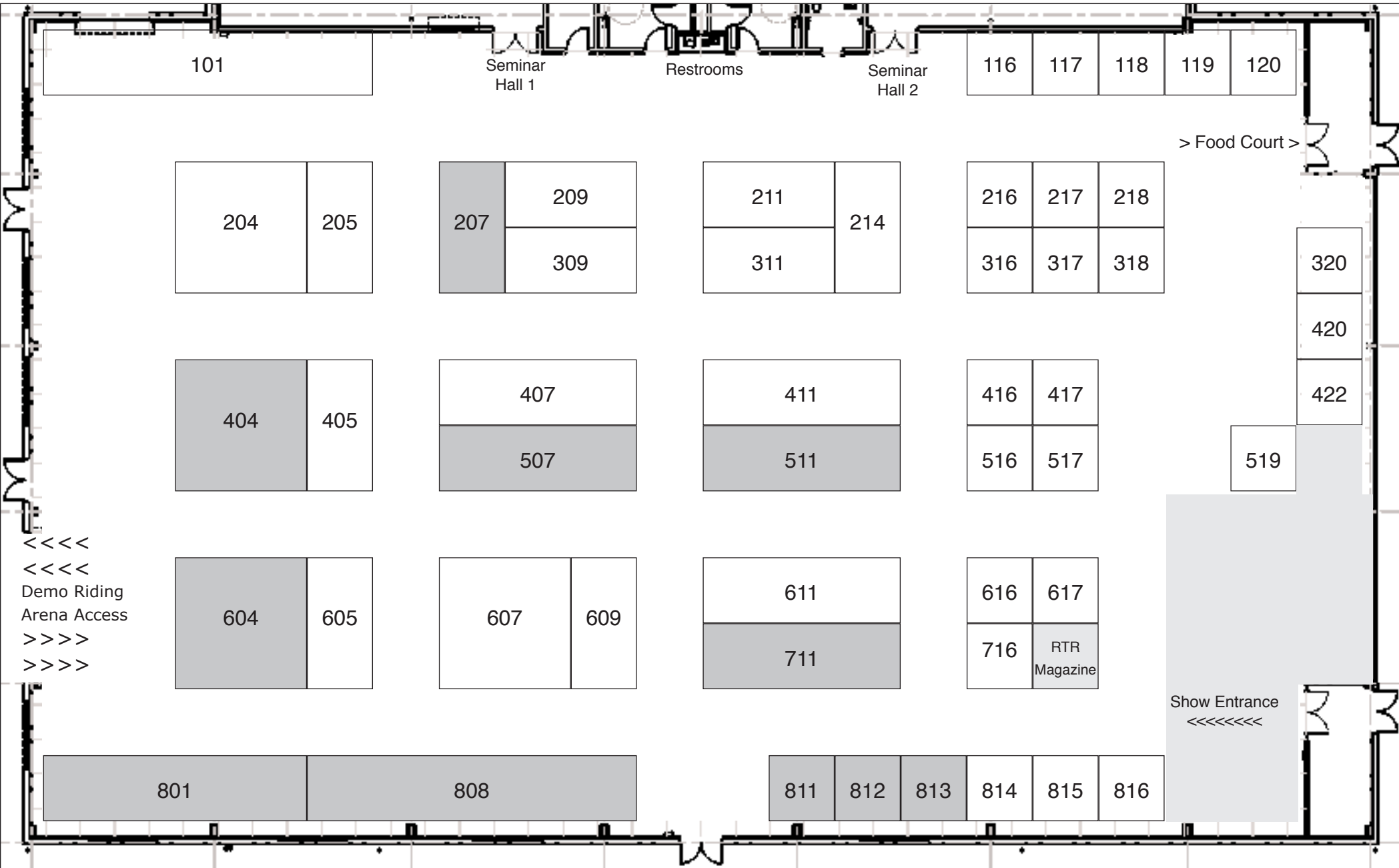

Exhibitor Space Contract for 2021 Cycle-Con Weekend: Recumbent Cycle-Con, Adaptive Cycling Expo, Bicycle Tour & Travel Expo, Electric Cycle-Con

1. Exhibitor agrees to abide by all regulations and rules adopted by Management in the best interests of the Show, and agrees that Management shall have the final decision in adopting any rule or regulation deemed necessary prior to, during and after the Show.

2. Booth Payment Schedule: 15% deposit due with contract submission. 50% of total due April 15, 2021. 100% of total due July 15, 2021.

3. All cancellations must be in writing to Coyne Publishing, LLC. There will be a 25% cancellation fee prior to August 1, 2021. After that date, there will be no refunds.

4. a: Non-Exhibiting Manufacturers Products. Exhibitor may not display products or signage in or above their booth from eligible non-exhibiting companies unless approved in writing by Show Management.

4. b: Sharing or Subletting Booth Space. Exhibitor shall not assign, sublet, share or apportion the whole or any part of the space allotted, or have representatives, products, equipment, signs, printed materials or any representation from other than the company contracted and assigned the exhibit space without the prior written consent of Show Management.

5. All electrical wiring and outlets shall be at the Exhibitor's expense. Exhibitor must use the Montgomery County Fairgrounds Event Center-approved electrical contractor for such services.

6. Exhibitor will be liable for and will indemnify and hold harmless Management for any loss or damages whatsoever occurring to or suffered by any person or company, including, without limiting the generality of the foregoing. Exhibitor, other Exhibitors, Management, official show contractors, the owner of the building and their respective agents, servants and employees, and members of the public attending the Show either (a) on the said space or (b) elsewhere if said loss damages arose from and were in any way connected with Exhibitor's occupancy of said space.

7. Management reserves the right any time to reject, prohibit, alter or remove exhibits or any part thereof, including printed materials, product signs, lights or sound, and to expel exhibitors or their personnel if, in management's opinion, their conduct or presentation is objectionable to other Show participants. All printed materials, product signs, lights or sound, shall be in good taste and will not contravene the spirit, mission and objectives of the Show.

8. Exhibitors agree to confine their presentations within the contracted space only, and within the maximum height set by the Show rules and regulations and to maintain a staff in their booth space during show hours. All single and inline linear booth back walls are restricted to 8 feet in height. No part of the structural display at its full 8ft. height may extend out more than 5 feet from the back wall at the height. Exhibitors may contract with Show Management other opportunities for further visibility, public presentations and advertising.

9. Exhibitor is responsible for the placement and cost of insurance related to Show participation. The Exhibitor is responsible to forward to the Show Management proof of insurance 60 days before the Show. The Exhibitor cannot participate in the show in any way until proof of insurance is provided.

10. Exhibitor agrees that no display or any part of the display be dismantled or removed during the entire run of the Show, but must remain intact until the closing of the hour of the last day of the Show. The Exhibitor also agrees to remove the exhibit, equipment and appurtenances from the Show building by the final move-out time limit. In the event of

failure to do so, the Exhibitor agrees to pay for additional costs as may be incurred.

11. Exhibitor agrees to abide by the instructions given by the Show Director pertaining to the move-in and move-out schedule.

12. Exhibitor agrees to observe all union contracts and labor relations agreements in force, agreements between Show Management, official contractors serving companies, and the building in which the Show will take place, in accordance with the labor laws of the jurisdiction in which the building is located. The Exhibitor will not do anything directly or indirectly connected with the display or regulation of any governmental body, or which may be in violation of The Montgomery County Fairgrounds Event Center, city, county or state regulations.

13. Management reserves the right at its sole discretion to change the date or dates upon which the Show is to be held, and shall not be liable in damages otherwise by reasons of any such change. In addition, Management shall not be liable for damages or otherwise failure to carry out the terms of this Agreement in whole or in part where caused directly or indirectly by or in consequence of fire, storm, flood, water damage, war, rebellion, insurrection, Wind Damage, Act of God, riot, civil commotion, strike or by any cause whatsoever beyond the control of Management, whether similar to or dissimilar from the causes enumerated herein. In the event that the exhibit space to be used by the Exhibitor should in any way be rendered unusable, the Exhibitor shall pay for such space only for the period during which it was or could have used as determined within the sole discretion of Management.

14. Management reserves the right to cancel this contract and to withhold possession of exhibit space if the Exhibitor fails to perform any material condition of this contract or refuses to abide by the Show rules and regulations, in which case the Exhibitor shall forfeit as liquidation damages all space rental payments made by him and any further occupancy of such space.

15. The Exhibitor Service Manual will be forwarded to all participants at the latest 60 days before the event. *Show Management reserves the right to modify, or add to the above noted regulations. All modifications if any will be announced on Show Management's web site and/or will be published in the Exhibitor Service Manual. The names Bicycle Tour & Travel Expo, Recumbent Cycle-Con Trade Show & Convention, Bicycle Tour & Travel Expo, and Electric Cycle-Con belong to Coyne Publishing, LLC. All use of these names may only be used with the permission of Coyne Publishing, LLC. All unauthorized uses will be prosecuted.
