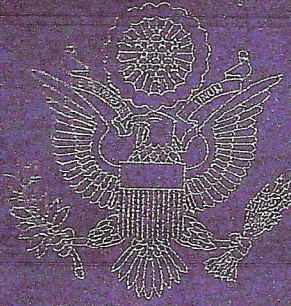

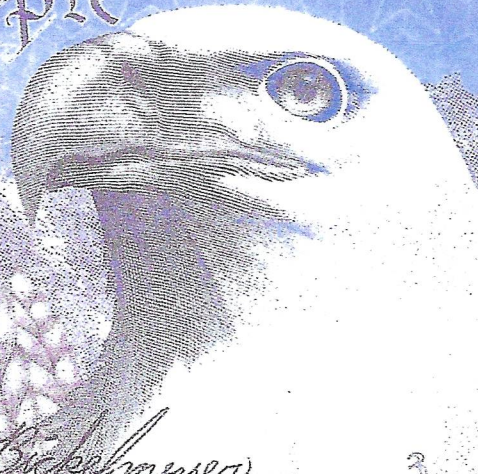
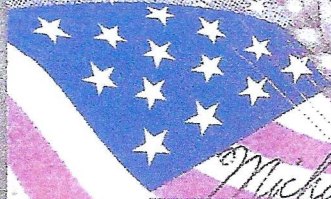

## AUTOBIOGRAPHY

My name is Michael Bickelmeyer, I am 58 years old. I am single, never married, no children, and I live alone. I am a condominium owner in Brunswick, Ohio. This is my 1st property. I hold an Associate of Arts Degree August 1985 from Cuyahoga Community College, and a Bachelor of Science Degree in General Business Administration June 1996 from Chancellor (Myers) University. After that I graduated from a Security Academy at Cuyahoga Community College/Unified Technology Center, December 1999, where I made the Dean's List. Continuing on I earned my Master of Management Degree Online at The University of Phoenix December of 2013.

I currently work in the Security Field for US Security Associates as a Security Officer at Strongsville High School in Strongsville, Ohio full-time. My second full-time job is at The Holiday Inn Strongsville in Ohio as well, where I transport airline Flight crews to and from Cleveland Hopkins International Airport and Hotel in a shuttle van or bus. During the Strongsville High School when in session I currently work 92.5 hours each week. I like to stay busy as they say and a moving target is hard to hit. I have 42 years of work experience in the private sector. Over my 42 years of working I have been hospitalized three times, once every 10 years for work exhaustion and sleep deprivations. My last hospitalization was January 7, 2007 whereby my hospital stay was two months, and I threw myself into a Bi-Polar State. This was three days after my Birthday January 4, 2007. I am currently prescribed 9 mg. of paliperidone in the morning, a psychotropic medication and required to stay on this medication for the rest of my life. I have been under the care of nine different Psychiatrists since I was 23 years old, and after 36 years of being under their study, they have determined I am a Type-A person.

My interests and hobbies include monitoring current economic trends, forecasting, and conceptual thinking. I have an interest in monitoring current economic trends as an aid to my previous education in economics, and to gauge the stability of United States and World Governments, and Markets.

My personal endeavors have included four Federal Projects. First an Internal Revenue Service 1023 application, for a Tax-Exempt status for my personal holding company Bugger & Hund Inc., a C-Corporation. Then a grant application project for an Industrial Recycling Facility powered by Clean Energy Generation, August 4, 2008. And thirdly two United States Provisional Patents, And three Non Provisional Patent Applications for An Adaptable Airport System with Industrial Zones and Clean Energy Generation. And fourthly a Non Provisional Patent Application for an Orbital Weapons System titled A Gift for Children. The United States Patents and Applications and Federal Grant Application are currently under negotiations to transfer to The National Aeronautical Space Administration. The Patent Projects seem to be well received by both the Republicans and the Democrats on Capitol Hill. I have had communications with The United States Secret Service, Four Senators Offices, The Drug Enforcement Agency, The Environmental Protection Agency, The Internal Revenue Service, The United States Department of Agriculture, The Department of Defense, The Central Intelligence Agency, The Federal Bureau of Investigation, The National Aeronautical Space Administration,

and The White House. Capitol Hill would like to see me secure the Patents Worldwide. They look like a thing of the future. Thank God!

I ran for The Office of President of the United States of America as a Republican in 2016, and I was a write-in Candidate here in Ohio. My four Federal Projects serve as my platform. They address National Security, Job Creation, and Environmental Issues. I am also running for President of the United States of America again in 2020 as a Republican. My statement of Candidacy was dated and submitted to our Federal Election Commission on Inauguration Day, January 20, 2017. I didn't ask anyone for money and received only \$12.00 in unsolicited campaign contributions in the 2016 election. Had I been able to afford media attention with my four Federal Projects, Hillary Clinton, and Donald Trump would have never stood a chance next to me. FOR YOUR INFORMATION: On your own future home purchase. I was a 1st time home buyer and went through Third Federal Savings and Loan. I attended their free two week 1st time home buyer seminar at their Headquarters in Cleveland, Ohio. After completion Third Federal gave me \$600.00 towards closing costs. I also received \$3,000.00 from NOAH, an organization that Third Federal is affiliated with towards closing costs. I saved a Federal Government Student Loan Check for \$4,400.00 and contributed \$2,000.00 of my own funds for the 15% down payment. The purchase price was \$47,500.00 for the three bedroom-two story condominium at Oxford Heights Condominiums in Brunswick, Ohio. Third Federal Savings and Loan gave me a 30-year fixed mortgage loan for 3.49% interest. My monthly principal and interest payments are \$180.75. My taxes are under \$63.00 a month, and my home maintenance fee is under \$247.00 a month. These condominiums were appraised and selling for \$90,000.00 before our economic downturn in 2009. The United States Secret Service advised me to keep this condominium, and make double mortgage payments every other month, and a triple mortgage payment twice a year at every sixth month point. So far I have been able to do so. I pay a extra \$200.00 towards the principal every other month, and an additional \$400.00 towards the principal twice a year at every six month point. The title transferred May 20, 2016. I moved in May 26, 2016. For my Mother's Birthday, June 13, 2016 I put the property into my revocable trust and signed it over to my Mother and Sister 50% equally in the event of my death. For Medicaid planning here in Ohio, any property, tangible or intangible in a trust for at least five years and one day, Medicaid and a nursing or rehab facility cannot take your assets. In 2015 and 2016 my gross annual earnings were just under \$40,000.00 for each year. I earn under \$10.00 an hour at both of my full time employers. FYI: I currently have \$50,000.00 of whole life insurance with New York Life through AARP. The United States Secret Service advised me, do not buy anymore life insurance, and do not invest in any government controlled retirement programs. Thank you!
