

**AMELIA VILLAGE, OHIO**  
**Ordinance No.: O-2013-48**

**AN ORDINANCE ENACTING AND ADOPTING A SUPPLEMENT TO THE CODE OF ORDINANCES, AND DECLARING AN EMERGENCY.**

**WHEREAS**, American Legal Publishing Corporation of Cincinnati, Ohio has completed the 2012 supplement to the Code of Ordinances of Amelia Village, which supplement contains all ordinances of a general and permanent nature enacted since the prior supplement to the Code of Ordinances of Amelia Village; and

**WHEREAS**, American Legal Publishing Corporation has recommended the revision or addition of certain sections of the Code of Ordinances which are based on or make reference to sections of the Ohio Revised Code; and

**WHEREAS**, it is the intention of Amelia Village Council to accept these updated sections in accordance with the changes of the law of the State of Ohio; and

**WHEREAS**, it is necessary to provide for the usual daily operation of Amelia Village and for the immediate preservation of the public peace, health, safety and general welfare of Amelia Village that this ordinance take effect at the earliest date allowed by law.

**NOW, THEREFORE**, be it ordained by Council of Amelia Village, that:

**SECTION I** The 2012 supplement to the Code of Ordinances of Amelia Village as submitted by American Legal Publishing Corporation of Cincinnati, Ohio, and as attached hereto, be and the same is hereby adopted by reference as if set out in its entirety.

**SECTION II** Such supplement shall be deemed published as of the day of its adoption and approval by the Amelia Village Council and the Fiscal Officer is hereby authorized and ordered to insert such supplement in the copy of the Code of Ordinances kept on file in the Office of the Fiscal Officer.

**SECTION III** Council hereby finds and determines that all formal actions relative to the passage of this ordinance were taken in an open meeting of this Council, and that all deliberations of this Council and of its committees, if any, which resulted in formal action, were taken in meetings open to the public, in full compliance with applicable legal requirements including Section 121.22 of the Revised Code.

**SECTION V** This ordinance is declared to be an emergency for the preservation of the public health and safety. Specifically, its adoption is necessary for the normal daily operations of the Village. Therefore, this ordinance shall go into immediate effect.
