**PLEASE NOTE: THERE ARE MULTIPLE WAYS TO GET TO THIS BUILDING**  
**I HAVE PRESENTED SOME OF THESE DIRECTIONS BELOW**

**I-5 Heading North or South Exit 142 B (See attached Maps)**

- Take **exit 142B** which merges onto **WA-18 W**
- WA 18 W turns into **S 348<sup>th</sup> St.** Proceed to **Pacific Hwy S (WA Hwy 99)**
- Turn **RIGHT** onto **Pacific Hwy S (WA Hwy 99)** near Taco Bell
- Proceed until **S. 336<sup>th</sup> St** (you will see Home Street Bank/Advance Auto Parts)
- **Take a Left onto S 336<sup>th</sup> St.** (by Advanced Auto Parts / Home St. Bank)
- Get into the **Right Hand Lane.**
- You will Pass 6<sup>th</sup> Ave S (and will see sign for **Key Compounding**)
- Turn into the **next entrance** on your Right (you will see a sign for "**Bay Equity**")
- Go straight and building **is on Left**. The number **500 is above Door**.
- **If you reach 1st Way S, you have gone too far.**
- **Front of Building is on the Left across the lot from Theary Beauty Salon**
- Proceed to **FRONT** of building for **parking** (including **Disability** parking).
- **Back** of Building May Be locked so make Sure you are at the **Front (see map)**
- Go into the entrance and take the elevator to **Second floor**.
- Proceed forward out of Elevator
- Turn down the Left Hallway and go to end
- **Suite 216 is the last Office on the Left at the end of Hall.**

**I-5 Heading South- Exit 143**

- Take **exit 143 (S 320<sup>th</sup> St.)**
- From I-5 Heading South, turn **Right** off exist continuing onto S 320<sup>th</sup> St. (by **Red Robins**)
- Get into Left Hand Lanes
- Turn **Left** onto Pacific Hwy S (WA-99) by **Chase Bank / BOA**
- Get into **Right Hand Lane**
- Turn **Right onto S 336<sup>th</sup> St.** (by **Home Street Bank**)
- Get into the **Right Hand Lane**
- **Proceed to office as discussed above.**

**FROM PUYALLUP**

- Can Take WA 161 N. Turn Left onto **S 348th St.**
- Proceed to office as discussed above.

**FROM AUBURN**

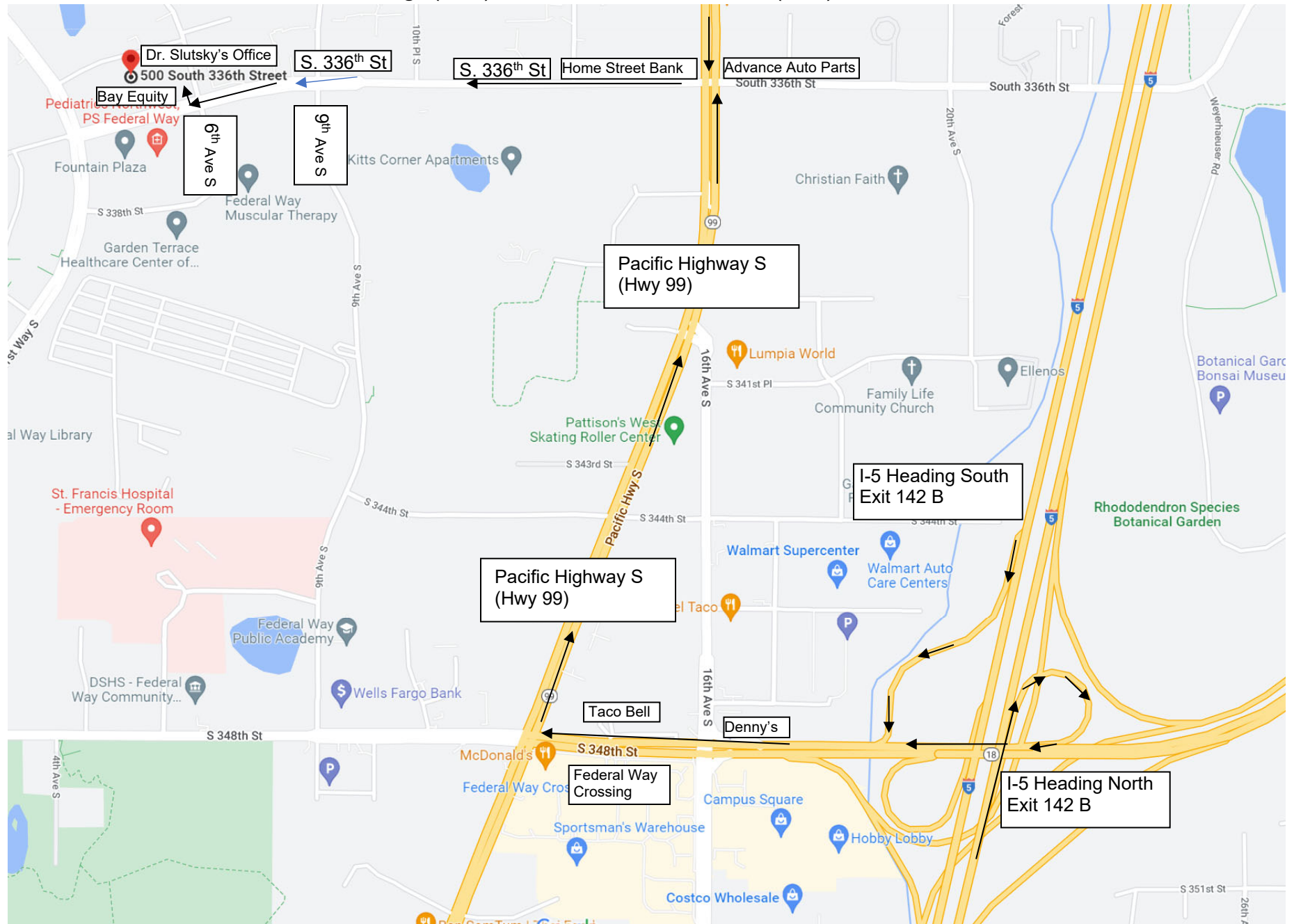
- Can Take **WA Hwy 18W towards Federal Way**. This turns into **S 348th St**
- Proceed to office as discussed above.

**FROM KENT**

- Can Take WA 516 to 509 to 99 S to Pacific Hwy S.
- Turn Right onto **S 348th St.**

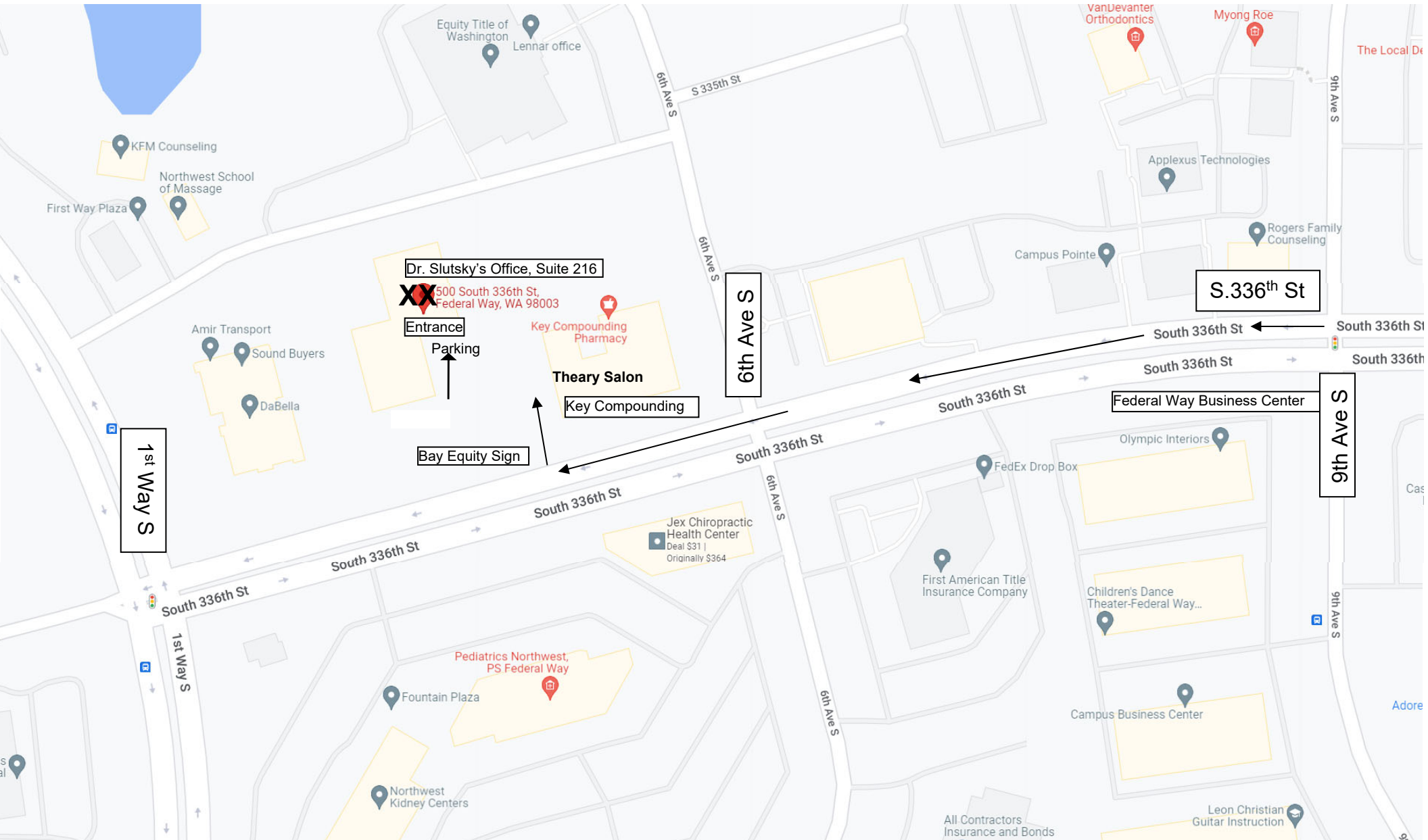

**GENERAL OFFICE POLICIES**

Dear Patients,

Please be aware of Dr. Slutsky's Policies (below)

- A. **Face Covering** is optional. It is not required.

- C. When you arrive at the Building, please **Wait in Your Car**. **Dr. Slutsky will call you on your Cell Phone when it's safe to enter the premises.**
- D. Those **who don't have a Cell Phone**, can only come into the Building **exactly at their Appointment Time**.

- F. **No Guns** are allowed in Dr. Slutsky's office.
- G. **No Animals are allowed** in Dr. Slutsky's office. The only exception is a **Certified Service Animals** however you must be pre-approved by Dr. Slutsky.
- H. **Small Children, Babies who are not able to sit quietly** may not be brought into my office for the appointment as we will not be able to perform a valid Hearing Test.
- I. Patients must have **14 hours of Low or No Noise Exposure prior to their appointment**. Otherwise a valid Hearing test cannot be performed
