

THE GIFT OF BLACK THEOLOGICAL EDUCATION

A conversation between Dr. Delores F. Brisbon and Dr. John W. Kinney at Union Station in Washington DC where they discussed the importance of black theological education, and the inherent responsibilities and duties of the entities entrusted with securing its longevity has had a resounding and positive impact on black faith communities.

From that conversation, The GIFT of Black Theological Education was launched. Since that time, The GIFT has applied for and received a grant from the Lilly Endowment, Inc., which allowed Christian denominations and their educational institutions to collaboratively develop, implement, and structure practices that addressed ways to sustain the merits of black theological education despite ongoing struggles.

The primary Black theological seminaries and their denominations are: Payne Theological University, African Methodist Episcopal (AME); Interdenominational Theological Center, the Christian

Methodist Episcopal (CME), National Secretary, American Baptist Church-Baptist Convention-USA (NBC), Progressive National Baptist Convention (NBC), and the Church of God in Christ (COGIC); Shaw University, the General Baptist State Convention of North Carolina (GBNC); Hood Theological Seminary, the African Methodist Episcopal Zion (AMEZ), and Virginia Union University, the Baptist General Convention of VA (BGCVA).

These institutions have successfully leaders educated throughout the years. When we look at our dear VUU and BGCVA. While the list of notable students and graduates associated with Virginia Union University and the BGCVA cannot be counted, some of them currently impacting theological training are: Dr. Angela D. Sims, President Colgate Rochester Crozer Divinity School; Dr. Micah D. McCreary, President, New Brunswick Theological Seminary: Dr. John Guns, Dean, School of Theology at Virginia Union University; Dr. Gregory Howard, former Dean, Shaw Divinity School and Interim Dean of the Samuel Dewitt Proctor School of Theology; Dr. James Harrison, Executive es of the South; Dr. James Victor, 2nd Vice President Lott Carev Foreign Missions Board; and Dr. James E. Coleman, Jr., Dean, School of Religion at Virginia University of Lynchburg and President of BGCVA. Dr. Leo Whitaker serves as BGCVA'S Executive Minister. More than ninety percent of our BGCVA Presidents are also graduates of VUU. In addition, Dr. Peter Wherry, a graduate of the Samuel DeWitt Proctor School of Theology at Virginia Union University was recently named Director of the Doctor of Ministry Program at Howard University.

The leadership of these individuals attest to the strength, credibility, importance, and the gift that is inherent in the black theological educational experience! 2024 Priority Issues for Public Policy

The Baptist General Convention of Virginia, Inc. (BGCVA), through its Commission on Social Justice, focuses its justice efforts on the needs and challenges of members of our congregations and those living in the Commonwealth of Virginia. BGCVA focuses on five main areas: ecology (where we live, what we breathe, what eat, and health), education (where and how we learn), employment (how and where we earn and gain resources), economics (where and how we spend our resources), and election (who represent(s) us). This document outlines areas for advocacy and action that the BGCVA is requesting all congregations and association to focus on in 2024, as was presented at the BGCVA's 125th Annual Session and Congress of Christian Faith Formation in July 2024.

HEALTH EQUITY (Matthew 25:36b) – Health disparities impact communities across the United States, but the history of America's medical treatment of African Americans became exacerbated during the COVID-19 pandemic. The work of health equity must address disparities in healthcare that affect our communities.

- Engaging in BGCVA Food Network with local church, legal association and food pantry/bank access to community feeding people is one of greater health challenges.
- Ensure African Americans have access to healthcare without racial bias in the training, licensure, and credential renewal of healthcare professionals.
- Focus on providing greater access and choice to healthcare for women and those who are pregnant.
- Have greater preventive care and food security in communities where this challenge exists.

HOUSING (Isaiah 32:18) – Access to affordable and fair housing impacts communities across the nation but has greater impact on African-American communities. The policy priorities are three-fold.

- Ensure there is control on the cost of housing in locales beyond issues of simple inflation.
- Aim to allow congregations to use their land to develop housing for local communities.
- Ensure African-American communities have fair fiscal equity in housing values and valuations, as housing is part of building generational wealth.

EDUCATION (Hosea 4:6) – This history of education is built on disparities across the United States, but the Commonwealth of Virginia still set up laws against literacy for African Americans as far as the Code of Virginia in 1849. We must mandate educational equity for our communities.

Provide and ensure support for literacy at or above grade level.

- Give guidance on book banning, regardless of content, as it aims to dismantle holistic conversations on diversity, equity, and inclusion.
- Ensure equitable funding and access for schools for education reform.

CRIMINAL JUSTICE REFORM (Matthew 25:36c) – We must address the prison-industrial complex that objectifies black bodies. Laws have been adapted to make incarceration a perpetual reality for our community.

- Fight for automatic restoration of rights for returning citizens.
- Strengthen greater access to higher education in prisons.
- Develop policy on free communications for those who are incarcerated.

VOTING (Romans 13:1) – The access to the ballot box is the greatest threat to democracy. The ability for African Americans to vote without intimidation was not present until the Voting Rights Act of 1965. We see the fragility of the vote in the piecewise dismantling of this act on the federal level. Voting decides who represents us on all levels of government. We must ensure fair and equal access to the ballot box and to those who represent us.

- Strengthen our precinct level voting access and expand voter registration within our congregations and communities.
- Fight against voting restrictions and redistricting designed to dilute the influence and impact of our communities.
- Develop leadership that is positioned to serve in public office to move the priorities forward that affects our communities.

Soon it was time for my mother to start cooking the Christmas meal. The house was filled with the sights and smells of Christmas. The smells of pine, cinnamon, potatoes, greens, meats and so much more were forever etched in my memory.

When I became a family man, I shared these stories with my wife and children. I also tried to recreate the sights and smells of Christmases past. Most of all, I tried to instill the true meaning of Christmas. My children learned early that Jesus was born to identify with sinful man. Jesus' primary purpose for coming to earth is to shine the light of truth into this dark world of sin. He became the supreme sacrifice for our sins so we could experience true deliverance and salvation from our sins. They learned that we can experience eternal life.



BGCVA LILLY ENDOWMENT INITIATIVE CHURCH LEARNING GRANT

Congratulations to the 2024 recipients of the Lilly Endowment Initiative Church Learning Grant. Thirteen churches from around the state, representing each region will receive the \$1,500 grant. The awardees are as follows:

- Faith Community Baptist Church (Richmond)
- First Baptist Church Hampton (Hampton)
- First Gravel Hill Baptist Church (Smithfield)
- Greater Brandon Chapel Missionary Baptist Church (Alton)
- Mount Olive Baptist Church (Centreville)
- Mount Olive Baptist Church (Northumberland)
- New Life Faith Center (Henrico)
- New Mount Calvary Baptist Church (Eastern Shore)
- Pleasant Grove Missionary Baptist Church (South Boston)
- Providence Transformation

Church International (Lynchburg)

- St John Baptist Church (Williamsburg)
- Thirty-first Street Baptist Church (Richmond)
- Union Street Missionary Baptist Church (Danville)

Applicants were asked to respond to a series of questions that expressed how the grant funds will be used to expand upon the church's current mission in the community. Twenty-three churches submitted applications for the first of five grants. The grants will be offered every year for the next five years.

The selection of learning grant awardees was a blinded process that involved having reviewers who were both skilled in these types of processes as well as steeped in the missional work of the church. The BGC grant staff were intentional in selecting persons from across the five regions of the state to review applications and provide feedback using a carefully constructed assessment rubric. Due

to three churches receiving the same score, the Lilly Grant staff increased the number of recipients from the original plan to award 10 churches a grant, to awarding 13 churches a grant.

The awardees will begin the process of implementing their proposed ideas over the next several weeks. The Lilly Grant staff will provide continued support as churches embark upon their expanded ministry.
