An index universal life policy is permanent life insurance that combines the protection of a tax-free death benefit with the potential to be credited Excess Index Interest based in part on changes in an index or multiple indexes. The Transamerica Financial Foundation IUL[®] and TFLIC Financial Foundation IUL[®] offer the policy owner the flexibility to allocate net premiums to the Global Index Account, the S&P 500[®] Index Account, the Basic Interest Account, or a combination of the three.

S&P 500[®] Index Account

INTEREST CREDITING METHOD


The Company credits Excess Index Interest, if any, to this Index Account using a formula based on changes in the S&P 500[®] Index, excluding dividends. The index change percentage is then compared to the Cap.



Global Index Account

INTEREST CREDITING METHOD

The Company credits Excess Index Interest, if any, to this Index Account based on a weighted average of the index change percentages of three indexes, excluding dividends. The weighted index change percentages are added together and compared to the Cap. To arrive at the weighted index change percentage, we apply the following factors:



TO THE PERCENTAGE CHANGE IN THE S&P 500[®] OR THE EURO STOXX 50[®], WHICHEVER IS LOWER

TO THE PERCENTAGE CHANGE IN THE HANG SENG INDEX
