## WHIP CRACKING RULES

- 1. The Whipper Snappers, Junior and Senior age divisions are open to Sarasota County residents that meet school eligibility criteria as stated in General Rules and Regulations, FFA & 4-H Rules. (copies available On-Line)
- 2. The Open Division is for residents of Sarasota County.
- 3. To **qualify** for tee shirts, registration forms are due in the fair office on Friday, March 8, 2019 before 5:00 pm. (Tee shirt availability is the responsibility of the organizers and sponsorships- not SCAFA.)
- 4. Entry forms may be turned in to the Fair office up until Thursday, March 14, 2019 or at the Houser Show Arena from 5:00 pm to 5:30 pm the day of the event before the contest begins. (may not be eligible for tee shirts)
- 5. The Whip Cracking Contest will be on Saturday, March 16, 2019 at 7:30 pm in the F.T. Houser Show Arena.
- 6. If the number of Whip Cracking contestants exceeds 60, there will be a qualifying round at 5:30 pm before the competition.
- 7. Whip Cracking contestants will wear long pants or leg coverings, safety goggles, and closed toe shoes (boots and jeans recommended).
- 8. Exhibitor Conduct: Any unbecoming behavior of exhibitor will disqualify them and all awards and premiums will be forfeited.
- 9. A warm up session outside with a committee member present will be held between 6:35 pm and 6:45 pm.
- 10. Each contestant will have forty five (45) seconds to perform their whip cracking ability.
- 11. Whips can be at lengths up to 14 feet.
- 12. In case of a tie, there will be a Pop-off to determine the winner.
- 13. Contestants will be disqualified from the contest and removed from fairgrounds if found cracking or popping whips at any time before or after they enter the arena or during the fair.
- 14. Judges will score on the 1 to 10 scale with 10 being the highest score. Contestants will be judged on the most original, sharpness, loudness and best overall performance.
- 15. Final interpretation and administration of the rules will be vested in the management of the Sarasota County Fair and their decision will be final.
- 16. A participant may compete in only one (1) division.

Divisions: Age will be calculated as of September 1, 2018.

A. Whip Snappers Division: 5-8 year old

B. Juniors Division: 9-14 year oldC. Senior Division: 15-18 year old

D. Open Division: 19 +

Premiums: Blue= Ribbon/\$10.00

Red= Ribbon/\$8.00 White= Ribbon/\$5.00 Division Winner= Rosette
