Healthy Lakes Report

All of us who live on the Briggs Lake Chain should know by now what we mean when we talk about **aquatic invasive species [AIS].** After all, the BLCA has been spending thousands of dollars annually [from grants, individual donations and charitable gambling donations] to manage curly leaf pondweed. Curly leaf is an **aquatic invasive species.** If you have been paying attention, you will also know that our efforts to manage curly leaf pondweed have been working. There is less of the weed now than several years ago when it was nearly impossible to navigate some of our waters.

Another concern you should already be aware of: **Impaired Waters**. Having the Briggs Lake Chain on the Minnesota Pollution Control Agency's **Impaired Waters List** has heightened our awareness of the high levels of phosphorous and the impact on water quality. And now there is another wolf at the back door: **Zebra mussels**.

What are they? The barnacle-like **zebra mussel** looks like a small clam with a yellowish or brownish, D-shaped shell, with alternating dark and light colored stripes, giving them their name. They are usually under an inch in size and grow in clusters containing numerous individuals. They attach themselves to solid objects: submerged rocks, docks, boat lifts, water-intake pipes, etc., and their shells are razor sharp.

Zebra mussels are now present in at least 14 of Minnesota's 87 counties, with new counties being added to the list annually, and are easily transported by boats and boat trailers. We know that the zebra mussel larvae, known as veligers, which are microscopically small, can survive five days or more out of water. The typical fishing boat and trailer have safe places for vilegers such as the hull, the bilge, boat wells, live fish tanks, outboard motors and the trailer bunks on which the boat hull rests. Lakes like Green Lake in Spicer are very susceptible to being infested because of the number of fishing tournaments hosted each year.

Best Management Practice (BMP)

Think Spring?

Fall officially begins on Wednesday, bringing with it a wet and worrisome outlook for spring. Saturated ground and high rivers in the fall have set up serious spring flooding for the past two years, and this season isn't looking any different.

Across Minnesota summer rain seemed to reach a crescendo in September, when it's usually slacking off. The creek at the north end of Briggs was boiling through the culverts after the day-long downpour on Thursday, September 23rd. The Elk River is swollen over its banks too.

Farm crops have stopped using rainwater by now; therefore, precipitation this time of year either runs off into rivers or stays in the soil where it freezes until spring. That means the spring snowmelt can't seep into the ground, but runs into streams and rivers. In addition, below-normal temperatures so far in September across the state have slowed down the rate at which water might also evaporate.

If we have average quantities of snowfall this winter, I'd say the chance of high water on the Briggs Lake Chain come March/April is pretty high.

As we all are preparing for winter, there are a host of precautions we can take to minimize the impact the flooding will have on our water quality and alleviate the awful mess a flood usually makes:

- Clean out any fire pits that could potentially flood.
- Pick up any leaves and grass clippings that could potentially be reached by high water.
- Pick up any fallen tree branches or wood of any sort near the water's edge.
- Clean up pet droppings.
- Skip fertilizing the area of your yard that's likely to be impacted by high water.
- Move dock sections to higher ground, or at a minimum, run a rope or cable through them and tie to a tree to prevent them from floating away.
- If you have a boathouse that normally floods, store everything off of the floor.
- Floating docks, or other flotation type toys, should be tied off or anchored.

During last spring's floods, there was still a significant amount of ice on the lake. Ice can cause severe damage if it blows or drifts ashore. High water can also cause damage if it freezes around dock frames and boat lifts. As a preventive measure pull dock frames and boat lifts up a little farther than normal.

With a little planning and preparation, everyone can do their part to limit the water quality impacts of spring flooding.
